NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

1. Basis of Presentation

The accompanying financial statements of Vomela Specialty Company 401(k) Profit Sharing Plan (the Plan) have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

2. Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in guaranteed investment contracts are stated at contract value.

As described in the Accounting Standards Codification ("ASC"), 946, *Financial Services – Investment Companies*, investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales are recorded on the trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net change in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

3. Contributions

Contributions from Plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation.

NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

4. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment recorded.

5. Participant Direction of Investments

Subject to the provisions of the Plan, a participant has the right to direct the investments of the balance in their accounts in the specific investment funds made available by the Plan administrator. At December 31, 2024 and 2023 all investments are participant directed.

6. Payment of Benefits

Benefits are recorded when paid.

7. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE B – DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General and Eligibility

The Plan is a defined contribution plan. Substantially all employees of Vomela Specialty Company, Subsidiaries, and Affiliates (the Employer) are eligible to participate in the Plan after meeting certain requirements. In order to be eligible to participate in the Plan, an employee must not be in a bargaining unit unless the bargaining agreement provides coverage under the Plan and must not be a leased employee. An employee is eligible for participation upon attaining 21 years of age and completion of 1 month of service.

NOTE B – DESCRIPTION OF THE PLAN - CONTINUED

1. General and Eligibility - Continued

An eligible employee may become a participant on the next entrance date, which is the on the first day of the next month of the Plan year coinciding with or following the date eligibility requirements are met.

The Employer is responsible for appointing an administrator and trustee for the Plan. The trustee has discretionary powers in executing investment transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The costs of the Plan administration are the responsibility of the Plan.

2. Contributions

The Plan allows participants to contribute up to 100% of annual eligible compensation, as defined by the Plan, subject to limits imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans.

All Employer contributions are determined at the discretion of the Employer. The Employer may make discretionary matching contributions or discretionary Employer profit sharing contributions. Employer matching contributions, when made, will be made to all participants regardless of service and are based on a discretionary percentage of participant salary deferrals. Employer discretionary profit sharing contributions are allocated to all participants based on the participant's compensation as compared to the total compensation of all participants. Qualified non-elective contributions are allocated to all non-highly compensated employees in an amount to be determined by the Employer. All participants share in the allocation of Employer discretionary matching contributions and qualified non-elective contributions regardless of service completed during the Plan year or employment status on the last day of the Plan year. The participant must complete one year of service and be employed on the last day of the Plan year to share discretionary Employer profit sharing contributions. There are no Employer contributions during the year ended December 31, 2024.

3. Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Employer's discretionary matching contribution, (b) the Employer's discretionary qualified non-elective contribution, (c) the Employer's discretionary profit sharing contribution, and (d) investment income or loss on investments less administrative expenses. Allocations are based on participant compensation or account balances, as defined.

3. Participant Accounts - Continued

Changes in a participant's deferral percentage for future contributions may be made quarterly during the Plan year, unless the participant chooses to change their percentage to 0%, which can be done at any time during the year. Reallocation of participant investment accounts among the investment options may be made at any time during the Plan year.

4. Vesting

Participants are immediately vested in their employee and in the Employer contributions.

5. Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of the participant's employment, a participant may receive a lump sum distribution equal to the participant's vested account balance. There are no minimum required distributions.

6. Notes Receivable from Participants

Loans to participants from a participant's vested balance are permitted up to the lesser of 50 percent of the vested balance or a maximum of \$50,000 for each participant. The minimum note amount is \$1,000. The loans shall bear a reasonable rate of interest, be adequately secured, and have a definite repayment schedule, generally over a period not to exceed five years unless the loan is for the purchase of the employee's primary residence. Loans used for the purchase of the employee's personal residence may be repaid within a period of no more than 15 years. Principal and interest are paid ratably through payroll deductions.

8. Risks and Uncertainties

The Plan is comprised of investments in a combination of investment securities. Investment securities are exposed to various risks, such as interest, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

NOTE D - FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation method used for assets measured at fair value. There have been no changes in the method used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) as a practical expedient to fair value of the units held by the Plan at year-end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan provides an investment option issued by Minnesota Life Insurance Company (MN Life) that simulates the performance of a guaranteed investment contract. MN Life maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The net crediting interest rate is 1.50% at December 31, 2024.

The contract meets the FBRIC criteria and, therefore, is reported at contract value. Contract value is the relevant measure for a FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by MN Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE F - FEDERAL INCOME TAXES

The Plan has adopted the Volume Submitter 401(k) Profit Sharing Plan, of Minnesota Life Insurance Company. The volume submitter sponsor obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the advisory letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. See Note K for reconciliation of financial statements to Form 5500 as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue and Regulations, Revenue Rulings, court decisions, and other evidence. The federal income tax returns of the Plan are subject to examination by the IRS generally for three years after they were filed.

NOTE G - EXCESS CONTRIBUTIONS PAYABLE

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There are \$61,401 and \$68,092 in excess contributions as of December 31, 2024 and 2023, respectively. The excess contributions were distributed by the Plan to the applicable participants within the allowable time frame as required by ERISA.

NOTE H - PARTY-IN-INTEREST TRANSACTIONS

Minnesota Life Insurance Company is the trustee of the Plan and holds the Plan's investments and executes transactions. The Stancorp Financial Group is an agent of the Plan and is the third-party administrator.

NOTE I - ADMINISTRATIVE EXPENSES

The Plan pays administrative expenses that consist primarily of administrative fees to the trustee. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

NOTE J - PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to reduce, suspend, or discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE L – SECURE ACT 2.0

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as “SECURE Act 2.0”.
