Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Mikuni Restaurant Group, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1: Description of Plan

The following description of the Mikuni Restaurant Group, Inc. 401(k) Plan (the Plan), is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on July 1, 2014, to provide all eligible employees of Mikuni Restaurant Group, Inc. (the Company), with retirement benefits in accordance with section 401(k) of the Internal Revenue Code (IRC). To be eligible to participate in the Plan, employees must have reached the age of twenty-one and have completed one year of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees may elect to make tax deferred and Roth 401(k) contributions to the Plan up to the lesser of 100% of their eligible compensation or \$23,000 (for 2024). The percentage elected by the participants is withheld from their paychecks and contributed to the Plan by the Company. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500 (for 2024). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company may make discretionary and non-elective contributions to the Plan. The Company will make safe harbor matching contributions equal to 100% of participant salary deferrals that do not exceed 3% of eligible compensation plus 50% of participant salary deferrals between 3% and 5% of eligible compensation. To be eligible for these contributions, the participant must be making deferral contributions to the Plan.

The Company may also elect to make profit sharing contributions. To be eligible for these contributions, the participant must be employed on the last day of the Plan year and have completed one thousand service hours with the Company. No profit sharing contribution was made for the year ended December 31, 2024. All contributions are subject to limits set by Federal law.

Participant Accounts

Each participant's account is credited with the participant's own contributions, an allocation of the Company's contributions, and an allocation of net earnings from investments and changes in investment values and Plan administrative expenses. Allocations are based on each participant's contributions, earnings, or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's account.

Forfeitures

Contributions by the Company that are forfeited by participants upon termination may be used to pay Plan administrative expenses or used by the Company to fund future employer contributions.

Note 1: **Description of Plan (Continued)**

Vesting

Participants are vested immediately in their elective deferral contributions, rollover contributions, qualified non-elective contributions, and safe harbor matching contributions and any earnings thereon. Vesting in discretionary non-safe harbor employer contributions and profit sharing contributions is based on years of continuous service, as defined by the Plan. Participants become vested at a rate of 20% after two years of service and 20% per year of service thereafter. Participants become 100% vested after six years of credited service.

Payment of Benefits

Upon termination of employment due to retirement, death, disability or separation from service, the balances in the participants' accounts will be distributed to the participants or to their beneficiaries in either a lump sum, equal installments in the form of nontransferable annuity, or some combination of the foregoing, at the election of the beneficiary.

Notes Receivable from Participants

Participants are allowed to borrow a minimum of \$1,000 up to one-half of their vested balance, up to a maximum of \$50,000. Participants may only have one loan outstanding at any time. Loans bear a reasonable fixed-rate of interest, which is determined by the Plan custodian. Generally, loans must be repaid over a maximum of five years. Loans to participants are stated at the principal amount outstanding, which approximates fair value.

Administrative Expenses

The Company, as Plan sponsor, pays certain administrative expenses on behalf of the Plan. Participant's accounts are adjusted for fees pertaining to loan or termination processing, and are charged for expenses incurred by the custodian in the performance of their duties.

Note 2: **Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are stated at fair value as certified by the Plan's custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2: **Summary of Significant Accounting Policies (Continued)**

Use of Estimates

In preparing the financial statements in accordance with accounting principles generally accepted in the United States of America, management makes estimates and assumptions which affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Subsequent Events

In preparing the accompanying financial statements, management has considered events that have occurred after December 31, 2024, through August 6, 2025, the date these financial statements were available for issuance. Management was not aware of any subsequent events requiring additional disclosure.

Note 3: **Information Certified by the Custodian**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the custodian of the Plan).

Note 4: **Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1) Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2) Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3) Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a PSA is calculated based on a compilation of primarily observable market information. There are no unfunded commitments or redemption restrictions as of December 31, 2024 and 2023.

Note 5: **Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor reserves the right to terminate the Plan at any time. In the event of Plan termination, all accounts become fully vested and non-forfeitable. Plan assets would be first used to pay expenses properly charged to the Plan. The remainder would then be distributed to participants in a lump sum.

Note 6: **Tax Status**

On June 30, 2020, the IRS stated that the non-standardized pre-approved plan adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: **Party-in-Interest Transactions**

Certain Plan investments include shares of registered investment company funds managed by John Hancock Life Insurance Company (John Hancock). As John Hancock is the custodian and trustee of the Plan, transactions with this entity qualify as exempt party-in-interest transactions.

Note 8: **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
