Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Harper Industries, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of the Harper Industries, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document or Summary Plan Description (SPD) for a more complete description of the Plan's provisions. The Plan Administrator is responsible for the oversight of the Plan. The Board of Trustees determines the appropriateness of the Plan's investments offerings and monitors investment performance.

Eligibility - The Plan is a defined contribution plan covering all full-time employees of Harper Industries, Inc. (the Company). Employees become eligible to participate in the Plan when they have attained the age of 18 and have completed six months of service. Employees are treated as participants the first day of each month following the date on which eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year the Plan provides that active participants may make voluntary pre-tax and after-tax contributions to the Plan up to the maximum allowed by the Internal Revenue Code (\$23,000 for 2024) as adjusted for applicable percentages of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 for 2024). The Company may make matching contributions of a discretionary percentage. During 2024, the Company matched 50% of the employee's contribution up to 3% of the employee's compensation. The Company may contribute additional amounts if it so decides. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions, as well as their portion of the Company's contributions, into various investment options offered by the Plan.

The Plan utilizes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan within six months. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contribution invested in a designated balanced fund until changed by the participant. Deferral rates automatically increase by 1% per year until the deferral rate reaches 10%.

Participant Accounts - Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, and Plan earnings, and charged with an allocation of administrative expenses, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions plus the earnings thereon. A participant is fully vested in the Company's contributions after six years of credited service.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance (reduced by the highest outstanding loan balance during the 12-month period), whichever is less, and may have a maximum of one loan outstanding at any given time. The loans are secured by the balance in the participant's account and bear interest at rates.

commensurate with local prevailing rates. Principal and interest are paid ratably through regular payroll deductions, not to exceed five years. The term of the loans are limited to five years.

Normal Retirement - Normal retirement age is 65 years of age.

Payment of Benefits - Payment to participants with vested balances of less than \$5,000 at retirement, death, disability, or termination is in the form of a lump-sum payment. If the participant has a balance in excess of \$5,000 the participant may elect any method or form of distribution available under the Plan. In-service withdrawals are allowed for participants over 59.5 years of age and for financial hardships, as defined by the Plan.

Forfeited Accounts - Forfeitures can be used to pay administrative expenses of the Plan or reduce the Company's contribution. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$181, respectively. In 2024, \$25,158 of forfeitures were used to reduce the Company's profit sharing contribution.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates - The accompanying financial statements are prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect: (1) the reported amounts of assets and liabilities, (2) disclosures such as contingencies, and (3) the reported amounts of revenues and expenses included in such financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition - Investments are valued at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors. The purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Contributions - Contributions from Plan participants and the Company discretionary matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Benefits Paid - Benefits are recorded when paid.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the

accrual basis. No allowance for credit losses has been recorded as of December 31, 2024, and 2023 for these notes receivable. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Administrative Expenses - Certain expenses to maintain the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value on investments.

Subsequent Events - These financial statements considered subsequent events through September 29, 2025, the date these financial statements were available to be issued.

3. INVESTMENTS CERTIFIED BY PRINCIPAL LIFE INSURANCE COMPANY (UNAUDITED)

The following is a summary of the information as of December 31, 2024, and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by Principal Life Insurance Company (Principal), a qualified institution, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from Principal that information provided to the Plan Administrator by Principal related to the following is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information below, the values in Note 4 and Note 5, and the values in the supplemental schedule related to the following.

4. FAIR VALUE MEASUREMENTS

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The following are three levels of inputs that may be used to measure fair value:

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for the instrument measured at fair value, including the general classification of such instrument pursuant to the valuation hierarchy.

Pooled Separate Accounts - The pooled separate accounts invest in single mutual funds. The fair value of the mutual funds are based on publicly quoted pricing inputs.

Below are the Plan's financial instruments carried at fair value on a recurring basis by the fair value hierarchy levels described previously. There are no Level 2 or 3 investments at December 31, 2024 or 2023.

5. GUARANTEED INVESTMENT CONTRACT WITH PRINCIPAL LIFE INSURANCE

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance totaling \$17,259 and \$19,817 at December 31, 2024 and 2023, respectively. Principal Life Insurance maintains the contributions in a general account. The account is credited with earnings on underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting

rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Life Insurance, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletions of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

6. **PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan assets are managed by Principal, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Principal for certain investment management fees were deducted from the net asset values of the registered investment companies held by the Plan. The various funds' operating expense ratios ranged from 0.02% to 0.92%, as of December 31, 2024. The Plan paid \$18,756 for administrative expenses for the year ended December 31, 2024.

7. TAX STATUS

The Plan adopted a Standardized Pre-Approved Profit-Sharing Plan (Prototype Plan) designed to qualify under Section 401 of the Internal Revenue Code (IRC). The Plan has obtained a copy of a favorable determination letter for the Prototype Plan dated June 30, 2020, of which the Plan is relying upon, that the Prototype Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. No provision or liability for income taxes has been included in the financial statements.

8. PLAN TERMINATION

Although it has not expressed an intention to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, the interests of the participants in the Plan shall be fully vested at the time of termination, and Principal shall liquidate all assets of the trust and continue to administer the trust in accordance with its provisions until all obligations have been satisfied.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. PROHIBITED TRANSACTIONS

For the period ended December 31, 2023, contributions of \$583 were not deposited within the required timeframe, as stated and interpreted by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The employer self-corrected the contributions and paid the applicable lost earnings in 2024. See also the supplemental Schedule of Delinquent Participant Contributions for more details.
