1. DESCRIPTION OF PLAN

The following description of the Tootsie Roll Industries, LLC Profit Sharing Plan (the "Plan") is provided for general information purposes only. Users of these financial statements should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established by Tootsie Roll Industries, LLC (the "Company") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") The Plan is commonly managed with all other defined contribution plans of the Company and its wholly-owned subsidiaries. All employees, except union employees and employees working 1,000 hours or less per year, as defined in the plan document, are immediately eligible to make elective contribution deferrals to the Plan. After completion of two years of service, employees are eligible for Company discretionary contributions to the Plan. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of various investment options.

Contributions - Each year, participants may contribute up to 100% of annual compensation (salary reduction contributions), as defined in the plan document. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Plan allows the Company to contribute a discretionary amount on the behalf of all eligible employees. In 2024 and 2023, this contribution was 2% of the participant's gross compensation, up to the annual compensation limit, as established by the Internal Revenue Service. Contributions are subject to certain limitations.

Participant Accounts - Each participant's account is credited with the participant's salary reduction contributions, rollover contributions, and an allocation of the Company's contributions and plan earnings or losses (net of administrative expenses). Allocations are based on the participant's eligible compensation or account balance, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Loans – Participant loans are not permitted.

Vesting – Participants are 100% vested at all times in the Plan.

Payment of Benefits - Benefits may be paid to the participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the plan document. The Plan provides for normal retirement at age 65. Benefits are distributed in the form of a lump-sum payment, installments, or partial withdrawal. In-service distributions are allowed, from the participant's elective deferral or rollover contributions, if the participant has reached age 59-1/2. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates – The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

Investment Valuation and Income Recognition – The Plan's investments are valued at fair value using quoted market prices. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. The mutual funds held by the Plan are deemed to be actively traded.

The Plan is invested in the Voya Stable Value Option, a pooled separate account, whose only underlying investment is the "Quality Fund II" (the "Fund"). The Fund has imbedded guaranteed investment contracts which are fully benefit responsive as well as other publicly traded fixed income securities. The statements of net assets available for benefits present the investment using the net asset value ("NAV") practical expedient in accordance with Accounting Standards Codification 820, as amended by Accounting Standards Update 2015-17. The Fund is presented at fair value, which is based on participation units owned and the NAV of the funds on the last business day of the Plan year. The NAV is based on the fair value of the underlying investments held by the Fund, plus cash balances and accruals, less any liabilities. Participant transactions (issuances and redemptions) may occur daily.

Should the Plan elect to exit the contract, the Plan can withdraw in cash its pro-rata share of the market value of the underlying assets held in the account by providing a 30 day notification. Plan administration believes termination of the contract is not probable.

There were no unfunded commitments and no redemption limitation or notice periods, but the issuer is allowed to terminate the contract with the fund and settle at an amount different from contract value at any time if required by federal or state law; or if there are any potential or actual adverse financial effects to the contract resulting from any change(s) in plan provisions, the administrative services of the Plan, or investment options offered by the Plan.

Administrative Expenses – The Company has borne substantially all of the Plan's administrative expenses.

Payment of Benefits – Benefits are recorded when paid.

3. PARTIES-IN-INTEREST

Certain plan investments are shares of mutual funds managed by the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain fees paid by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. All participants are 100% vested in their accounts.

5. AMOUNTS OWED TO PARTICIPANTS WITHDRAWING FROM THE PLAN

There are no amounts owed to participants who have withdrawn from the Plan as of December 31, 2024 and 2023 that have not been paid and therefore included in net assets available for benefits.

6. FAIR VALUE MEASUREMENTS

The Plan follows generally accepted accounting principles associated with fair value measurements and disclosure. Generally accepted accounting principles define fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

Generally accepted accounting principles related to fair value disclosure also establish a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The three levels of inputs that may be used to measure fair value are as follows:

- Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities ; or
- Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The plan sponsor is responsible for the determination of fair value. Accordingly, they perform periodic analysis on the prices received from the pricing services used to determine whether the prices are reasonable estimates of fair value. As a result of these reviews, the plan sponsor has not historically adjusted the prices obtained from the pricing services.

The following valuation methods and assumptions were used by the Plan in estimating the reported values for the investments described:

Mutual funds: Mutual funds are reported at quoted market prices in active markets.

Common Collective Trusts: Common collective trust funds are reported at NAV, as provided by the trustee of the funds.

Stable Value Option: The stable value option is considered a pooled separate account and is reported at NAV, as provided by the trustee of the Fund.

7. INVESTMENTS

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

8. INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

9. TAX STATUS

The Plan adopted a prototype defined contribution plan and trust sponsored by Voya Institutional Trust Company ("Voya"), which obtained its latest favorable opinion letter on June 30, 2020 from the Internal Revenue Service ("IRS"). The opinion letter states that the prototype plan constituted a qualified plan under Section 401 of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is currently designed and continues to be operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax-exempt and therefore no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or DOL. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
