## Independent Auditors' Report

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

### 1. Description of Plan

The following description of the Cavalry Investments, LLC 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established on July 1, 1985. The Plan is available to all employees of Cavalry Investments, LLC and the following related employers: Bala Partners, LLC, Cavalry Investment Holdings, LLC, Cavalry Portfolio Services, LLC, Lancewood Advisors, LLC, Lancewood Capital, LLC and Mecox Bay Financial, LLC (collectively the "Company"). The Plan provides deferred compensation benefits and is subject to the applicable regulations of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan investments are administered and held in a trust by the Plan's trustee, Fidelity Management Trust Company (the "Trustee"), which also serves as the custodian of the Plan. Fidelity Workplace Services LLC, an affiliate of the Trustee, is the record-keeper of the Plan. The Trustee, the record-keeper and the Plan administrator are appointed by the Company.

#### **Eligibility**

Participants are automatically entered in the Plan (unless they elect otherwise) on the first day of the month following two months of employment, provided that they are 21 years old. The Plan excludes those employees who are residents of Puerto Rico.

Participants are eligible for matching contributions upon enrollment in the Plan.

#### **Contributions**

Participants in the Plan may make contributions on a pre-tax basis subject to the Internal Revenue Code ("IRC") limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. A participant shall be permitted to irrevocably designate a portion of their elective deferral contributions allowed under the Plan as a Roth contribution and are permitted to make Roth direct rollover contributions to the Plan. A Plan participant may make a transfer to the Plan of a benefit from a qualified retirement plan of another employer, referred to as a rollover, with certain restrictions.

Prior to May 15, 2020 employees were automatically enrolled in the Plan at a rate of 2% of their eligible compensation, which increases annually by 1% of compensation until it reaches a maximum of 4% of compensation. Effective May 15, 2020, all new employees were automatically enrolled in the Plan at a rate of 4% of their eligible compensation, which increases annually by 1% of eligible compensation until it reaches a maximum of 10%. Employees may stop or change this automatic contribution at any time. Participants can change the amount of their elective deferral contributions prospectively on the first of each month.

### 1. Description of Plan *(continued)*

#### ***Contributions (continued)***

The Company may make a matching contribution to the Plan based on a discretionary percentage of each participant's elective deferral contribution. For the year ended December 31, 2024, the Company's matching contribution was 0.50%, 1.00%, 1.50% or 2.00% of compensation if the participant contributed at least 1.00%, 2.00%, 3.00% or 4.00% of compensation, respectively.

#### ***Participant Accounts***

The Plan administrator establishes and maintains a separate account for each participant, which is credited for rollover and voluntary contributions the participants make, Company matching contributions, and Plan earnings. Income earned and net appreciation or appreciation on Plan investments, for a given investment, are allocated in proportion to the participant's account balances in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Investments***

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

#### ***Vesting***

Participants are immediately and fully vested in their pre-tax or Roth contributions plus actual earnings thereon. Vesting in the employer matching contributions is based on years of continuous service. A participant is vested in all employer contributions as follows:

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. A borrower is limited to having a maximum of one outstanding loan under the Plan at any given time. Loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are paid ratably through payroll deductions over a period of time not to exceed five years. If the proceeds are used to construct or rehabilitate a participant's principal residence, the Plan administrator may permit a longer repayment term. Principal and interest repaid is reinvested based on the participant's present investment allocation selection.

Delinquent participant loans are classified as distributions based upon the terms of the Plan document.

#### ***Payment of Benefits***

Upon termination of service prior to the normal retirement age, the Plan administrator may direct the Trustee to distribute the participant's vested benefits within 60 days. Upon retirement, hardship, termination, death, age 59 1/2 or disability, vested benefits are distributed at the participant's or beneficiary's election via a lump sum payment.

A participant may apply for a hardship withdrawal at any time. This withdrawal must be for an immediate financial need for which funds are not reasonably available from other resources. Hardships include expenses incurred or necessary for medical care of the participant or their dependents, costs directly related to the purchase of a principal residence for the participant, payment of tuition and post-secondary education related expenses for the participant or their dependents, to prevent eviction from or foreclosure on a principal residence and to pay for funeral or burial expenses or immediate and heavy financial need as determined based on Internal Revenue Service regulations.

#### ***Forfeitures***

Forfeitures of terminated participants' non-vested accounts serve to reduce employer contributions or Plan expenses. The Company elected to use \$13,111 from the forfeited non-vested accounts to pay certain Plan expenses, as allowed by the Plan during the year ended December 31, 2024. At December 31, 2024 and 2023, the balance of the forfeited non-vested accounts amounts to \$82,775 and \$38,168.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The Plan prepares its financial statements in conformity with accounting principles generally accepted in the United States of America ("US GAAP"), using the accrual basis of accounting, which recognizes revenue when it is earned and expenses as they are incurred.

#### ***Use of Estimates***

In conformity with US GAAP, the Plan's management makes estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions to net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows US GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

The Plan's investments in mutual funds are considered to be valued based on Level 1 inputs.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Mutual Funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price. The mutual funds are considered to be actively traded.

Interest income is recorded on an accrual basis. Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade date basis.

Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### 2. Summary of Significant Accounting Policies (*continued*)

#### ***Notes Receivable from Participants***

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are paid. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is deemed to be a benefit distribution upon a distributable event.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

### 4. Tax Status

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

The IRS has determined and informed the Company by issuing a determination letter dated June 30, 2020, that the Plan and the related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust was tax-exempt as of the financial statement date.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company may terminate the Plan at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, all amounts credited to participant accounts shall become fully vested and non-forfeitable. Accordingly, assets will be distributed to the participants and beneficiaries in proportion to their respective account balances.

### 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 7. Party-in-Interest Transactions

Certain investments of the Plan are managed by the Trustee as defined by the Plan document and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Company, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

### 8. Subsequent Events

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 30, 2025.


