### Note 1: Plan Description

The following description of the RK Industries, LLC Salary Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution 401(k) profit sharing plan covering all non-union employees of RK Industries, LLC (the "Company") who have completed 6 months of service, and are not leased. The Plan covers employees rendering services for the employer on contracts subject to the Davis-Bacon Act, Service Contract Act, or other Federal, State, or Municipal prevailing wage laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Company is the plan administrator and is responsible for oversight of the Plan. Fidelity Management Trust Company ("Fidelity") serves as the trustee and recordkeeper. The plan advisory committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Contributions

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan, on a pretax or after-tax basis. Deferral contributions and after-tax Roth contributions shall not exceed certain limits set forth by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan includes a Safe Harbor provision that requires the Company to contribute 100% of the participant's elective deferral that does not exceed 3% of the participant's contribution, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation, but do not exceed 5% of the participant's compensation. In addition, the Company makes contributions to the Plan for employees, subject to prevailing wage laws, which are determined by the employer based on rates that satisfy the wage determination issued by the governmental agency responsible for the contract. Additional discretionary matching contributions may also be made for employees who are not subject to such prevailing wage rates, at rates determined by the Company. Each year, at the discretion of the Company's Board of Directors, the Company may also elect to make a discretionary nonelective profit sharing contribution to the Plan. During the year ended December 31, 2024, the Company made safe harbor matching contributions of \$2,324,920 and no additional discretionary matching contributions or discretionary nonelective profit sharing contributions.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, and allocations of plan earnings (losses), and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Note 1: Plan Description (Continued)**

#### **Vesting**

Participants are immediately vested in their voluntary contributions and the Company's Safe Harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions, plus actual earnings thereon, is based on years of continuous service. Participants are 100% vested in the discretionary matching and profit sharing contributions after 3 years of credited service.

#### **Investment Options**

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, interest bearing cash, a common collective trust (stable value fund), and self-directed brokerage accounts as investment options for participants. Participants may change their investment options at any time.

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 reduced by the excess of the highest outstanding balance of plan loans or 50 percent of their vested account balance. Loan terms range from one to five years, or up to 15 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate comparable to the rates being charged by lending institutions in the same geographic locale as the Company. A loan will carry the same rate of interest throughout its term. Interest rates on loans outstanding at December 31, 2024, range from 4.25% to 9.50%. Principal and interest is paid ratably through weekly payroll deductions.

#### **Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,091 and \$7,805, respectively. These funds will be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During 2024, forfeitures of \$2,970 were used to offset plan expenses and \$0 were used to offset Company contributions.

#### **SECURE 2.0**

The SECURE 2.0 Act of 2022 (“SECURE 2.0”), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provisions to elect in the future.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan’s valuation policies utilizing information provided by the investment advisors and the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held, during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable may be reclassified as benefits paid to participants based upon the terms of the plan documents.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 2, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Information Prepared and Certified by the Trustee (Unaudited)**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan has certified that the following unaudited data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Interest and dividend income, net appreciation in fair value of investments, and interest income on notes receivable from participants as shown in the Statement of Changes in Net Assets Available for Benefits.
- All investment information included in the Supplemental Schedule - Form 5500 Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

This information has not been audited by the Plan's independent auditors.

### **Note 4: Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets in active markets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level

1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Interest Bearing Cash:** Valued at cost plus accrued interest, which approximates fair value. These amounts are considered highly liquid and are typically held in money market accounts or similar instruments.

**Self-Directed Brokerage Accounts:** Accounts primarily consist of interest bearing cash and crypto currencies that are valued on the basis of readily determinable market prices.

**Common Collective Trust:** The investments include a stable value fund. The fair values of participation units held in the stable value fund are based on NAV after adjustments to reflect all fund investments at fair value, including direct and indirect interest in fully benefit-responsive contracts. The NAV is used as a practical expedient to measure fair value. If the fund experiences periods of insufficient liquidity, then the stable value fund may defer honoring any payment request until liquidity is sufficient. The Plan is permitted to redeem investment units at NAV on the measurement date. The investment objective of the fund is to seek safety of principal and consistency of returns while attempting to maintain minimal volatility.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5: Party-in-Interest Transactions

Fidelity is the trustee and recordkeeper, and Innovest Portfolio Solutions provides investment advisory services to the Plan. Transactions with these companies qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments as they are paid through revenue sharing rather than a direct payment. The Plan made direct payments of \$91,230 for administrative services to Fidelity which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

### Note 7: Tax Status

The Plan utilizes a volume submitter plan, which obtained a favorable opinion letter from the IRS dated June 30, 2020, stating that the volume submitter plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate the tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosures in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in place.

### Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
