Note 1 - Description of Plan

The following description of the Bozeman Deaconess Health Services Comprehensive Health and Welfare Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Generally, the Plan provides health and welfare benefits to employees who work on a continuing and regular basis of at least 16 hours per week. Employees are eligible the first day of the month following the completion of 30 days of work.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participating Employers

The following Bozeman Health and Affiliate company employers participate in the Plan:

- Bozeman Deaconess Health Services DBA Bozeman Health
- Bozeman Health Medical Group, LLC
- Bozeman Health Big Sky Medical Center, LLC
- Bozeman Health Foundation
- Bozeman Health Urgent Care, LLC
- Bozeman Health Deaconess Hospital
- Bozeman Health Convenience Care, LLC

Benefits

The Plan provides medical, pharmacy, dental, vision, life insurance, accidental death and dismemberment, and long-term disability benefits to eligible employees of Bozeman Deaconess Health Services DBA Bozeman Health and affiliates (collectively referred to as Sponsor) and their covered dependents as defined by the Plan document. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Insured Benefits

The Plan fully insures the dental, vision, life insurance, accidental death, and dismemberment, and long-term disability benefits through insurance contracts. Premiums for the fully insured benefits are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The Plan is responsible for individual claims up to \$250,000 per year.

Self-Insured Benefits

The Plan is “self-insured” for medical and pharmacy benefits up to stop-loss limits. The claims for self-insured benefits are processed by the Plan’s third-party claims processor under administrative services only (ASO) arrangements. The claims processor pays claims directly to or on behalf of participants and is then reimbursed by the Plan’s 419(e) Trust. Despite the Plan’s utilization of a third-party claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan’s actual utilization pattern of specific drugs.

The Plan has flexible spending account (FSA) arrangements for health care and dependent care reimbursements that are funded solely by active employee contributions. The FSA’s allow eligible participants to be reimbursed tax free for qualified health care and dependent care expenses subject to annual limitations established under the Plan. The employer is not permitted to refund any part of the FSA balances to the employee; the accounts cannot be used for anything other than qualified health care and dependent care expenses; remaining amounts are not portable upon termination once the employee leaves the employer; and any unused amount is forfeited back to the Plan Sponsor. Residual FSA amounts unused at the end of the year can be carried over for three months into the next year to allow qualified expenses incurred during that period to be reimbursed from the account. Any residual FSA amounts remaining after the three-month extension are immediately forfeited.

Active employees enrolled in the high-deductible health plan (HDHP) are eligible to enroll in a health savings account (HSA), subject to Internal Revenue Service (IRS) eligibility requirements. Employees can elect to make contributions to their account subject to IRS limits. The contributions made to the HSA can be used on a tax-free basis to pay or reimburse for qualifying health care expenses. The participant owns the account and is responsible for substantiating distributions from the HSA account.

HSAs are not considered Plan assets as they belong to the individual participants; therefore, there is no reporting in the accompanying financial statements as there is no obligation of the Plan to pay the benefits.

Contributions

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of dental, vision, supplemental and dependent life insurance and supplemental accidental death and dismemberment insurance programs, based on the current group rate premium cost. The Sponsor pays the full cost of basic life insurance, basic accidental death, and dismemberment insurance, and stop loss insurance.

The Sponsor makes contributions to the Plan as needed to fund claims in excess of participants’ contributions. Any deficiency of the Plan’s net assets over benefit obligations is funded by the Sponsor on a pay-as-you-go basis.

Plan Termination

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 2 - Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations, and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Payments for Benefits

Premiums paid by either the Sponsor or the 419(e) Trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan, are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits. These payments are recorded as claims paid in the accompanying statements of changes in net assets available for benefits.

Stop Loss

Premiums for stop loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits for the year ended December 31, 2024 and 2023. Stop loss refunds totaling \$1,031,981 and \$1,234,800 for the years ended December 31, 2024 and 2023, respectively, have been netted with claims paid in the accompanying statements of changes in net assets.

Refunds

Refunds due from the Plan's PBM cannot be reasonably estimated. As a result, such rebates are recorded when received. Pharmacy rebates totaling \$2,087,953 and \$1,873,605 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Flexible Spending Accounts

Employee contributions totaling \$365,816 and \$327,430 were received during the plan years ended December 31, 2024 and 2023, respectively, for the health care reimbursement spending accounts and are reflected in participant contributions in the accompanying statements of changes in net assets. Claims submitted under the health care reimbursement accounts before year end or during the subsequent extension period totaled \$365,816 and \$327,430 for the years ended December 31, 2024 and 2023, respectively, and are included in claims paid in the statements of changes in net assets available for benefits.

Receivables and Allowance for Credit Losses

The Plan has tracked historical loss information for its receivables and determined that all receivables are fully collectible and no allowance for credit losses is needed.

Management believes that the historical loss information it has compiled is a reasonable base on which to determine expected credit losses for receivables held at December 31, 2024 and 2023, because the composition of the receivables at those dates is consistent with that used in developing the historical credit expectations (i.e. the similar risk characteristics of its receivables). Additionally, management has determined that the current and reasonable and supportable forecasted economic conditions are consistent with the economic conditions included in the historical information. As a result, the historical loss rates have not been adjusted for differences in current conditions or forecasted changes. Accordingly, the allowance for credit losses at December 31, 2024 and 2023, is \$-0-.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies and procedures utilizing information provided by investment advisors and custodians. See Note 3 for discussion on fair value measurements.

Interest income is recorded on the accrual basis.

The classification of investment earnings reported in the statements of changes in the net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Expenses

Administrative expenses incurred in the administration of the Plan that are paid by the Plan include medical administrative fees and professional service fees. These expenses are recorded as deductions in the accompanying statements of changes in net assets available for benefits. Expenses that are paid by the Sponsor are excluded from these financial statements.

Claims Incurred but not Reported

Plan obligations at December 31, 2024 and 2023, for health claims incurred by participants, but not reported at that date are estimated based on an analysis of claims paid subsequent to the Plan year-end. Such estimated amounts are included in the accompanying statements of benefit obligations in the amounts currently payable.

Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4 - Tax Status

The Trust established under the Bozeman Deaconess Health Services Comprehensive Health and Welfare Benefit Plan to hold the Plan’s assets, is a non-qualified holding trust defined under Section 419 (e) of the Internal Revenue Code and is subject to income tax as a complex trust. The Plan administration does not intend to change this status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. No federal or state income taxes have been recorded in the years ended December 31, 2024 and 2023, for unrelated business taxable income.

Note 5 - Other Income

Several years ago, Bozeman Health (along with five other Montana health systems) was involved in a lawsuit relating to alleged ERISA violations. This case was settled in 2019. As a result of this lawsuit, the Sponsor pursued an insurance claim against the Plan’s fidelity bond insurer. This claim was settled during 2022 resulting in the Plan receiving \$255,500 during 2023. This is recorded as other income on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2023. No such activity or other income received or recorded during the year ended December 31, 2024.

Note 6 - Related Party and Party-in-Interest Transactions

As described in Note 1, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The estimated liability for claims payable and claims incurred but not reported is based on historical trend information, which is subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would-be material to the financial statements.

Note 8 - Concentration of Credit Risk

The Plan maintains its cash and overnight repurchase accounts in bank deposit accounts which exceed federally insured limits. Accounts are guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor, per insured bank, for each account ownership category. At December 31, 2024 and 2023, the Plan had approximately \$235,000 and \$39,000, respectively, in excess of FDIC-insured limits.

Note 9 - Reconciliation of Financial Statements with Form 5500
