## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
St. Mary's Home for Children 403(b) Retirement Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting**

As discussed in Notes 1 and 5 to the financial statements, the Board of Directors of the St. Mary's Home for Children, the Plan's Sponsor, voted on October 19, 2024 to terminate the Plan. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**1. Description of the Plan**

The following description of the St. Mary's Home for Children 403(b) Retirement Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a participant-directed defined contribution 403(b) plan covering substantially all employees of St. Mary's Home for Children (the Plan Sponsor, Organization or Employer). Employees become eligible upon hire and can enter the Plan immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Organization ceased operations on August 22, 2024. On October 17, 2024, the Board of Directors (BOD) approved the dissolution of the Organization, and on October 19, 2024, the BOD formally voted to terminate the Plan. The Plan termination was finalized on December 4, 2024, see Note 5 for additional information. The following is a description of the Plan prior to termination.

The Plan Sponsor is also the Administrator of the Plan. As Administrator, the Plan Sponsor maintains participant account records and instructed the custodian to execute transactions such as benefit payments to participants. Teachers Insurance and Annuity Association of America (TIAA) is the appointed custodian of the Plan and acts at the direction of the Plan Administrator regarding investments and changes in those investments.

Effective October 19, 2024, the BOD's approved a resolution to terminate the Plan and delegated authority for the termination process to the Organization's Dissolution Committee. The Plan Sponsor continued to serve as Plan Administrator through December 31, 2024, at which time fiduciary responsibility for plan administration was formally transferred by the Dissolution Committee to the Organization's dissolution attorney.

***Contributions***

Participants may elect to contribute up to 100% of pretax annual compensation not to exceed annual limitations as provided by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants with 15 years of service are entitled to make special Code Section 403(b) catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions), provided the rollover is made directly from another plan and is contributed to the Plan within sixty (60) days of the receipt of the distribution.

The Plan Sponsor may contribute discretionary non-elective contributions as determined by the Plan Sponsor's Board of Trustees. These contributions are allocated to the accounts of the individuals who are participants in the Plan on the last day of the Plan year for which such contributions are made and who have completed two years of service (minimum of 1,000 hours per year), and are twenty-one (21) years old or older. No Employer discretionary non-elective contributions were contributed to the Plan for the period from January 1, 2024 to December 4, 2024.

***Investment Options***

Participants may direct their contributions in percentage increments into a series of annuity funds, a pooled separate account, or the insurance company general account. Participants may change their investment options at any time.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Plan Sponsor's discretionary non-elective contribution, and their allocation of the Plan's earnings and losses. The allocation of earnings and losses is performed based on individual participant account balances. The Plan allocates discretionary non-elective contributions from the Plan Sponsor to participants as a uniform percentage of compensation. The benefit a participant is entitled to receive is limited to the participant's vested account balance.

***Vesting***

Participants are immediately vested in their contributions and Plan Sponsor contributions, plus actual earnings thereon.

***Plan Loans***

Plan loans are issued as separate contracts by TIAA as contemplated under IRC Section 72(p)(5) and do not represent plan assets. Loans are collateralized using a participant's TIAA Traditional account balance in an amount equal to 110% of the outstanding loan balance. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her TIAA Traditional account balance subject to annuity contract and plan provisions. Loan terms range from 1 to 5 years in one-year increments (up to 10 years for the purchase of the participant's primary residence). Principal and interest are paid ratably by the participant to TIAA and each payment will reduce amounts collateralized by the borrowing participant's TIAA Traditional account balance. As of December 4, 2024 there were no loan balances outstanding from participants to TIAA. As of December 31, 2023, loan balances outstanding from participants to TIAA were \$2,531.

***Payment of Benefits***

On retirement, death, disability, termination of service or at age 59½, a participant (or participant's beneficiary in the event of death) may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. A participant may also elect to receive a joint and survivor annuity or installments over a specified period of time not to exceed the life or life expectancy of the participant or beneficiary. Participants who have reached the age of 55 may elect to receive a cash withdrawal as permitted.

Hardship withdrawals from the Plan are permitted, subject to the limitations imposed by the IRC.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

As discussed in Note 5 to the financial statements, the Organization's BOD voted to terminate the Plan on October 19, 2024, and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value, except for the fully benefit-responsive investments in the insurance company general account, which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3). Contract value represents investments at cost plus accrued interest income less withdrawals and expenses (Note 4). The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and custodians.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Participant contributions are recorded bi-weekly when the Plan Sponsor remits the contributions for investment into the Plan.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

***Administrative Expenses***

Expenses incurred in the administration of the Plan are paid by the Plan Sponsor unless the Plan Sponsor directs that the expenses be paid by the Plan. Expenses paid by the Plan Sponsor are excluded from these financial statements. Investment management and recordkeeping fees, if applicable, are paid by the Plan as a reduction of investment income (net appreciation or depreciation) from the related investment fund. During 2024, the Plan terminated and no administrative expenses were incurred by the Plan.

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and disclosures. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Plan Benefits.

***Financial Instruments with a Concentration of Credit Risk***

Prior to termination, the Plan's investments are held by a single custodian. The Plan's exposure to credit risk is associated with the outside entity's non-performance of its fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

***Subsequent Events***

Management has evaluated subsequent events through September 30, 2025, which is the date these financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

***Variable Annuities:*** Variable annuities include investments in CREF Accounts and TIAA Access Accounts. The CREF and TIAA Access Accounts are primarily valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Unit values are available at TIAA.org. Variable annuity contracts held by the Plan are deemed to be actively traded.

***Pooled Separate Account:*** The pooled separate account represents the TIAA Real Estate Account (REA) which generally invests in real estate properties and real estate-related investments. The REA's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The REA sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Unit values are calculated each day and are posted at tiaa.org.

Although the underlying assets of the REA cannot be quickly sold and converted to liquid assets, the TIAA General Account provides the REA with a liquidity guarantee i.e., TIAA ensures that the REA has funds available to meet participant redemption, transfer or cash withdrawal requests executed at quoted unit values. As a result, the REA is deemed to be actively traded.

***TIAA Traditional Annuity Fund (Non Benefit-Responsive Portion):*** A fixed rate guaranteed annuity contract available as an investment option to Plan participants offered through a variety of contract types. Each contract is fully and unconditionally guaranteed by TIAA. The type of contract through which a participant invests determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant’s account, and the options for receiving income upon retirement. Certain contracts are nonbenefit-responsive (NBR), and accordingly, are reported at fair value, which approximates the contract value of accumulated cash contributions and interest credited to the contract, less any withdrawals.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant’s principal, plus a specified minimum rate of interest, is guaranteed by TIAA’s claim-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA’s Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years

As a result of the Plan termination, there are no investment balances at December 4, 2024 (Note 5).

**4. Insurance Company General Account**

Investments held in the insurance company general account (General Account) include the TIAA Traditional Guaranteed Annuity Fund (TIAA Traditional), which is comprised of certain fully benefit-responsive contracts and certain non-benefit-responsive contracts. In addition, the General Account includes the Plan Loan Default Fund (PLDF) which is invested in a TIAA Traditional fully benefit-responsive contract.

TIAA Traditional is an unallocated fixed-annuity contract that is fully and unconditionally guaranteed and backed by the claims-paying ability of TIAA. TIAA Traditional provides a guarantee of principal, a guaranteed minimum rate of interest between 1% and 3% and the potential for additional interest if declared by TIAA. Additional interest, when declared, remains in effect for the “declaration year,” which begins each March 1. Additional interest is not guaranteed for future years. Contributions to a participant’s account purchases a guaranteed amount of lifetime annuity income. When a participant’s account in the TIAA Traditional is annuitized based on available options, the present value of the stream of payments is equal to the account balance. The subsequent stream of annuity payments occurs outside of the Plan and is not reflected in these financial statements.

In determining the rate of interest to be guaranteed for the upcoming 12-month period, TIAA considers the projected investment earnings, the current interest environment, its investment expense and a profit and risk component for the 12-month period. The funds do not have maturity dates or penalties for early withdrawals. Contract value represents contributions made under the contract plus interest at the contract rate, less funds used to pay termination benefits, in-service withdrawals and to pay for the insurance company’s administrative expenses.

The PLDF represents plan assets held as collateral for plan loans on which participants have not made payments as agreed upon in the loan agreement and the loan has gone into default. The PLDF is maintained in TIAA’s general account until an event allows the participant to take a cash distribution at which time the outstanding loan is paid. The PLDF is valued at the outstanding defaulted loan balance plus accrued interest.

Certain events limit the Plan’s ability to transact at contract value with TIAA. Such events include the following: amendments to the Plan documents, changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. As further described in Note 5, the Plan terminated in 2024. The ability of the Plan to realize contract value upon liquidation is subject to the terms of the termination provisions in the investment contract.

Fully benefit-responsive contracts have no liquidity restrictions except that immediate transfers cannot be made to competing investment options pursuant to the contract’s “equity wash” provisions, as defined in the Plan documents. The Plan’s ability to receive amounts due in accordance with fully benefit-responsive and non-benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The following table represents the Plan’s investment in the TIAA Traditional fully benefit-responsive contract, the average crediting rate and the range used to measure that instrument:

**5. Plan Termination**

The Organization ceased operations on August 22, 2024. On October 17, 2024, the BOD approved the dissolution of the Organization, and on October 19, 2024, the BOD formally voted to terminate the Plan. All participants were 100% vested in their account balances as of the termination date.

The Plan termination was finalized on December 4, 2024. Benefit payments were satisfied through distributions as full or partial cash payments or as rollovers into an eligible plan or individual retirement account. If a participant did not make a distribution election, assets held in individually owned annuity contracts issued by TIAA-CREF shall remain the property of the respective participants. Each participant shall retain all rights, benefits and responsibilities under the terms of their individual annuity contracts, which will continue independently of the Plan. As of December 4, 2024, Plan assets were fully distributed and no assets remained in the Plan.

**6. Income Tax Status**

Final regulations under Section 403(b) of the Internal Revenue Code (IRC) were published by the Internal Revenue Service (IRS) on July 26, 2007, requiring plan sponsors to adopt a written plan document effective January 1, 2009. The Plan Sponsor adopted a written Plan effective January 1, 2009, which it believes satisfies the written plan requirement and has since adopted required amendments. The Plan Sponsor further believes that the Plan was designed and operated in compliance with applicable requirements of the IRC through its termination on October 19, 2024, and that participants' account balances were distributed in accordance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 4, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
