**NOTE 1 - PLAN DESCRIPTION**

The following description of the Athens Insurance Service, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Adoption Agreement (the Agreement) for a more complete description of the Plan's provisions.

(a) General

The Plan was established effective January 1, 1992 as a 401(k) salary reduction plan for its employees. The Plan is a restatement of a previously established qualified plan and trust of the employer which was effective July 1, 1969. The Plan is a defined contribution plan. Employees who have completed 30 days of service and are at least 18 years of age are eligible to participate in the Plan on the first of the month following eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and as such, has been amended periodically to comply with changes made by ERISA. The plan sponsor is Athens Insurance Services, Inc. (the Company). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees. The Plan operates under a volume submitter profit sharing plan of its Benefits Administrator, Empower Annuity Insurance Company, that maintains an individual account for each participant.

(b) Contributions

Participants may elect to make a basic salary reduction contribution up to the maximum percentage allowable not to exceed Internal Revenue Service limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and an insurance investment contract as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. The automatic deferral percentage will increase by 1% per year up to a maximum of 6% of compensation. The Plan allows for discretionary employer matching contributions to the plan of \$0.50 for every dollar contributed on the first 6% of pay contributed each pay period. Participants may only elect to make a basic salary reduction contribution in whole percentage increments. Contributions are subject to certain statutory limitations.

(c) Participant's Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, and (b) plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service.

Participants are 100% vested in their salary reduction contributions at all times. The employer's matching contributions for participants are vested based on the following schedule:

Terminated employees' nonvested benefits may be utilized to reduce the employer's matching contributions and pay plan expenses.

Each plan year, the Company, in its sole discretion, may make a non-elective contribution to the plan. Employer non-elective contribution of \$1,118,617 was made for the 2024 plan year.

(e) Forfeitures

Forfeitures of non-vested Company contributions are used to reduce future Company contributions. During 2024, \$45,815 of forfeited participant accounts was used to reduce the Company's contributions.

(f) Hardship and Pre-Retirement Distributions

Hardship distributions are allowed for participant accounts which are 100% vested. Pre-retirement distributions are allowed, provided that the participant is 100% vested and has reached the age of 55.

(g) Notes Receivable from Participants

The Plan allows for loans to be made to participants in accordance with the provision and restrictions of ERISA. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Loans must be repaid through payroll deductions within 5 years unless the loan is used for the purchase of a primary residence. If the loan is used to purchase a primary residence, the loan must be repaid within 30 years. Principal and interest are paid ratably through bi-weekly payroll deductions.

(h) Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Benefits are recorded when paid.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

(a) Basis of Accounting

The Plan financial statements have been prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP), requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at that measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 3 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

(e) Allowance for Credit Losses

The Plan adopted FASB ASC 326 effective January 1, 2023. The impact of the adoption was not considered material to the financial statements and primarily resulted in enhanced disclosures only. All employee and employer contribution receivables at December 31, 2024 were collected in the following plan year. For notes receivable from participants, delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Therefore, no allowance for credit losses has been established.

(f) Excess Contribution Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants on March 8, 2024.

(g) Administration Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

(h) Date of Management's Review of Subsequent Events

In preparing the financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 18, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Variable annuities:* Values are calculated daily by the annuity provider according to the methods described in the annuity contracts.

**NOTE 4 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a fully benefit-responsive investment contract (Guaranteed Income Fund) with Empower Annuity Insurance Company (Empower). Empower maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. For fair value measurement purposes, this is considered a level 2 input. The crediting rate is based on a formula established by the contract issuer but may not be less than 2.05% from January 1, 2024 to June 30, 2024 and 2.10% from July 1, 2024 to December 31, 2024. The crediting rate is reviewed on a semi-annual basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Prudential, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the Issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$5,823,405 and \$5,155,266, respectively.

**NOTE 5 - TAX STATUS**

The volume submitter plan sponsor has received an opinion letter dated September 16, 2022 from the Internal Revenue Service stating that the form of the Plan is acceptable under Section 401 of the Internal Revenue Code ("IRC") for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and California Franchise Tax Board. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

**NOTE 7 - RISK AND UNCERTAINTIES**

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 8 - RELATED PARTY TRANSACTIONS**

Plan investments are managed by Empower for 2024 and for 2023. Empower is the trustee and recordkeeper of the Plan and, therefore, these transactions qualify as a party in interest transactions. Empower receives revenue from mutual fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan. If the revenue received by Empower from such mutual fund service providers exceeds the amount owed, such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. Fees paid by the plan for the investment management service amounted to \$27,356 for the year ended December 31, 2024.

Harrison Accounting Group, Inc., the Plan auditor, performed attest (financial statement review) and non-attest services (financial statement preparation, tax return preparation, and consulting) for the Company for the 2024 plan year; Paycom and Paycor perform payroll services for the Company; and Qualified Plan Advisors acts as investment advisor for the Company.

The Company provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged. These transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 9 - CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Prudential (the trustee of the Plan). Prudential certified the values of investments and notes receivable from participants as follows:

**NOTE 10 - CONCENTRATION OF CREDIT RISK**

The Plan investments consist of mutual funds and a group insurance annuity contract maintained by Prudential. The balances of those investments may have exceeded FDIC and SPIC insured limits during the year.

**NOTE 11 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
