### Note 1 - Description of Plan

The following brief description of ACP CreativIT, LLC (Company) 401(k) Plan (Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

#### General

The Plan is a voluntary, defined contribution plan covering substantially all full-time employees of the Company. Employees are eligible to contribute to the Plan after working one hour during the first month of employment and reaching the age of 19. For the employer match and profit sharing contributions, employees are eligible after working 1,000 hours in a 12 month period after their date of hire, and must be employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### Contributions

Each year, participants may contribute between 1% and the maximum allowed of pretax annual compensation, as defined by the Plan. Participants may also elect to make Roth 401(k) contributions. Contributions are subject to certain IRS limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an automatic deferral feature, and accordingly, the plan sponsor will automatically withhold 3.5% of eligible participants' compensation and contribute that amount to the Plan as a pre-tax 401(k) deferral unless the participant elects not to defer or enters into a salary reduction agreement with an alternative percentage of withholding.

The Company makes a matching contribution to eligible participants. The match is 100% of the first 3.5% of eligible compensation that a participant contributes to the Plan and is limited to \$6,000. The matching Company contribution is invested directly into the same investment options as directed by the participants. The Company's matching contributions were \$947,531 and \$905,032 for the years ended December 31, 2024 and 2023, respectively.

#### Participant Accounts and Rollovers

Each participant's account is credited with the participant's contributions and an allocation of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and individual accounts are also charged directly for loan processing fees. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

#### Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants are 100% vested in the Company's contributions and related earnings after three years of credited service.

### Note 1 - Description of Plan (Continued)

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years, except in the case of a home loan in which the maximum repayment period is fifteen years. The loans are secured by the vested balance in the participant's account and bear interest at a rate of prime plus 2%. Principal and interest are paid ratably through bi-weekly payroll deductions.

#### Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant (or beneficiary) may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period not to exceed the life or life expectancy of the participant or beneficiary, if applicable. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participant balances that are less than \$5,000 are paid via a lump-sum distribution regardless of whether or not an election has been made. The Plan allows for hardship distributions if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

#### Forfeited Accounts

Plan forfeitures arise as a result of participants who terminate service from the Company before becoming 100% vested in the Company's contributions and related earnings. The forfeited non-vested account balance at December 31, 2024 and 2023 was \$980 and \$3,533, respectively. Fees were reduced by \$11,164 and \$13,728 from forfeited accounts for the years then ended December 31, 2024 and 2023, respectively.

#### Administration

The Company is the sponsor and administrator of the Plan and has appointed Associated Trust Company, N.A. as recordkeeper and trustee. The trustee is responsible for investing and safekeeping all of the assets of the Plan.

### Note 2 - Summary of Significant Accounting Policies

This summary of significant accounting policies of ACP CreativIT, LLC 401(k) Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to generally accepted accounting principles.

#### Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Administrative expenses may be paid either by the Plan or by the Company. Expenses paid by the Company are excluded from these financial statements. Certain expenses of maintaining the Plan are allocated and charged to participants based on participant account balances, as defined, and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

### Note 3 - Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value. That framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Common Collective Trust Funds:* Valued at the NAV of units of a common collective trust. The NAV, as provided by the trustee, is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV readily determinable fair value was used, since it was determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of other methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 4 - Related Party and Party-in-Interest Transactions**

Certain Plan investments are managed by Associated Trust Company, N.A. who is the trustee and recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management and recordkeeping services to Associated Trust Company, N.A. amounted to \$112,835 and \$103,270 for the years ended December 31, 2024 and 2023, respectively. KerberRose SC is the Plan auditor and therefore, transactions with KerberRose SC qualify as related party transactions. Fees paid from plan assets in 2024 and 2023 for audit services were \$10,000 and \$9,500, respectively. Certain employees and officers of the Company, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan. Additional investment fees paid to the trustee are included in net appreciation in the fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

Associated Trust Company, N.A. provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Associated Trust Company, N.A. Associated Trust Company, N.A. receives revenue from fund service providers for services Associated Trust Company, N.A. provides to the funds. This revenue is used to offset certain amounts owed to Associated Trust Company, N.A. for its administrative services to the Plan.

If the revenue received by Associated Trust Company, N.A. from such fund service providers exceeds the amount owed under the MSA, Associated Trust Company, N.A. remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, there were no excess amounts. The Plan or Company may make a payment to Associated Trust Company, N.A. for administrative expenses not covered by revenue sharing.

### **Note 5 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to the participants' accounts will become fully vested and will be distributed to the participants in accordance with the Plan's provisions.

### **Note 6 - Information Certified by The Plan's Trustee**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule of assets, including investments held, cash and cash equivalents and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Associated Trust Company, N.A. (the trustee of the Plan).

### Note 7 - Reconciliation of Financial Statements to Form 5500

The Plan has a cash value of life insurance that is an allocated contract for one participant in the Plan. The benefits of this contract are fully guaranteed by the insurance company and under generally accepted accounting principles, allocated contracts are excluded from the Plan's financial statements.

### Note 8 - Income Taxes

The Company adopted a volume submitter profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020. As such, the Plan qualifies under Section 401(a) of the Internal Revenue Service Code and, therefore, is not subject to tax under present income tax laws. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and to recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 9 - Risks and Uncertainties

The Plan invests in various investment securities through mutual funds and common collective trust funds. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
