1. Description of the Plan

The following description of the Dynamic Map Platform North America, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the Plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Dynamic Map Platform North America, Inc. (the Company) excluding those employees who are residents of Puerto Rico, covered by a collective bargaining agreement, independent contractors, a nonresident alien, or a statutory employee. Employees of the Company generally become eligible to join the Plan on the first day of the month following completion of three months of employment and attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective April 7, 2023, the Plan was amended to change the name of the Plan to Dynamic Map Platform North America, Inc. 401(k) Plan, to be consistent with a name change by the plan sponsor. Prior to this change, the Plan was known as the Ushr Inc. 401(k) Plan.

Contributions

Eligible employees may make pre-tax and/or Roth contributions of up to 100% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus additional catch-up contributions of up to \$7,500 for those participants who have reached at least 50 years of age by the end of the Plan year. Participants eligible and electing the catch-up contribution are limited to the lesser of \$7,500 or 100% of their eligible compensation for their additional catch-up. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company makes safe harbor matching contributions up to 100% of the first 4% of eligible compensation contributed by participants. In August 2024, the Plan was amended to change the contribution period for purposes of calculating the amount of safe harbor matching contributions from each payroll period to each Plan year, requiring a true-up safe harbor matching contribution to be performed at the end of each Plan year. In 2024, safe harbor matching contributions totaled \$620,369, including \$82,765 in true-up safe harbor matching contributions for the 2024 Plan year made subsequent to year-end. The Company may also make discretionary matching contributions to the Plan or discretionary non-elective contributions. Contributions may be subject to certain limitations. There were no discretionary matching contributions or discretionary non-elective contributions made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, any Company contributions, and earnings or losses on the investments in their account, and is charged with transaction fees for services received by the participant and certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested at all times in their contributions (including rollovers) and safe harbor matching contributions. For Company discretionary matching and discretionary non-elective contributions, vesting occurs on a three-year cliff, with 100% vesting following completion of three years of service.

Payment of Benefits

At the time of death, disability, termination of service or retirement, the participant or their beneficiary may elect to receive their benefits as a lump-sum amount equal to the value of his or her vested account. If a participant terminates employment and has a vested account balance totaling less than \$7,000, the participant will automatically receive a lump-sum distribution equal to the value of their account. Participants are eligible to receive hardship withdrawals when certain conditions are met.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$280 and \$6, respectively. Forfeited non-vested accounts are used first to pay administrative expenses and then to reduce future employer contributions. In 2024, \$21 of forfeitures were used to pay expenses and \$0 were used to reduce future employer contributions.

Administrative Expenses

The Plan document permits certain administrative expenses to be paid by the Plan. Those expenses paid by the Plan are allocated pro rata based on the participant's account balance. These expenses related to recordkeeping services that are paid to a service provider of the Plan qualify for party-in-interest transactions. Certain transaction fees for withdrawals are charged directly to the participant. The Plan has an ERISA account where the custodian deposits revenue sharing payments that may be used to pay certain Plan administrative expenses or allocated to participant accounts. During 2024, \$1,331 was deposited to this account and none was used to

pay administrative expenses or allocated to participant accounts. Deposits to this account are included in net change in fair value of investments in the accompanying statement of changes in net assets available for benefits. Payments from this account are included in expenses during the year they are paid. The account had an available balance of \$2,400 and \$1,069 as of December 31, 2024 and 2023, respectively, which is included in the money market fund on the statements of net assets available for benefits.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates, and such differences may be material to the financial statements.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company safe harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. Discretionary matching and non-elective contributions are considered payable to the Plan after approval by the Plan's Administrative Committee. Any unfunded participant or employer contributions are included in the employee or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

In accordance with Financial Accounting Standards Board Accounting Standards Codification 326, *Financial Instruments—Credit Losses*, the Plan estimated the current credit risk associated with the employer contributions receivable. After giving consideration to the risk characteristics, including historical payment experience, the Plan determined that no allowance for credit losses was necessary and there was no current year activity in the allowance for credit losses.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes realized and unrealized gains and losses on those investments and interest and dividend income.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through August 26, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and the net change in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the Plan's qualified institution.

4. Investments

Certain Plan investments are shares of mutual funds and a money market fund managed by Fidelity. Fidelity is the Plan's qualified institution, and therefore, transactions in these securities qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, among others. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest

priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in the money market fund and mutual funds are valued at quoted market prices for the identical security in an active market (Level 1).

5. Plan Termination

Although it has not expressed any intent to do so, the Company has a right under the Plan document to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Company discretionary matching and non-elective contributions.

6. Income Tax Status

In May 2021, the Plan that was based on a Volume Submitter Profit Sharing Plan with CODA (volume submitter plan) sponsored by Fidelity Management & Research Co. (FMRC) moved to a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (pre-approved plan) sponsored by FMR LLC (doing business as Fidelity Institutional Asset Management). The Internal Revenue Service has opined and informed FMR LLC by letter dated June 30, 2020, that the pre-approved plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt and has no income subject to unrelated business income tax. The Plan's returns for the past three years are subject to examination by taxing authorities and may change upon examination.
