### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Mothers Against Drunk Driving Tax Deferred Annuity Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

**Note 1. Description of the Plan**

***General***

The following description of the Mothers Against Drunk Driving Tax Deferred Annuity Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Mothers Against Drunk Driving (Organization) for the benefit of its employees. The Plan covers substantially all employees of the Organization, except for leased employees and contracted employees. After satisfying all of the eligibility requirements, employees become participants of the Plan on the first day of the month coinciding with or immediately following the date all requirements have been met. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

The Plan is administered by the Retirement Committee for Mothers Against Drunk Driving (Committee or Plan Administrator) appointed by the board of directors of the Organization. The Committee has the primary responsibility of administering the Plan for the exclusive benefit of the participants and their beneficiaries, subject to the specific terms of the Plan. The Committee appointed VOYA Retirement Insurance and Annuity Company (VOYA) as custodian and record-keeper. The custodian is responsible for the custody and management of the Plan's assets.

***Contributions***

Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan, not to exceed the limits of IRC §401, §402, and §415. At the participant's election, these may be either "traditional" before-tax or "Roth" after-tax 403(b) contributions, depending on whether they are deducted before or after federal income taxes are withheld. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted.

The Plan provides for a discretionary matching contribution for each payroll period. The Organization's board of directors approved a dollar for dollar match limited to 3% of an employee's compensation up until April 1, 2024. Thereafter, the Organization's board of directors approved a dollar for dollar match limited to 1.5% of an employee's compensation. Until November 1, 2024, participants making 403(b) contributions, who are at least 18 years of age, have completed one year of service, and have worked at least 1,000 hours were eligible to receive employer contributions. Effective November 1, 2024, the Plan removed the year of service eligibility requirement, thus, participants became eligible for employer contributions upon their Entry Date. The Entry Date for a participant to receive matching contributions is the first day of each month. Participants may receive the discretionary matching contribution for a particular payroll period if they are eligible to participate in the Plan at any time during that payroll period. Contributions are subject to certain limitations.

See Note 10 for changes made to eligibility during 2024.

***Participant Investment Account Options***

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan to any one or more of the investment alternatives maintained by the custodian, determined at the discretion of the participant and in such multiples as the participant prescribes. A participant may change their investment direction with respect to future contributions or redirect the investment of their account balances.

Effective May 1, 2023, the plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 10%.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Organization's contributions, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions and rollover contributions, if any, plus actual earnings thereon. The discretionary employer matching contribution has a 100% vesting period after two years of service. As a result, upon completion of the employee's second year of employment, the employee will be 100% vested in the discretionary employer matching contributions made on the participant's behalf to the Plan. Full and immediate vesting will also occur upon normal retirement age (age 65), early retirement (age 55), death, or total disability, as defined by the Plan. Participants who leave the Organization before they are vested in the Organization's contributions forfeit their nonvested portion.

***Notes Receivable From Participants***

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000, reduced by the highest outstanding loan in the previous 12 months, or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

***Payment of Benefits***

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may elect to receive a distribution of their vested account as a lump-sum, annuity, or substantially equal installments; leave the amount in the Plan and receive payment at a later date; or choose a direct rollover to another qualified plan or an individual retirement account. In addition, in-service and hardship distributions are permitted if certain criteria are met. If the vested account balance is less than \$5,000, the participant may be subject to an involuntary lump sum cash-out.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,775 and \$51,486, respectively. These accounts will be used to reduce the Organization's future employer contributions or to pay plan administrative expenses. For the years ended December 31, 2024 and 2023, plan administrative expenses of \$0 and \$5,000, respectively, were paid from forfeited nonvested accounts. For the years ended December 31, 2024 and 2023, forfeitures were used to reduce employer contributions by \$71,295 and \$0, respectively.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for

benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year as well as held at year-end.

***Contributions***

Contributions from plan participants and the matching contributions from the Organization are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Organization or the Plan, at the Organization's discretion.

**Note 3. Certification of Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, VOYA, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets or liabilities

measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan held no Level 2 or Level 3 securities at December 31, 2024 and 2023.

**Note 5. Investment Contract With Insurance Company**

The Plan has entered into a fully benefit-responsive investment contract with VOYA. VOYA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by VOYA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Organization or other Organization events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 6. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are managed by VOYA. VOYA is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid approximately \$31,000 and \$30,000 of record-keeping fees to VOYA during the years ended December 31, 2024 and 2023, respectively. The Organization provides certain administrative services at no cost to the Plan.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. The Plan provides for full and immediate vesting of all participant rights upon termination of the Plan.

**Note 8. Tax Status**

The Plan, together with the investment vehicles, is intended to be a tax-sheltered annuity plan under Section 403(b) of the Internal Revenue Code of 1986, as amended. The Plan has not requested or obtained a determination letter, as the Internal Revenue Service does not currently provide that service for 403(b) plans. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Note 10. Plan Amendment**

Effective November 1, 2024, the Plan was amended and restated to revise the Year of Service Eligibility requirement. The revision removes the requirement of participants to complete one year of service to be eligible for matching contributions and removes the requirement for 1,000 hours of service during the relevant Eligibility Computation Period. Effective May 1, 2023, the Plan was amended and restated to change the age of eligibility from 21 to 18 and for participants to become eligible immediately upon enrollment. The amendment also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 10%. Additionally, the amendment modified the vesting schedule for participants to be 100% vested after two years of service.

**Note 11. Subsequent Events**

Subsequent events have been evaluated through October 6, 2025, which is the date the financial statements were available to be issued.
