Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rescue Agency Public Benefit, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [an ERISA 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Rescue Agency Public Benefit, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1. DESCRIPTION OF THE PLAN

The Rescue Agency Public Benefit, LLC 401(k) Plan (the "Plan"), was established effective January 1, 2014, as a defined contribution plan pursuant to Section 401(a) and related provisions of the Internal Revenue Code ("IRC"). The Plan is sponsored by Rescue Agency Public Benefit, LLC and is designed to provide employees of Rescue Agency Public Benefit, LLC and related participating employers (together, the "Company") with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, or termination. The Plan covers all employees of the Company who meet certain eligibility requirements. The Plan is subject to the provisions of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), and the requirements of the IRC.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Eligibility

All employees of the Company are eligible to participate in the Plan once they have reached age 21, except employees whose employment is governed by a collective bargaining agreement in which retirement benefits are subject to good faith bargaining, leased employees, independent contractors, temporary employees with less than one year of service, and non-resident aliens.

Contributions

Participants may elect to contribute through payroll deductions an amount up to 100% of their eligible annual compensation, as defined in the Plan. The Plan permits both pre-tax and Roth contributions. Participants over the age of 50 may also elect to make additional catch-up contributions, as defined.

Participants may also contribute amounts representing distributions from other qualified sources.

The Company may make discretionary matching contributions to all eligible participants. For 2024, the Company matched 100% of the participant contributions up to 3% of eligible compensation, calculated on a per payroll period basis. The Company may also make discretionary non-elective employer contributions. The Company did not make a discretionary non-elective contribution in 2024.

All contributions are subject to certain limitations as defined in the IRC.

Participant Accounts

Each participant's account reflects the participant's contributions, the Company's contributions (if any), allocations of Plan earnings or losses, and an allocation of expenses. Allocations are based on participant earnings or account balances, as defined.

Administrative charges related to participant loans and distributions are deducted directly from the transacting participant's account. Investment expenses are paid directly from the underlying assets of the respective investment and are included in the net realized and unrealized appreciation or depreciation in fair value of investments in the statement of changes in net assets available for benefits. Certain expenses related to the administration of the Plan are paid by the Company.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Participant Accounts (Continued)

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions to any of the Plan's investment options. Subsequently, participants may change their allocations and transfer account balances between investment options in accordance with Plan provisions.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. In the event of termination of employment due to death, total and permanent disability, or attaining normal retirement age, participants shall become 100% vested in Company contributions. For all other participants, vesting in the Company contribution portion of their accounts is based on credited years of service, as defined in the Plan, according to the following schedule:

2	25%
3	50%
4	75%
5 or more	100%

Notes Receivable from Participants (Participant Loans)

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum generally equal to the lesser of \$50,000 or 50% of their vested account balance. The repayment of principal plus interest is generally required by the Plan to be made through semi-monthly payroll deductions within five years unless the loan was obtained in connection with the purchase of a principal residence, in which case, the repayment term may be longer. The loans are secured by the balance in the participant's account and bear interest at a fixed rate equal to 1% above the prime rate. As of December 31, 2024, the interest rates on all outstanding loans were 4.25% to 9.50%.

In April 2020, the Plan operationally implemented certain provisions of the Coronavirus Aid, Relief, and Economic Security Act (the "CARES Act"). Participants requesting relief under the CARES Act were permitted an increased loan limit to the lesser of \$100,000 or 100% of the nonforfeitable account balance (available until September 23, 2020).

Payment of Benefits

Participants, or their beneficiaries when applicable, are entitled to a distribution of their vested benefits in the event of death, disability, retirement, termination of employment, or termination of the Plan.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits (Continued)

If a participant's vested account balance is equal to or less than \$1,000, the balance is distributed, after a 30-day waiting period has expired, in a lump-sum cash payment unless a direct rollover into another qualified benefit plan is requested. If a participant's vested account balance is less than \$7,000 but greater than \$1,000, the Plan administrator may roll the balance into an individual retirement account selected by the Plan administrator provided that the participant has not elected to receive a cash distribution or have the balance rolled into an individual retirement account of the participant's choosing. If a participant's vested account balance is greater than \$7,000, the participant may elect to receive benefit payments in a single lump sum or direct rollover, or postpone payment to a later date and remain in the Plan as described in the Plan document.

In certain other situations, participants may withdraw their vested funds while still employed with the Company. Participants may withdraw all or part of their vested account balances once they reach age 59½. At any time and at any age, participants may withdraw any amounts representing rollover contributions into the Plan.

Pursuant to the Setting Every Community Up for Retirement Enhancement Act of 2019 (the "SECURE" Act), which became law on December 20, 2019, participants may defer taking distributions as follows:

- If a participant reached the age of 70½ in 2019, the participant may defer receiving distributions until the later of April 1, 2020, or the April following the calendar year in which the participant retires;
- If a participant reaches the age of 70½ in 2020 or later, the participant may defer receiving distributions until the later of the April following the calendar year in which the participant reaches age 72 or retires.

The distribution provisions of the SECURE Act were modified by the SECURE 2.0 Act of 2022 (Note 12), such that beginning in 2023, the age a participant must begin taking distributions was raised to 73. If a participant reached the age of 72 during 2023, the participant may defer receiving distributions until April 1, 2025, the latest date that a required minimum distribution may be taken for 2024.

As permitted by the CARES Act, the Plan operationally implemented the following provisions for CARES Act related distributions: (i) participants may withdraw up to \$100,000 without a 10% early distribution penalty during 2020, (ii) such distributions can be repaid within three years of the date of distribution, and (iii) required minimum distributions were temporarily suspended for 2020.

Forfeited Accounts

The nonvested balance of a separated participant's account is forfeited when a distribution of vested benefits is made. For separated participants who do not receive a distribution of vested benefits, the nonvested balance is forfeited after five consecutive one-year breaks in service. Forfeitures may be used to first reduce Plan administrative expenses and second to reduce future employer contributions. As of December 31, 2024 and 2023, there was a balance of \$23,621 and \$37,210, respectively, in the forfeiture account. During the year ended December 31, 2024, \$33,848 was forfeited and the forfeitures account earned \$608 in investment gains. Also during 2024, \$31,870 of forfeitures were used to reduce employer contributions and \$16,175 of forfeitures were used to pay Plan administrative expenses.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants (Participant Loans)

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses

Certain of the Plan's administrative expenses, such as trustee, accounting, and legal expenses, are paid by the Company; other administrative expenses are paid by the Plan, including certain distribution and loan fees, which are paid by the transacting participants.

Investment Valuation and Recognition of Income and Loss

Investments are reported at fair value, except for the investment in the insurance company unallocated contract. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends, which are included in net realized and unrealized appreciation or depreciation in the fair value of pooled separate accounts, are recorded on the ex-dividend date. Net realized and unrealized appreciation or depreciation in the fair value of pooled separate accounts includes the Plan's gains and losses on such investments sold during the year as well as held at year end.

The insurance company unallocated contract is a fully benefit-responsive investment contract which is reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5 for further discussion of the insurance company unallocated contract.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through the date of the independent auditors' report, which is the date these financial statements were available to be issued.

NOTE 3. INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule (Schedule H, Part IV, Line 4i), including investments held at December 31, 2024 and 2023, and net appreciation or depreciation in fair value of pooled separate accounts and interest income from insurance company unallocated contract for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company, the trustee of the Plan.

NOTE 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement for the asset or liability at the measurement date. These inputs reflect Plan management's best estimate of what market participants would use in pricing the asset or liability at the measurement date. Consideration is given to the risk inherent in the valuation technique and in the inputs to the model.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for investments measured at fair value at December 31, 2024 and 2023:

Pooled separate accounts: Valued at the accumulation unit value ("AUV"). The AUV is determined based on the net asset value of shares of the underlying fund, the fund's dividends, and the contract's separate account charges. The AUV is determined daily as reported by Voya.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. INSURANCE COMPANY UNALLOCATED CONTRACT

The Plan invests in the Voya Fixed Account (the "Contract"), a fully benefit-responsive group annuity investment contract issued by Voya. Investment contracts held by defined contribution plans are required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits for a defined contribution plan attributable to such contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Contributions to Voya under this contract are maintained in a general account that is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value. There are no reserves against contract value for credit risk.

The Contract is not a portfolio of contracts whose yields are based on changes in the fair value of underlying assets, but is rather a single group annuity contract with a fixed rate of interest. As a result, the average yield earned by the Plan is the yield earned, or the interest credited, on the group annuity contract.

NOTE 5. INSURANCE COMPANY UNALLOCATED CONTRACT (Continued)

The interest crediting rates are determined on a monthly basis and are calculated based upon many factors, including current economic and market conditions, the general interest rate environment, and purchases and redemptions by unit holders. The guaranteed minimum rate under the contract is 1%. An employer-level surrender of the Plan's interest in the Contract for reasons other than the payment of benefits to participants may be subject to a market value adjustment and a surrender charge.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan sponsor does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

There are no unfunded commitments. The Contract defines the circumstances and amounts for which the contracts may be terminated by the Plan. The Plan must provide Voya a minimum of 90 days notice prior to the redemption of the Contract.

NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the accompanying financial statements.

NOTE 7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain of the Plan's operating expenses are paid by the Company. The Company also provides administrative services for the Plan at no cost to the Plan. Certain investments are managed by the trustee of the Plan. In addition, the Plan allows participants to take loans against their account balances. These transactions qualify as exempt party-in-interest transactions.

NOTE 8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 9. TAX STATUS

The Company has adopted a pre-approved defined contribution plan and relies upon the pre-approved plan's opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that, in its opinion, the form of the plan is acceptable under and is designed in accordance with applicable sections of the IRC. The Company has not applied for a determination letter from the IRS specific to the Plan. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the accompanying financial statements.

U.S. GAAP requires Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 10. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain investments are classified differently on the Form 5500 from how they are disclosed in the financial statements. For financial statement purposes, investments at fair value are disclosed as consisting of pooled separate accounts (Note 4). Although the investments meet the definition of pooled separate accounts, because the trustee doesn't separately report its pooled separate account assets to the DOL, these investments are categorized according to their underlying investments (registered investment companies) rather than as pooled separate accounts on the Schedule H of the Form 5500.

NOTE 11. CARES ACT

In response to the effects of the coronavirus on the economy, in March 2020, Congress passed the CARES Act. The CARES Act provides temporary relief for retirement plan sponsors and participants with respect to employer contributions, distributions, and participant loans. The provisions of the CARES Act may be implemented operationally prior to formally amending the Plan document. The Plan has implemented certain relief provisions included in the CARES Act as disclosed in the preceding notes to the financial statements. Plan management expects to formally amend the Plan by December 31, 2026.

NOTE 12. SECURE 2.0 ACT

On December 29, 2022, the SECURE 2.0 Act of 2022 (the "SECURE Act 2.0") became law. The purpose of the legislation is to expand access to retirement plans and to help working Americans increase their retirement savings. In addition to the changes to distributions described in Note 1, the SECURE Act 2.0 includes various required and optional provisions that will become effective between 2023 and 2033, certain of which are described below.

- Beginning in 2033, the age for required minimum distributions will increase from age 73 to 75.
- Beginning January 1, 2025, a participant from the ages 60 to 63 can elect catch-up contributions up to the limit of the greater of \$10,000 or 150% of the catch-up contribution limit imposed by the IRS.
- Beginning January 1, 2025, long-term part-time workers (defined as employees who have worked for two consecutive 12 month periods during each of which they have at least 500 hours of service) will become eligible to enroll in their employer's retirement plan after two years.
- Beginning January 1, 2027, catch-up contributions will be made on a Roth basis, unless the participant earns \$145,000 or less.

Additionally, Plan management has not yet determined which of the optional provisions, if any, the Plan will implement. Plan management expects to formally amend the Plan by December 31, 2026.
