Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Archways to Retirement 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in the "Information Certified by the Custodian" note to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Notes to Financial Statements

December 31, 2024

1) Description of the Plan

The following description of Archways to Retirement 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was originally adopted January 1, 2016, as the Archways to Retirement 401(k) Plan. The Plan is a defined contribution plan covering all employees of the group of employers (collectively the “Company”) who satisfy the eligibility requirements. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Board of Trustees is responsible for oversight of the Plan.

Eligibility

Employees who have completed twelve consecutive months of employment containing at least 1,000 hours of service and are age 21 or older are eligible to participate in the Plan. Employees may enter the Plan on the first day of the first month or seventh month that coincides with or follows the date on which they satisfy the eligibility requirements. Long-term part-time employees that have three consecutive years of employment and 500 hours are eligible to participate in the Plan.

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company may make a safe harbor matching contribution of 100 percent of the first three percent and 50 percent of the next two percent of the pretax annual compensation that a participant elects to contribute. Amounts deferred as catch-up contributions are also considered for matching contribution purposes. For the years ended December 31, 2024 and 2023, safe harbor matching contributions totaled \$492,550 and \$388,841.

The Company may make non-elective contributions which are made solely at the discretion of the Board of Directors. No discretionary non-elective contributions were made in 2024 and 2023.

Contributions are limited to the maximum amount which will not cause the Plan to violate the provisions of the Plan or cause the Plan to exceed the maximum amount allowable as a deduction to the Company under Internal Revenue Code (the “Code”) Section 404.

It is the policy of the Company to fund contributions to the Plan on a regular basis as soon as employee deferrals are made, and employer contributions are elected.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions and their allocable share of Company matching contributions into a variety of investment choices as more fully described in the Plan's literature.

Participants may change their allocation daily. All investments are participant directed.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company matching contributions and plan earnings, less an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and any Company safe-harbor matching contributions, plus actual earnings thereon. Vesting in any Company non-safe harbor nonelective contribution portion of their accounts is based on continuous years-of-service during which the participant is credited with at least 1,000 hours of service at a rate of 20 percent each year after the first year, becoming 100 percent vested after six years of service credited. Additionally, a participant will be fully vested upon reaching age 65 prior to termination of employment, or upon death or disability prior to that date.

Payment of Benefits

On termination of service or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. A participant who is still an employee and has reached age 59 ½ may request an in-service distribution of all, or a portion, of the participant's vested interest in his or her account in the form of a lump sum amount. Terminated participants with account balances less than \$5,000 are subject to mandatory "cash-out" provisions.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The majority of the Plan's investments are reported at fair value or contract value, as applicable. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount that would be received by the participant for permitted transactions. The Plan's Pension Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See additional information in the "Fair Value Measurements" note to the financial statements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Expenses

Substantially all administrative and investment related expenses are paid from plan assets. Investment related expenses are deducted from net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued.

3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

- Level 2 Inputs to the valuation methodology include
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the asset or liability;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: These accounts hold assets allocated to each separate account. The value of each separate account is determined at the close of each business day based on fair value. These accounts are separate accounts (not part of Empower Retirement’s (Empower) general account); income, gains and losses, whether realized or not, from assets of a separate account are credited to or charged against the separate account without regard to income, gains or losses of Empower or any other separate account.

4) Group Annuity Contract

The Plan has a group annuity contract with Empower Annuity Insurance Company of America. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than 0 percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- (a) Amendments to the Plan document (including complete or partial Plan termination or merger with another plan),
- (b) Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
- (c) Bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or
- (d) The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

5) Information Certified by the Custodian (Unaudited)

Empower Annuity Insurance Company of America, the custodian, holds all investments and executes all investment transactions on behalf of the Plan. Information regarding the value of all cash, investments, interest and dividend income and net appreciation/depreciation in the fair value of investments has been certified by the custodian as complete and accurate in accordance with Section 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

6) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of pooled separate accounts and fixed annuity managed by Empower. The life insurance company is the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Other parties-in-interest include the Company, Pension Committee, participants, and anyone performing services for the Plan. Plan expenses included custodial fees and other administrative expenses totaling \$121,472 and \$134,902 for the years ended December 31, 2024 and 2023, respectively.

7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of total or partial plan termination, affected participants will become 100 percent vested in their accounts.

8) Tax Status

The company has adopted a volume submitter plan document and is relying on the volume submitter sponsor's opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The letter states that the form of the plan is designed in accordance with applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Company has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require

recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Company believes it is no longer subject to income tax examinations for years prior to 2022.

9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
