### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

## **Basis for Opinion**

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedule of assets held for investment and schedule of delinquent participant contributions are presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

### **1. DESCRIPTION OF PLAN**

The following description of TherapyNotes (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a participant-directed defined contribution plan covering all employees of the company who are age 21 or older and completed 2 months of service (1 year of service to be eligible for employer contributions). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Contributions*

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan and subject to Internal Revenue Code restrictions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Certain participants are also eligible to make “catch-up” contributions in accordance with Internal Revenue Code regulations. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several different mutual funds as investment options to participants. The matching Company contribution is invested pursuant to the participant direction. Additional profit-sharing amounts may be contributed at the option of the Company’s Board of Directors. Contributions are subject to certain limitations.

#### *Participant Accounts*

Each participant's account is credited with the contributions and allocation of Plan earnings in accordance with their investment direction. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are immediately vested in their contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in the employer profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service.

#### *Payment of Benefits*

On termination of service due to death, disability, retirement or termination, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, benefits may be withdrawn from the Plan without terminating employment upon attaining age 59 1/2 or in the case of certain financial hardships.

#### *Forfeited Accounts*

Forfeited accounts are used to offset employer matching contributions in accordance with the Plan document. Forfeitures used by the employer to reduce employer contributions during the years ended December 31, 2024 and 2023 were \$15,000 and \$7,520, respectively. Forfeitures for the years ended December 31, 2024 and 2023 were \$16,149 and \$14,782, respectively. The forfeiture account balance as of December 31, 2024 and 2023 was \$16,915 and \$15,093, respectively.

### **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

#### *Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### *Subsequent Events*

Management has evaluated events and transactions occurring subsequent to December 31, 2024 for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through the date these financial statements were available for issue.

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Purchase and sales of securities are recorded on a trade-date basis. Interest income is required on the accrual basis. Dividends are recorded on the ex-dividend date.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Administrative Expenses*

All normal administrative costs and expenses of the Plan are currently being paid by the Company. Investment advisory, participant activity, contract charges and other investment related expenses are deducted from investment income on participant accounts. Distribution fees are charged to participants receiving benefits.

### **3. INFORMATION CERTIFIED BY THE CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Hand Benefits & Trust Company, the Trustee, has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate.

**4. FAIR VALUE MEASUREMENTS**

ASC 820, Fair Value Measurements, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identifiable assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used only when Level 1 inputs were not available. An asset's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The three levels of the fair value hierarchy are as follows:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical unrestricted assets.
- Level 2: Quoted prices in markets that are not active, or inputs that are observable either directly or indirectly, for substantially the full term of the asset.
- Level 3: Prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable (i.e. supported with little or no market activity).

The following is a description of the valuation methodologies used for instruments measured at fair value:

The mutual funds and money market funds with Hand Benefit & Trust company are stated at fair value as reported to the Plan by Hand Benefit & Trust Company, based on the quoted market prices of the mutual funds ("Level 1").

**5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate, amend, modify or suspend the Plan in whole or in part at any time subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balances.

**6. TAX STATUS**

The Internal Revenue Service has ruled that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**7. RELATED PARTY TRANSACTIONS**

TherapyNotes, Inc., the participants, and the trustee have all been identified as related party transactions. The Plan invests in shares of mutual funds managed by the trustee. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. The plan paid \$51,901 and \$33,500 to the custodial trustee for the years ended December 31, 2024 and 2023, respectively.

Fees paid during the year for legal, accounting and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services and paid directly by the plan sponsor.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**8. PLAN AMENDMENTS**

The plan was amended to comply with regulatory changes.
