The liability under the unit credit cost method is the value of the accrued pension benefit using service and pay as of the valuation date. The sum of the present value of the accrued benefits for all participants is the ERISA funding target. The normal cost is the present value of the benefits earned during the year. The target normal cost is the sum of the normal costs for all participants and the assumed administrative expenses.

There was a change both in the enrolled actuary for the plan and in the business organization providing actuarial services to the plan. The conditions for automatic approval, as outlined in Announcement 2015-3, were satisfied.


