Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of Plan

The following brief description of the Meetings & Incentives Worldwide, Inc. (Company) 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan covering all full-time employees of the Company who are twenty-one years-old or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Contributions

Participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Newly hired employees are automatically enrolled in the plan with a contribution rate of 4% if the employee does not opt out within 30 days of initial satisfaction of the eligibility requirements. Participants may also rollover balances into the Plan from other qualified accounts. The Company, at the discretion of the Company's Board of Directors, may make matching and/or non-elective contribution. Non-elective contributions are allocated on an integrated basis to eligible participants. Matching contributions are based on a discretionary percentage applied to participant contributions. Contributions are also subject to certain Internal Revenue Code (IRC) limitations.

c. Participant's Accounts

Each participant's account is credited with the participant's contribution, employer contribution (if any), and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are immediately fully vested in their own and qualified non-elective contributions plus actual earnings thereon. Vesting in the Company's matching contributions and earnings thereon is based on years of continuous service and a participant is 100% vested after two years of credited service, attainment of normal retirement age, death, or disability while an employee. Vesting in the Company's non-elective contributions and earnings thereon is based on years of continuous service at a rate of 20% per year beginning in year two and a participant is 100% vested after six years of credited service, attainment of normal retirement age, death, or disability while an employee.

e. Notes Receivable from Participants

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at an interest rate based on rates currently being charged on similar commercial loans by persons in the business of lending money, as determined by the Plan Administrator. Any loan must be repaid within a five-year period, except if the loan is made for the purpose of purchase or construction of the primary residence of the participant, then such loan may be repaid over a period not

exceeding fifteen years. Principal and interest are paid ratably through payroll deduction. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan documents.

f. Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3 and \$3,098, respectively. Forfeitures may be used to reduce the employer contributions for the year, restore forfeitures, or pay reasonable Plan expenses per the Plan document. During 2024, the Plan used forfeitures of \$10,681 to reduce employer contributions.

g. Investment Options

Upon enrollment in the Plan, a participant is required to complete an investment designation stating the percentage of contributions made on behalf of the participant to the available investment options. Participants may change their election with respect to future contributions and current invested balances through completion of a subsequent investment designation form.

h. Payment of Benefits

On termination of service due to death, disability, or retirement, a participant or participant's beneficiary may elect to receive either a lump-sum amount equal to 100% value in his or her account, or installment payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution as soon as administratively feasible.

For participants whose vested interest in his or her account does not exceed \$5,000, the vested account balance will be distributed directly to the participant as soon as administratively feasible. The participant will have the option to choose to receive the distributions directly or to roll over the distribution into an individual retirement account or the qualified plan of a new employer.

In-service withdrawals are allowed from a participant's account for the following purposes:

- From a participant's rollover contribution account—A participant may receive a distribution from his or her rollover contribution account at any time;
- To a participant's Roth account—A participant may roll over an account balance from a non-Roth account to a Roth account. The account must be fully vested to qualify;
- Upon certification of disability—A participant may receive distributions from his or her elective deferral contribution account and qualified non-elective contribution account if a severe disability has occurred;
- Once a participant has reached normal retirement age (59½);
- For active military service—A participant who is called to active duty may receive a distribution from his or her vested account balance; and

- For hardship purposes—A participant may receive a distribution from his or her account if the Plan Administrator finds that the participant has an immediate and heavy financial need.

i. Plan Expenses

Administrative costs are shared between all the Plan participants based on the ratio of the account balance to the total account balance of all participants. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

j. Changes to the Plan

No significant changes were made to the Plan during the year ended December 31, 2024.

Note 2. Summary of Significant Accounting Policies

a. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and present the net assets available for Plan benefits and changes in those assets.

b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Significant estimates used in preparing these financial statements include those assumed in the valuing of investments at fair value. An estimate regarding a possible loss on these investments cannot be made due to the fluctuating nature of market conditions. It is at least reasonably possible that the estimates will change within the next year depending on market conditions.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustee. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Payment of Benefits

Benefits are recorded when paid.

e. Subsequent Events

The Plan has evaluated subsequent events through September 16, 2025 the date the financial statements were available to be issued.

Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company, LLC (the trustee of the Plan).

Note 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statement of Net Assets Available for Benefits.

Note 5. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan's Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Note 5. Tax Status (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor and Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 6. Related-Party and Party-in-Interest Transactions

The Plan contracts with John Hancock Trust Company LLC for recordkeeping and custodial services and the fees paid of \$45,530 during the year ended December 31, 2024 qualify as a party-in-interest transaction. The Plan contracts with LPL Financial LLC for investment advisory services and the fees paid of \$64,794 during the year ended December 31, 2024 qualify as a party-in-interest transaction. The Plan contracts with PPG Retirement Plan Services for plan administrative services and the fees paid of \$9,398 during the year ended December 31, 2024 qualify as a party-in-interest transaction. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 7. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 7. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during the years ended December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust - The Plan's investment in the MetLife Stable Value Fund ("Stable Value Fund"), holds investment contracts that are deemed to be fully benefit responsive investment contracts ("FBRIC"), however, this is considered to be an indirect FBRIC investment, and it is reflected at NAV as a practical expedient which is considered fair value. The NAV is equal to contract value of the underlying investment and is equal to the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals or transfers. The Stable Value Fund is not available for sale or transfer on any securities exchange. The contract value is a relevant measurement attribute because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The existence of certain conditions can limit the Stable Value Fund's ability to transact at contract value. Specifically, any event outside the normal operation of the Stable Value Fund that causes a withdrawal from an investment contract may result in a negative market value adjustment with respect to such withdrawal. Examples of such events include, but are not limited to, partial or complete legal termination of the Stable Value Fund or a unitholder, tax disqualification of the Stable Value Fund or a unitholder, and certain Stable Value Fund amendments if issuers' consent is not obtained. As of December 31, 2024, the occurrence of an event outside the normal operation of the Stable Value Fund that would cause a withdrawal from an investment contract is not considered to be probable. To the extent a unitholder suffers a tax disqualification or legal termination event, under normal circumstances it is anticipated that liquid assets would be available to satisfy the redemption of such unitholder's interest in the Stable Value Fund without the need to access investment contracts.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their accounts.

Note 9. Bonding

ERISA Section 412 (a)(2)(D) requires the Plan to be bonded in the amount of 10% of Plan assets, up to \$500,000. Bond coverage as of December 31, 2024 and 2023 was \$500,000 and \$500,000, respectively, and does meet the minimum requirements set by ERISA in 2024 and 2023.
