Independent Auditor's Report

To the Administrative Committee
The Salary Investment Plan of Mutual of Enumclaw Insurance Company:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Salary Investment Plan of Mutual of Enumclaw Insurance Company (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. 1. DESCRIPTION OF PLAN

The following description of The Salary Investment Plan of Mutual of Enumclaw Insurance Company (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan established on August 1, 1987 by Mutual of Enumclaw Insurance Company (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is also the plan sponsor and plan administrator.

b. Eligibility

All employees who are at least 18 years of age are eligible to participate in the Plan immediately upon hire unless they are excluded from participation in accordance with the plan agreement.

c. Contributions

Eligible participants are able to contribute up to 85% of their compensation, as defined in the Plan Document.

The Plan has adopted an automatic deferral, initially 6% of compensation, with annual automatic increases of 1% per year up to 12% of compensation, with an opt-out opportunity. Employees may choose between Pre-tax and Roth contributions in their elective deferrals. Participants are allowed to make modifications to their contributions biweekly.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company matches, dollar for dollar, the first 3% of eligible compensation contributed and 50 cents on the dollar for the next 4% of eligible compensation contributed. Additional employer matching contributions and employer profit sharing contributions may be made on a discretionary basis. No such discretionary contributions have been made for the year ended December 31, 2024.

Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. Participants are allowed to make modifications to their investment options daily.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

1. DESCRIPTION OF PLAN, (Continued)

c. Contributions, (Continued)

The Company also has a Defined Benefit Plan. That plan was frozen effective April 1, 2006. Participants whose sum of their age plus vested years of service with the Company was 60 or higher (rule of 60) were eligible to continue accruing a benefit in the Defined Benefit Plan. Those participants who did not meet the rule of 60, or actively elected to “freeze” their benefit became eligible to participate in the Company matching contributions to the Plan. Those participants of the Plan who continue to accrue a benefit in the Defined Benefit Plan may make contributions to the Plan but are not eligible to participate in the Company matching contributions to the Plan.

d. Participant accounts

Each participant’s account is credited with the participant’s salary deferral contribution and any Company matching contribution and allocation of (a) any Company profit sharing contribution, and (b) Plan earnings or losses. The allocation of the Plan’s earnings or losses is based on each participant’s share/unit values. Allocations of discretionary employer matching contributions are based on participant contributions for the Plan year. Allocations of discretionary employer profit sharing contributions are based on participant compensation for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

e. Vesting

The participants are fully vested at all times in their 401(k) salary deferral contributions and any discretionary employer matching or profit sharing contributions.

f. Notes receivable from participants (participant loans)

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms can be for up to 5 years. The loans are secured by the balance in the participant’s account and bear interest at prime plus 1% or a reasonable market rate as determined by the plan administrator. At December 31, 2024, the interest rate on all outstanding loans range between 4.25%-9.50%. Principal and interest are paid through payroll deductions; however, the participant may repay the loan at any time.

g. Payment of benefits

Upon termination of service, a participant (or beneficiary) may elect to direct the trustees to distribute to the participant or beneficiary the value of the participant’s vested interest in his or her account, either in a lump-sum amount or in installments.

If the participant’s account balance is over \$5,000, then the distributions will be paid either as a lump sum or in installment payments for required minimum distributions.

g. Payment of benefits, (Continued)

If the participant's account balance is under \$5,000, then the distribution will be made as soon as administratively practicable after the participant leaves the Company. If the participant does not respond regarding method of distribution, then the distribution will be rolled into an Individual Retirement Account in the name of the participant.

Participants may also withdraw funds from their account in the event of financial hardship as defined in the plan agreement.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

b. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the investment adviser and custodian. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes receivable from participants (participant loans)

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

e. Payment of benefits

Benefits are recorded when paid.

f. Administrative expenses

Transaction based fees are charged directly to participants accounts. Certain administrative expenses were paid by the Company and are not reflected in these financial statements. Administrative expenses not paid by the Company are charged to participants' accounts and are apportioned based upon their relative account values.

g. Date of Plan's review

The Plan has evaluated subsequent events through August 21, 2025, the date the financial statements were available to be issued.

3. TRUSTEE CERTIFICATIONS UNDER ERISA SECTION 103(a)(3)(C)

The plan sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the scope of the auditors' examination did not extend to the following information certified by T. Rowe Price Trust Company (TRP), the trustee, as complete and accurate:

- Investments
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

4. FAIR VALUE MEASUREMENTS, (Continued)

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common trust funds: Valued at the NAV of units of the common trust funds. The NAV, as provided by the fund's trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell an investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common trust fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust for 30 days (retirement trusts) or twelve months (stable value common trust).

Cash, interest bearing: Valued at the quoted balance, including accrued interest if applicable, per the financial institution, as of the date of the financial statements.

5. PARTY-IN-INTEREST TRANSACTIONS

The Plan offers investment options issued by TRP. TRP is the trustee and third-party administrator, as defined by the Plan and therefore, these transactions are recognized as exempt party-in-interest transactions under ERISA.

For the year ended December 31, 2024, the Plan paid \$74,688 for certain expenses related to plan operations to service providers. These expenses are exempt party-in-interest transactions under ERISA.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants would receive the balance of their accounts at the time of termination.

7. TAX STATUS

The Plan utilizes a prototype non-standardized pre-approved profit sharing plan document administered by TRP that obtained a determination letter dated August 19, 2020 from the IRS, which states that the Plan, as designed, complied with applicable requirements of the Internal Revenue Code (IRC). The plan administrator and the Plan's ERISA counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
