Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of North Alamo Water Supply Corporation Employees' 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of North Alamo Water Supply Corporation Employees' 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of North Alamo Water Supply Corporation Employees' 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE A - DESCRIPTION OF PLAN

The following description of the North Alamo Water Supply Corporation Employees' 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement and Plan amendments for a more comprehensive description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering all employees of North Alamo Water Supply Corporation (Corporation), who have completed at least one hour in six calendar months of service. Eligible employees may enter the Plan on the first day of the first and seventh month of the Plan year. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

Participants may contribute up to the maximum allowed by law (\$23,000 in 2024), as defined by the Plan. Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code (the "Code") as defined in the Plan Documents. Eligible participants may make a rollover contribution to the Plan.

Participants who are eligible to make salary deferral contributions under the Plan and who have attained the age of 50 before the close of the year may make catch-up contributions in the amount of \$7,500 in accordance with, and subject to, the limitations imposed by the Code.

The Corporation makes a discretionary 5% profit sharing contribution for each of its employees on a weekly basis with not annual true up provisions at the end of the year. Contributions are subject to certain limitations. The total employer profit sharing contributions for December 31, 2024 was \$280,589. The Corporation did not make any discretionary matching contributions for the year ended December 31, 2024.

3. Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the employer's discretionary and qualified non-elective contributions, (b) forfeitures and (c) Plan earnings (losses) and charged with distributions and an allocation of administrative expenses, if any. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Forfeitures are directly allocated to the remaining participants.

4. Notes Receivable from Participants

Participants are permitted to borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A maximum of two loans per participant are permitted at any given time. The notes receivable are secured by the balance in the participant's account and bear interest at reasonable rates equal to the prime rate. The Principal and interest is paid ratably over 5 years, or 15 years for the purchase of a primary residence, through regularly scheduled payroll deductions.

5. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Corporation's employer contribution portion of accounts, plus actual earnings thereon are as follows:

6. Investment Options

Upon enrollment in the Plan, a participant may direct their salary deferrals into any of the Plan's investment options.

7. Payment of Benefits and Distributions

Normal retirement age is when a participant attains their 65th birthday. Participants may elect early retirement if they have attained the age of 55 and completion of one year of participation.

Distributions upon death of the participant prior to receiving any benefits shall be made pursuant to the election of the participant or beneficiary. Distributions upon termination of employment may be made immediately at the participant's election. Distributions may be made in cash or property in the form of lump sums or installments.

Hardship distributions are available in the case of immediate and heavy financial needs from any participant deferral accounts which are 100% vested.

8. Administrative Expenses

Employees of the Corporation perform certain administrative functions with no compensation from the Plan. In accordance with the Plan's provisions, the Corporation pays costs relating to asset charges, recordkeeping and audit. Participants pay certain investment administrative expenses through their account balances. Expenses paid directly by participants totaled \$44,237 for the year ended December 31, 2024. Administrative expenses paid directly by the Corporation totaled \$4,955 for the year ended December 31, 2024.

9. Forfeitures

For any plan year, forfeitures can be added to or used to reduce the Corporation's discretionary contributions for the plan year in which such forfeitures occur and will be allocated among the participant's accounts in the same manner as the Corporation's discretionary contributions. 10. Top-heavy Status

A "top-heavy" plan benefits "key-employees" such as certain owners or officers. A plan will reach "top-heavy" status when 60% of the contributions or benefits have been allocated to these key-employees. In the event that the Plan becomes "top-heavy", the employer will be required to contribute a minimum allocation to each "non-key participant" to provide them with at least "top-heavy minimum benefits". The Plan was not "top-heavy" at December 31, 2024.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

1. Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

2. Investment Valuation and Income Recognition

The investments of the Plan are stated at fair value and are subject to market or credit risks customarily associated with equity investments.

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the year and unrealized increases or decreases in the market value of investments held at year end. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

3. Payments of Benefits

Benefits are recorded when paid except when corrective distributions are accrued as payable.

4. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance of credit losses have been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

5. Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires the Plan administrators to make estimates and assumptions that effect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

6. Contributions

Contributions from the Corporation and participants are accrued as they become obligations of the Corporation, as determined by the Plan's administrator, and in the period in which they are deducted from payroll, in accordance with salary deferral arrangements.

7. Fair Value Measurements

The Plan follows FASB ASC Topic No. 820, *Fair Value Measurements and Disclosures*, for financial assets and financial liabilities. ASC Topic No. 820 defined fair value, establishes a framework for measuring fair value in generally accepted accounting principles, and expands disclosure about fair value measurements. ASC Topic 820 applies to all financial instruments that are being measured and reported on a fair value basis. ASC Topic No. 820 defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

ASC Topic 820 also establishes a fair value hierarchy that prioritizes the inputs used in the valuation methodologies into the following three levels:

- Level 1 Inputs – Unadjusted quoted prices in active markets for identical assets or liabilities.
- Level 2 Inputs – Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

• Level 3 Inputs – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. Level 3 assets and liabilities include financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or other valuation techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

When only net asset value of investments is available, the Plan follows the Financial Accounting Standards Board (FASB) update ASU 2015-07, which removes the requirement for reporting entities to categorize within the fair value hierarchy all investments for which fair value is measured using the net asset value per share practical expedient. ASU 2015-07 also removes the requirement to make certain disclosures for all investments that are measured at fair value using the net asset value per share practical expedient.

Stable value investment contracts (also known as investment contracts or wrap contracts) are contracts issued by insurance companies, banks, and other financial institutions that provide book value accounting treatment for the fund. These contracts are designed to provide capital preservation and permit benefit-responsive transactions at book value. Investment contracts do not insure the value of the fund and are not insurance against fund losses but rather by applying book value accounting standards permit the amortization of gains and losses over time through the crediting rate thus providing capital preservation.

NOTE G - TAX STATUS

The IRS has determined and informed the Plan sponsor by a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification.

The Corporation believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The Plan's management evaluates tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax position taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any period in progress.

NOTE H - TERMINATED PARTICIPANTS

The vested amount due to terminated participants totaled \$45,067 at December 31, 2024.

NOTE I - PARTIES-IN-INTEREST TRANSACTIONS

Parties-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

The Plan invests in shares of mutual funds managed by Principal Life Insurance Company, which acts as the record-keeper for only those investments as defined by the Plan. Transactions in such investments qualify as a party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

NOTE J – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
