### 1. DESCRIPTION OF PLAN

The following brief description of the Our Hospice Retirement Plan provides only general information. Plan participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### GENERAL

The Plan is a defined contribution plan covering all employees and participating affiliates of Our Hospice of South Central Indiana, Inc. (the Company) who have completed one month of service and are at least 18 years of age. Employees will become a participant on the first day of the plan year quarter coinciding with or next following the completion of the eligibility requirements. The assets of the Plan are held by ADP Retirement Services (ADP). Recordkeeping services are provided by ADP Retirement Services, Inc. and advisory services are provided by Reliance Trust Company.

#### CONTRIBUTIONS

Participants may elect to defer a percentage of their compensation each year, up to annual Federal applicable maximum limits. Participants over age 50 may make additional catch-up contributions, as provided by the Internal Revenue Code (IRC).

For the year ended December 31, 2024, the Company elected to make matching contributions equal to 100% of the first 4% of the participant's compensation which is deferred as an elective contribution. Matching contributions are calculated each payroll period and submitted to ADP.

#### PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contributions, an allocation of the Company's contribution, if applicable, and the Plan's earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts at the time of benefit event.

#### VESTING

Participants are always 100% vested in their contributions, as well as the employer matching contributions plus actual earnings thereon. Discretionary employer contributions and earnings thereon vest at 20% per year beginning at the end of year 2 and are fully vested in year 6.

#### BENEFITS

Benefits are payable to participants upon termination of employment for reasons such as retirement, disability, or death. In the event the participant's vested balance does not exceed \$5,000, a lump-sum distribution will be made regardless of whether the participant consents to receive it. If the participant's vested balance exceeds \$5,000, they have the option of receiving a distribution of their vested balance in a single lump sum, installments, or partial withdrawals of \$1,000. Benefits are recorded when paid.

### NOTES RECEIVABLE FROM PARTICIPANTS

The Plan does not allow for loans to participants.

### FORFEITED ACCOUNTS

Upon a participant's separation from service, nonvested accounts are forfeited to the Plan and are used to pay administrative expenses and reduce Company contributions. At December 31, 2024 and 2023, the Company had \$18 and \$14 of forfeited nonvested accounts, respectively.

### PLAN TERMINATION

While the Company hopes and expects to continue the Plan indefinitely, it reserves the right to terminate, discontinue making contributions to, amend, or modify the Plan at any time, acting through written resolution of the Company's board of directors. In the event the Company terminates its participation in the Plan, the affected participants who are actively employed by the Company at the time of termination, shall be fully vested for amounts credited to their accounts on the termination date. The Plan will arrange for distributions upon Plan termination as soon as administratively possible.

## 2. SIGNIFICANT ACCOUNTING POLICIES

### BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting, whereby additions and deductions are recorded in the year in which they are incurred rather than in the year which they are received or paid.

### ESTIMATES

The Plan Administrator uses estimates and assumptions in preparing financial statements in conformity with the accounting principles generally accepted in the United States of America. These estimates and assumptions affect the reported amounts of net assets available for benefits, the disclosure of contingencies and the reported additions to and deductions from net assets available for benefits. Accordingly, actual results could differ from those estimates.

### INVESTMENT VALUATION AND INCOME RECOGNITION

The assets of the Plan are held by ADP. Mutual funds are stated at their fair market values. Investments held in the insurance company's general account are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net appreciation or depreciation of investments is reported in the statement of changes in net assets available for benefits and consists of the realized gains and losses and the unrealized appreciation or depreciation of these investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded as received.

### EXPENSES OF THE PLAN

Certain expenses of the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments. Certain administrative expenses of the Plan, including claim administrative fees, are paid by the Plan as incurred.

### **3. INCOME TAXES**

The Plan uses a prototype plan document sponsored by ADP Retirement Services, Inc., the Custodian of the Plan. In a letter dated March 31, 2014, the Internal Revenue Service (IRS) determined that the prototype plan constitutes a qualified trust under Section 401(a) of the IRC and is, therefore, exempt from income taxes. The Plan provides for retirement benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Although the Plan has been amended since receiving a favorable opinion letter from the IRS, the Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt.

The Plan evaluates all significant tax positions. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability, nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next 12 months. The Plan's income tax returns are subject to examination by the appropriate regulatory authorities; there are currently no audits for any tax periods in progress.

### **4. PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such a person.

Certain Plan investments are managed by the Custodian or other advisors. Fees may be deducted from the return earned on a participant's investments. Transactions with these parties qualify as exempt party-in-interest transactions. Agresta, Storms, & O'Leary, PC served as the Plan's auditors. The Company provides certain accounting, administrative, and investment management services to the Plan, for which they receive no compensation. Fees paid by the Plan for investment advisory, management fees, and administrative services totaled \$47,904 for the year ended December 31, 2024.

### 5. INVESTMENTS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, ADP has certified to the completeness and accuracy of all investments reflected on the accompanying statement of net assets available for benefits and the schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### 6. INVESTMENT IN GUARANTEED INTEREST CONTRACT(S) AND STABLE FUND(S)

The Plan had an investment in Metlife Reliance Stable Value Fund (the Fund) for the year ended December 31, 2024 and 2023. The Fund was a fully benefit-responsive investment fund for the collective investment of qualified plans. Because this investment was fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to this fully benefit-responsive contract. Such contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawal or transfer all or a portion of their investment at contract value. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer(s). Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Fund to qualify for exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable. The contract value of the investment in the Fund was \$891,102 and 718,799 at December 31, 2024 and 2023, respectively.

### 7. FAIR VALUE MEASUREMENTS

The mutual funds are reported at fair value in accordance with ASC 820, *Fair Value Measurement and Disclosures*, in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

ASC 820 defines fair value, establishes a framework for measuring fair value under GAAP and expands disclosures about fair value measurements. ASC 820 also establishes a three-level fair value hierarchy that prioritizes the inputs used to measure fair value. This hierarchy requires that the Plan maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of inputs used to measure fair value are as follows:

Level 1 – Quoted prices in active markets for identical assets or liabilities.

Level 2 – Observable inputs other than quoted prices in Level 1, such as quoted prices for similar assets and liabilities in active markets, similar assets and liabilities in markets that are not active or can be corroborated by observable market data.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets and liabilities. This includes certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.
