Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Plan Description

The following brief description of the Tampa Microwave, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was established on August 1, 2006, amended and restated effective May 1, 2022, and is a defined contribution plan and operates under Section 401(k) of the Internal Revenue Code (IRC). The Plan covers all eligible employees (as defined) of Tampa Microwave, LLC and its affiliates (the Company or Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2025, the Plan's trustee changed from Reliance Trust Company to ADP Retirement Trust Company, LLC.

Eligibility

Employees aged 18 or older are eligible to enter the Plan and receive employer matching contributions on the first day of the month following meeting the eligibility requirements.

Contributions

Participants in the Plan may make pre-tax and Roth contributions up to 90% of the eligible compensation provided that the participant's contribution does not exceed the maximum dollar amount determined by the Internal Revenue Service (IRS) each year.

The Employer matches 100% of participants' elective contributions up to a maximum of 5% of a participant's eligible compensation calculated on a pay period basis. The Plan allows for discretionary non-elective contributions. The Company did not make any non-elective contributions for the year ended December 31, 2024.

Vesting

Participants are immediately 100% vested in their own contributions, employer matching contributions, and discretionary non-elective contributions plus actual earnings thereon.

Forfeitures

A participant who terminates employment and is less than 100% vested in their account balance forfeits the non-vested portion of their account. Forfeitures are used to pay Plan expenses or to reduce matching contributions of the Employer. During the year ended December 31, 2024, there were no forfeitures used to reduce matching contributions or pay plan expenses. As of December 31, 2024 and 2023, the balance in the forfeiture account was \$0.

Participant Accounts

Individual participant accounts are credited with applicable participant contributions and related employer matching contributions and allocations of 1) employer profit sharing contributions and 2) plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is equal to the vested portion of the participant's account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Benefit Payments

The Plan provides benefits upon termination of employment, termination of service due to death, disability or retirement, or attainment of age 59½ while still employed. Generally, a participant may elect to receive the value of their vested interest in his or her account in either a lump-sum amount, equal installments, or partial withdrawal as set forth in the Plan Document. Hardship withdrawals are available, as defined in the Plan Document.

Notes Receivable from Participants

Participants may borrow from their accounts with a minimum of \$500 up to a maximum equal to 50% of the vested account balance. The loans are secured by the balance in the participant's account and bear interest at the federal prime rate plus 2% at the date of the loan. Loans must be repaid within a period not to exceed five years unless it is to purchase a principal residence loan and then the loan must be repaid within a period not to exceed 30 years. Participants may not have more than 1 loan outstanding at a time. Principal and interest are paid through payroll deductions. Interest rates on outstanding loans ranged from 5.00% to 9.50% at December 31, 2024.

Note 2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of Plan income and expenses during the reporting period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative fees and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded (deemed distribution).

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Company.

Subsequent Events

Management evaluated subsequent events for the Plan through October 1, 2025, the date the financial statements were available to be issued.

Note 3. Certified Investments

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value of measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value fall into one of the three levels of the fair value hierarchy below and are defined as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access

Level 2 - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies during 2024 and 2023.

Mutual Funds – valued at unadjusted quoted market prices in an active market.

Common Collective trusts – the fair value of the common collective trust is determined by the custodian of the common collective trust funds based on the underlying assets, which represents the net asset value. Participant directed redemptions can be made on any business day and do not have a redemption period. There were no unfunded commitments.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes that its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party Transactions and Party in Interest Transactions

Fees paid by the Plan to ADP trustee, recordkeeping and administrative services amounted to approximately \$3,000 for the year ended December 31, 2024. Fees paid to the investment advisors also qualify as party-in-interest transactions. Total fees paid to the investment advisor were approximately \$54,000.

ADP and the Company have an agreement whereby participants are charged a fee in proportion to their account balance, which is credited to the expense budget account. This amount can be used to pay for ERISA qualified expenses or allocated to participants at the end of the year. For the year ended December 31, 2024, approximately \$27,000 was charged to participants and \$27,000 was used to pay for ERISA qualified investment advisor fees. There was no remaining balance available to pay for future expenses at December 31, 2024 and 2023.

Note 6. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by ADP, LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.
