Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1. Description of Plan

The following description of the BlueAlly Technology Solutions 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by BlueAlly Technology LLC (the “Company”) for the benefit of substantially all its employees who are age 21 or older and who have completed three months of service with the Company. Related employers who also participate in the Plan include N2Grate Government Technology Solutions, LLC, and Chesapeake Netcraftsmen, LLC. The Retirement Committee of the Board of Directors of the Company controls and manages the operation and administration of the Plan. Reliance Trust Company serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 90% of annual compensation, as defined in the plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants are permitted to irrevocably designate that a portion or all of deferral contributions are made as Roth 401(k) contributions that are includable in the participants’ gross income at the time deferred. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Company may make discretionary matching and qualified non-elective contributions in an amount that is determined by the Company’s board of directors. During 2024, the Company made discretionary matching contributions equal to 100% of the first 3% of compensation. Contributions are subject to certain limitations.

Investment Options

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a money market fund as investment options for participants.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, allocations of the Company’s discretionary contributions, and plan earnings (losses) and charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in employee deferral contributions and discretionary matching contributions. Qualified non-elective contributions are subject to a six-year graduated vesting schedule, which is defined in the plan adoption agreement.

Participants with employer contribution source balances transferred into the Plan from Virtual Graffiti, Inc. on January 1, 2022 are subject to different vesting requirements than employer contribution source balances accumulated after the transfer date. The employer contribution source balances transferred into the Plan from Virtual Graffiti, including matching contributions, are subject to a six-year graduated vesting schedule, which is defined in Virtual Graffiti, Inc.’s plan adoption agreement effective January 1, 2015.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. At December 31, 2024, outstanding loans bore interest rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or partial withdrawals as provided by the Plan. Amounts contributed may be withdrawn upon certification by the participant of financial hardship, with limitations as defined in the Plan. In-service distributions are permitted from fully vested accounts after attaining age 59½.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts were \$3,175 and \$622, respectively. During 2024, forfeitures of \$1,765 were used to reduce Company discretionary matching contributions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income from notes receivables from participants is recorded when received. Other interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded upon distribution.

Administrative Expenses

The Plan’s administrative expenses are paid by the Plan, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable and distributions) are charged directly to the participant’s account.

Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan’s assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual and Money Market Funds

Mutual and money market funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Note 4. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule(s) is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 5. Exempt Party-In-Interest Transactions

Fees paid by the Plan for investment management services and recordkeeping services were \$89,185 and \$53,510, respectively, for the year ended December 31, 2024. These fees are allocated to each participant account.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Note 7. Tax Status

The Plan has not obtained a determination letter from the Internal Revenue Service (the “IRS”) stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the prototype non-standardized plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated October 6, 2020 that the non-standardized prototype plan document was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Plan Mergers

On January 30, 2023, the Company entered into an agreement to acquire N2Grate Government Technology Solutions. Ownership of all assets in the N2Grate 401(k) Plan was transferred to the BlueAlly Technology Solutions 401(k) Plan effective December 31, 2023. The assets in the N2Grate 401(k) Plan were in transit to the BlueAlly Technology Solutions 401(k) Plan as of December 31, 2023.

On March 14, 2022, the Company entered into a merger agreement with Chesapeake Netcraftsmen, LLC. Ownership of all assets in the Chesapeake Netcraftsmen, LLC 401(k) Plan was transferred to the BlueAlly Technology Solutions 401(k) Plan effective December 31, 2023. The assets in the Chesapeake Netcraftsmen, LLC 401(k) Plan were in transit to the BlueAlly Technology Solutions 401(k) Plan as of December 31, 2023.

On July 23, 2023, the Company entered into an agreement to acquire Strata Business Solutions, LLC. Ownership of all assets in the Strata Consulting LLC 401(k) P/S Plan was transferred to the BlueAlly Technology Solutions 401(k) Plan effective December 31, 2023. The assets in the Strata Consulting LLC 401(k) P/S Plan were in transit to the BlueAlly Technology Solutions 401(k) Plan as of December 31, 2023.

The merger and acquisition activity above resulted in \$26,159,528 being transferred to the Plan effective December 31, 2023.
