### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Morgan Li, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Morgan Li, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Reliance Trust Company (Reliance) as of December 31, 2024 and for the period from October 1, 2024 to December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Notes to Financial Statements

#### Note 1 – Description of plan

The following brief description of the Morgan Li, LLC 401(k) Plan (The Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan was adopted effective January 1, 2014, by Morgan Li, LLC (the Company) and is the sponsor of the Plan. The Plan is a noncontributory defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended. (ERISA).

#### *Trustee and Administration of the Plan*

The trustees and/or custodians of the Plan are Reliance and Matrix. The recordkeeper of the Plan ADP Retirement Services (ADP). The administrator of the Plan is the Company. The trustee and/or custodian hold all the assets of the Plan in accordance with the service provider contract with the Company.

#### *Eligibility*

Participant must be 21 years of age to participate in the Plan. Additionally, the participant must complete two months of service to participate in the Plan. An eligible participant can enter the Plan on the first date of the month coinciding with satisfying the eligibility requirements. Furthermore, union employees are excluded from participation in the Plan.

#### *Contributions*

Participants may contribute up to 90% of annual compensation, as defined in the Plan document, as pretax or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

In accordance with Plan provisions, the Company makes safe harbor and profit-sharing contributions. The Company contributes 100% of the first 3% of the eligible participant compensation. Additionally, the Company makes a discretionary profit-sharing contribution which for 2024 is 100% of the first 2% of eligible participant compensation. To be eligible for the profit-sharing contribution a participant must be employed on the last day of the plan year. For the year ended December 31, 2024 the safe harbor and profit-sharing contributions amounted to \$244,498 and \$298,926, respectively. Contributions are subject to certain statutory limitations, as defined in the Plan.

### Notes to Financial Statements

#### Note 1 – Description of plan, cont'd

##### *Participant accounts*

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

##### *Vesting*

Participants are immediately vested in their contributions and safe harbor plus actual earnings thereon. Vesting in the Company's profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

##### *Payment of benefits*

A participant's entire vested balance in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum amount, installment payments equal to the vested portion of the participant's account, leave the account in the Plan, or rollover the vested balance to another qualified retirement plan or IRA.

Immediate lump-sum distributions are to be made to terminated participants if the participant's vested account balance is \$5,000 or less.

Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

Participants may also withdrawal an amount at age 59½ if certain criteria are met.

##### *Forfeited accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$22,695 and 7,399 respectively. These accounts may be used to pay administrative expenses and reduce future Company contributions.

### Notes to Financial Statements

#### Note 1 – Description of plan, cont'd

##### *Notes Receivable from Participants*

Participants may borrow from their account balance up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. The Plan requires a minimum loan of \$1,000. The Plan allows up to two loans outstanding at any time. Loan terms range from one to five years; however, terms may exceed five years, as defined in the Plan document, for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at 1% above the prime rate. The interest rate on loans outstanding in 2024 and 2023 ranged from 4.25% to 9.5%. Principal and interest are repaid through a payroll deduction agreement, except to the extent the Plan administrator determines payroll withholding is not practical given the level of participants' wages, the frequency with which the participant is paid, or other circumstances.

#### Note 2 - Significant accounting policies

##### *Basis of accounting*

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

##### *Use of estimates*

The preparation of financial statements in accordance with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

##### *Investment valuation and income recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Note 2 - Significant accounting policies, cont'd.

##### *Notes receivable from participants*

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

##### *Payment of benefits*

Benefit payments to participants are recorded when paid.

##### *Administrative costs*

Administrative expenses of the Plan are paid by the Plan, except for certain expenses that are charged to participant accounts, including loan fees, withdrawal fees, plan administrative fees, and investment management fees. Certain investment expenses which are charged within investments are presented net of the appreciation in fair value of investments. All other expenses of the Plan for the year ended December 31, 2024, were paid by the Company and are excluded from these financial statements.

##### *Date of management's review*

Subsequent events were evaluated through September 20, 2025, which is the date the financial statements were available to be issued.

#### Note 3 – Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

#### Note 4 – Certified investment information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance and Matrix, qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation and or depreciation in fair value of investments, interest income on notes receivable from participants, and other income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### Note 5 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under U.S. GAAP, are described as follows:

Level 1 - This level includes inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - This level includes inputs to the valuation methodology that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - This level includes inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

Note 5 - Fair value measurements, cont'd

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during 2024.

*Mutual Funds* - Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Notes to Financial Statements

#### Note 6 - Party-in-Interest Transactions

Certain Plan investments are managed by Reliance and Matrix. Any purchases and sales of these funds qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Notes receivable from participants and fees paid to Reliance and ADP also qualify as exempt party-in-interest transactions.

#### Note 7 – Tax status

The Plan has adopted the ADP, LLC (ADP) Non-Standard Pre-Approved Profit-Sharing/Money Purchase/CODA. Accordingly, the Plan is permitted to rely on ADP's opinion letter. The IRS has determined and informed ADP by letter dated October 6, 2020 that the Plan is designed in accordance with the applicable sections of the IRC. Although the Plan has subsequently been amended, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8 – Plan termination

Although it has not expressed any intent to do so, the Company has the right to, at any time, terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, each participant's individual account balance will be held under the original Plan agreement and continue to accrue investment earnings or losses until it is used to provide benefits according to the terms of the Plan.
