### Note 1 – Description of the Plan

The following brief description of the Van Acker Construction 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of its provisions.

#### General

The Plan is a defined contribution profit sharing plan with a cash or deferral arrangement under section 401(k) of the Internal Revenue Code (IRC). New loans are not permitted into the Plan, per the July 1, 2022 plan amendment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

A Plan committee, appointed by the Board of Directors of Van Acker, manages the Plan. Reliance Trust Company, the Trustee, holds all the Plan investment assets. ADP Retirement Services is the Administrator and prepares the Form 5500.

#### Eligibility

Employees of Van Acker may participate in the Plan on the first day of January or July coincident with or following one year of service with at least 1,000 hours of service and attainment of age 21; however, employees covered by a collective bargaining agreement or nonresident aliens without U.S. income are not eligible to participate in the Plan.

#### Contributions and vesting

Participants may defer (pre-tax regular and post-tax Roth) up to the lower of 90% of their annual qualified compensation and the IRC limit to the Plan. Participants that attain age 50 by the last day of the Plan year may defer additional amounts (“catch-up” contributions) to the Plan. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Rollovers are not subject to Plan or IRC contribution limits. Participants are always 100% vested in their deferral, catch-up and rollover contributions and earnings thereon.

The Plan provides for an annual non-elective Safe Harbor contribution by Van Acker and allocates it to each participant, equal to 3% of their eligible compensation. Participants are always 100% vested in their annual non-elective Safe Harbor contribution and earnings thereon. There was no change from the non-elective Safe Harbor contribution rate used during the year ended December 31, 2023.

The Plan also provides for an annual discretionary profit sharing contribution, determined by the Board of Directors of Van Acker. Van Acker allocates any annual discretionary profit sharing contribution based on the relative eligible compensation earned by each eligible participant. An eligible participant for the annual discretionary profit sharing contribution is one that Van

Acker credited with at least 500 hours of service during the Plan year, employed at the end of the Plan year, or dies, becomes disabled or reaches normal retirement age (65) during the Plan year. Participants are always 100% vested in their annual discretionary profit sharing contribution and earnings thereon. During the year ended December 31, 2024, Van Acker paid an annual discretionary profit-sharing contribution equal to 1.9% of eligible participant compensation. There was no change from the discretionary profit-sharing contribution rate used during the year ended December 31, 2023.

The Plan also provides for an annual discretionary matching contribution, determined by the Board of Directors of Van Acker. Van Acker allocates any annual discretionary matching contribution as a percentage of participant deferrals, limited by eligible compensation. Participants not deferring during the Plan year are ineligible for any annual discretionary matching contribution for that Plan year. Participants are always 100% vested in their annual discretionary matching contribution and earnings thereon. During the years ended December 31, 2024 and 2023, Van Acker made no annual discretionary matching contribution. There was no change from the matching contribution rate used during the year ended December 31, 2023.

Participant accounts

Each participant's account is credited with the participant's contributions, employer safe harbor contributions, as well as allocations of employer discretionary profit sharing and matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment options

Participants choose investment options for their deferral, catch-up, rollover, Safe Harbor, profit sharing and matching contributions from the investment options offered by the Trustee. As of December 31, 2024, the Trustee offered mutual funds to participants.

Notes receivable from participants

Effective April 7, 2021, participants could borrow, by withdrawing a portion of their vested account balance, a minimum of \$500 and a maximum of the lower of 50% of the vested account balance or \$50,000 (less the highest outstanding note balance during the past twelve months). The notes would bear fixed interest at rates similar to those issued by lending institutions under similar circumstances and the term of the notes could not exceed five years, except when the participant used the note proceeds to buy the participant's principal residence, in which case the maximum term was thirty years. Participants would make weekly note payments with deferrals

of after-tax compensation. The remaining participant account balance secured the note. Notes became due immediately upon termination of employment. Effective July 1, 2022, new loans are not allowed into the Plan. At December 31, 2024 and 2023, the Plan had no participant notes receivable outstanding.

Payment of Benefits

Upon termination of employment, death, attainment of age 59 ½, retirement, disability and for any other reasons permitted by the Plan or the IRC, a participant or beneficiary is entitled to receive a lump-sum distribution, a rollover, or installments equal to the participant's vested interest in his or her account. A participant also can take a distribution of his or her rollover contributions and Roth contributions (if any) at any time. Terminated participants with account balances in excess of \$7,000 may delay the receipts of distributions. The Plan, at its discretion, will distribute terminated participants' account balances of \$7,000 or less directly to participants.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by Van Acker. Expenses that are paid by Van Acker are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (US-GAAP).

Use of estimates

The preparation of financial statements in conformity with US-GAAP requires management to make estimates and assumptions that affect reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustees. See Note 3 for disclosure of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Note 3 – Investments at Fair Value Measurements

The Plan uses a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to level 1 inputs and the lowest priority to Level 3 inputs. The hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs consist of quoted prices for identical assets or liabilities in active markets, quoted prices for identical assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs consist of unobservable inputs that are significant to the fair value measurement.

The fair value measurement level of an asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methodology used to measure fair value at December 31, 2024 and 2023.

The Plan bases the fair value of mutual funds on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). The SEC requires mutual funds to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are considered to be actively traded.

As of December 31, 2024, the fair values and input Levels of the Plan investments totaled as follows:

Note 4 – Financial Information Certified by the Trustee

Reliance Trust Company, the Trustee, certified all of the investments in the statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Line 4(i): Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment income in the statement of changes in net assets available for benefits for the year ended December 31, 2024, in accordance with Section 2520.103.5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Independent auditors did not audit the information certified by the Trustee.

Note 5 – Receivables

The Trustee received and allocated the annual non-elective Safe Harbor and discretionary profit-sharing contributions, calculated on eligible compensation earned during the year ended December 31, 2024, and totaling \$401,878 and \$253,665, on April 2 and March 28, 2025, respectively.

The Trustee received and allocated the annual non-elective Safe Harbor and discretionary profit-sharing contributions, calculated on eligible compensation earned during the year ended December 31, 2023, and totaling \$371,827 and \$235,083, on March 29 and April 4, 2024, respectively.

As of December 31, 2023, deferrals from compensation earned during the pay period December 17, through 23, 2023 and subsequently received and allocated by the Trustee on January 2, 2024, totaled \$9,883.

Note 6 – Income Tax Status

Van Acker last amended and restated the Plan effective July 1, 2022, and patterned the amended and restated Plan after the “Non-standardized Pre-Approved Profit Sharing Plan/Money Purchase with CODA” of the Trustee. The Internal Revenue Service (IRS) issued the latest determination letter for the “Non-standardized Pre-Approved Profit Sharing Plan/Money Purchase with CODA” on October 6, 2020. The favorable determination letter stated that the “Prototype Non-standardized Profit Sharing Plan with CODA,” as then designed, complied with the applicable requirements of the IRC. Although Van Acker has since amended the Plan, management and its tax counsel believe that the current design, qualification and operations of the Plan comply with the applicable sections of the IRC and the related trust was tax-exempt as of December 31, 2024. Accordingly, Van Acker did not include a provision for income taxes.

In addition, management evaluates certain tax positions taken by the Plan and recognizes a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. As of December 31, 2024 and 2023, two investment funds represented approximately 39% and 36% of total investments, respectively.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, Van Acker has the right to discontinue future profit sharing and matching contributions at any time and to amend or terminate the Plan subject to the provisions of the ERISA. Under no circumstances may any vested Plan assets revert to Van Acker by Plan amendment or termination.

Note 9 – Terminated Participants

As of December 31, 2024 and 2023, participants who were no longer employees of Van Acker had \$2,969,872 and \$3,473,718, respectively, remaining in their accounts, all of which is fully vested.

Note 10 – Related Party and Party-in-Interest Transactions

The Trustee and its affiliates own, control or sub-advise the investments of all the mutual funds. Such investment transactions constitute party-in-interest transactions.

The Trustee provides certain administrative services to the Plan. The Trustee may receive revenue from mutual fund service providers for services it provides.

All of these party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

Note 11 – Form 5500 Reconciliation
