## KVH Industries, Inc. 401(k) Plan Notes to Financial Statements

### **1. Description of Plan**

The following description of the KVH Industries, Inc. 401(k) Plan (the Plan) is provided for general purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan, available to all employees of KVH Industries, Inc. (the Plan Administrator) who have met the eligibility requirements stipulated by the Plan. The Plan is administered by the management of the Company and is subject to the provisions of the Employee Retirement Income Security Act (ERISA). Reliance Trust Company (Reliance) was the trustee of the Plan and ADP Retirement Services (ADP) provided recordkeeping services for the Plan as of and for the years ended December 31, 2024 and 2023.

#### **Eligibility**

In general, employees are eligible to participate in the Plan upon 30 days of service and attainment of age 21. Employees who meet the eligibility requirements can enter into the Plan at any time. Eligible participants are automatically enrolled in the Plan at a 6% contribution rate on the first of the month following 30 days of service unless they opt out of participation in the Plan or elect a different contribution rate.

#### **Contributions**

Each year, participants may contribute a dollar amount or percentage up to 90% of their pretax annual compensation as defined by the Plan. Participant contributions are subject to limitations imposed by the Internal Revenue Code, which was \$23,000 for 2024 and \$22,500 for 2023 (plus \$7,500 for eligible catch-up contributions made by participants of the age of 50 and older, for 2024 and 2023). Participants may also designate a portion of their contributions as Roth 401(k) contributions, which are taxable to the participant at the time of deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans under the rollover provisions of the Plan.

The Company, at its discretion, may elect to contribute a matching contribution. For the Plan years ended December 31, 2024 and 2023, the Employer elected to match 50% of the first 6% of eligible compensation that a participant defers into the Plan with no maximum annual corporate match.

The Employer may also make a discretionary profit-sharing contribution in an amount determined annually by the Compensation Committee of the Board of Directors. To be eligible to receive a discretionary profit-sharing contribution, a participant must complete 501 hours of service during the Plan year and be employed on the last day of the Plan year. No profit-sharing contributions were made for the years ended December 31, 2024 and 2023.

**1. Description of Plan (continued)**

**Participant Accounts**

Each participant's account is credited with the participant's elective deferrals (pre-tax and/or Roth segregated), rollover contributions, matching contributions, allocations of Company profit-sharing contributions and Plan earnings (losses). Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant directed transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options**

All of the assets of the Plan are held by Reliance Trust Company. All investments are fully participant directed. Participants may direct the investment of their contributions and the Company matching contributions into any of the Plan's available investment options.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants vest in the Company's matching contributions, any employer profit sharing contributions, and any earnings thereon in accordance with the following schedule. Participants are credited with a year of service for any year in which they work 1,000 hours or more.

A participant becomes fully vested upon death, disability, or retirement, as defined by the Plan.

**Notes Receivable from Participants**

Participants may borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are limited to only having two loans outstanding at a time. Loans must be repaid over a period of no more than 5 years except in the case of a loan used to acquire a principal residence, in which the Plan Administrator may permit a longer repayment term. Payments of principal and interest are made through payroll deductions over the loan period. A loan is secured by the vested balance in the participant's account. The loan bears interest at a rate that is equal to the prime rate as published in the Wall Street Journal plus one percent and is fixed for the duration of the note.

**1. Description of Plan (continued)**

**Payment of Benefits**

Upon a participant's separation from service due to death, disability, termination, or retirement, benefits may be distributed to them in a single lump sum amount equal to the vested value of their account, through installments over a certain period at the participant's election or through partial withdrawals.

Active participants may also take in-service withdrawals from their accounts under certain hardship conditions or upon reaching age 59 ½. Hardship withdrawals may be taken from a participant's deferral account without respect to earnings. Deferral contributions are suspended for a six-month period after receipt of a hardship withdrawal.

Upon termination, if the vested benefit is less than \$5,000, the Plan Administrator will initiate an involuntary distribution. Prior to such distribution, the participant has the right to request that the amount be distributed directly to the participant in the form of a lump sum amount or request that it be rolled over to a different IRA provider.

**Forfeitures**

Upon a participant's separation from service, unvested contributions are forfeited by the participant and may be used to reduce future employer contributions. During 2024 and 2023, the amount forfeited totaled \$85,532 and \$69,967, respectively. The Company used \$55,750 and \$69,120 in forfeitures to reduce employer contributions for 2024 and 2023, respectively. There were \$29,782 and \$847 forfeited nonvested accounts at December 31, 2024 and 2023, respectively.

**Administrative Expenses**

Expenses incurred in the administration of the Plan are paid by the Employer unless the Employer directs that such expenses shall be paid by the Plan or the Participants. Fees related to the administration of notes receivable from Participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their accounts.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### **Risks and Uncertainties**

The Plan invests in various securities, including mutual funds and common collective trusts. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

### **Benefit Payments**

Benefits are recorded when they have been paid by the Plan.

### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned, and ranges from 4.25%-9.5%. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

### **Investment Income Recognition**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. The Plan presents in the Statements of Changes in Net Assets Available for Benefits the net appreciation (depreciation) in the fair value of its investments, which consists of realized and unrealized gains (losses).

**2. Summary of Significant Accounting Policies (continued)**

**Fair Value of Financial Instruments**

The Plan's investments are stated at fair value. Shares of mutual funds are valued at quoted market prices. The Plan's investments in common collective trusts are measured using the net asset value (NAV) per share of the investment as a practical expedient as permitted by Financial Accounting Standards Board (FASB) Accounting Standards Codifications (ASC) 820, *Fair Value Measurement and Disclosures* (ASC 820) and ASC 946, *Financial Services – Investment Companies*.

The Plan follows ASC 820 for all financial assets and liabilities and nonfinancial assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring basis. ASC 820 defines fair value, establishes a fair value hierarchy, and expands disclosures about fair value measurements.

ASC 820 defines fair value as the price that would be received upon sale of an asset or paid upon the transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability.

The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity. In addition, the fair value of liabilities should include consideration of non-performance risk including the Plan's own credit risk.

**Unit Values**

Individual participant accounts for the common collective trusts are maintained on a unit value basis. Participants do not have beneficial ownership in specific underlying securities or other assets in the funds but do have an interest therein represented by units which are valued daily. The funds earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the Participants' accounts are charged or credited with the number of units properly attributable to each participant.

**3. Information Certified by the Trustee**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance, the trustee of the Plan, certified to the Plan Administrator the following information related to their respective investments as complete and accurate, which has been relied on by the Plan Administrator in the preparation of the Plan's financial statements in compliance with ERISA.

**4. Fair Value Measurements**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use on unobservable inputs. The hierarchy prioritizes the inputs into three levels based on the extent to which inputs used in the measuring fair value are observable in the market. Each fair value measurement is reported in one of three levels which is determined by the lowest level input that is significant to the fair value measurement in its entirety. These levels are:

*Level 1* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be observable by market data.

*Level 3* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

**4. Fair Value Measurements (continued)**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact purchases and sales at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trusts*

Valued at the NAV of units of the common collective trusts. The NAV, provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate full redemption of the common collective trusts, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Party-in-Interest and Related Party Transactions**

Reliance is the trustee of the Plan and ADP is the record keeper and maintains custody of the assets. Transactions with those parties qualify as party-in-interest transactions. Notes receivable from participants and interest also qualify as exempt party-in-interest transactions, as defined by ERISA. Total fees paid, net of revenue credits, by the Plan to ADP were \$87,674 and \$106,007 for the years ended December 31, 2024 and 2023, respectively.

During the years ended December 31, 2024 and 2023, the Plan received revenue credits of \$ 50,043 and \$50,000, respectively, from ADP and used these credits to pay certain Plan expenses.

**6. Tax Status**

The Plan adopted a Non-Standardized Pre-Approved Profit-Sharing Plan, an Automatic Data Processing prototype plan. In accordance with Revenue Procedures 2005-16, the Company has chosen to rely on the opinion letter dated October 6, 2020. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**7. Partial Plan Termination**

In June 2024, the Company determined that a partial plan termination occurred as a result of certain reductions in the workforce and the sale of division. Under ERISA, a partial plan termination may occur if a significant percentage of the Plan participants are terminated due to actions taken by the Company. A partial plan termination occurs if 20% or more of plan participants are terminated. The partial plan termination resulted in affected participants becoming fully vested in the accrued benefits at their termination date. As a result, the Company was required to make certain affected employees that had funds withdrawn prior to the determination whole by crediting back forfeited amounts plus lost earnings. In September 2024, for the Plan year ended December 31, 2024, the Company paid \$5,880 of employer contributions for forfeited amounts credited back to affected participant accounts in 2024. The remaining unaffected participants' vesting continues to be determined according to the Plan provisions.
