### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**1. DESCRIPTION OF PLAN**

The following description of the RHC Group Management, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General –**

The Plan is a defined contribution plan covering substantially all employees of RHC Group Management, LLC (the Company) and adopting employers, who are at least age 21 and have completed one month of service. Employees who are non-resident aliens and residents of Puerto Rico are excluded from participating in the Plan. The Plan's inception date was January 1, 2024. The Plan is subject to the provisions of the Internal Revenue Code of 1986, as amended (the Code) and the Employee Retirement Income Security Act of 1974 (ERISA). All investments are participant directed.

Employees of the following employers became eligible to participate in the Plan during the plan year: Crossroads Medical Group, PLLC (effective August 1, 2024); Revere Medical of Massachusetts, PC, RHC Group, PLLC, and Smokey Mountain Urgent Care, PC (effective November 1, 2024); and Steward Healthcare (effective December 1, 2024).

**Contributions –**

Each year, participants may contribute up to 90% of their eligible compensation, as defined in the Plan, subject to the maximum amount allowed by the Code. Both pre-tax and Roth contributions are permitted under the Plan. Upon becoming eligible for the Plan, participants have a 30-day period to make their elections under the Plan or decline participation. After the 30-day period, all new employees on or after January 1, 2024 will automatically be enrolled at 3% of eligible compensation with their pre-tax deferrals directed to a default investment fund selected by the Company. Beginning on or after the first day of each succeeding Plan Year the initial automatic deferral amount will increase by 1% to a maximum of 10%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. With the approval of the plan administrator, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts –**

Each participant's account is credited with the participant's contribution, as well as allocations of Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting –**

Participants are immediately vested in their contributions and rollovers, plus earnings thereon.

**1. DESCRIPTION OF PLAN (Continued)**

**Notes Receivable from Participants –**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are required to be repaid within 5 years unless the loan is to be used for the purchase of a primary residence in which case the loan may be repaid within a period of no more than 30 years. The loans are secured by the balance in the participant's account and bear interest at the rate of prime plus 1%, as defined. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits –**

Upon termination of service, retirement, disability or death, a participant may elect to receive a lump sum, equal installment payments or partial payments in an amount equal to the value of the participant's vested interest in their account. A participant may withdraw from their rollover account at any time. In-service withdrawals from the participant's account are available upon reaching age 59 ½. If a participant's account balance is greater than \$1,000 but equal to or less than \$7,000 (increased from \$5,000 effective January 1, 2024 under the SECURE 2.0 Act), the plan administrator can automatically rollover your entire vested account balance into a traditional individual retirement account (IRA). If a participant's account balance is less than \$1,000, the plan administrator can distribute the entire balance in a lump sum amount.

Hardship withdrawals are available from the participant's accounts, in order to meet a participant's immediate and heavy financial need, as defined in the Plan document.

**Forfeitures –**

Forfeitures are used to pay Plan expenses. At December 31, 2024, there were no unallocated forfeitures. For the Plan year ended December 31, 2024, no forfeitures were used to pay Plan expenses.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting –**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates –**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition –**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

**Investment Valuation and Income Recognition (Continued) –**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants –**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent notes receivable from participants, if applicable, are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits –**

Benefits are recorded when paid.

**Administrative Expenses –**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Under the terms of the revenue sharing agreement, the Plan has a Plan Administrative Account whereby any excess revenues that exceed the administrative expenses for the plan year may be applied to pay future administrative expenses of the Plan or allocated to the accounts of participants on a pro rata basis. During the years ended December 31, 2024, excess amounts totaling \$429 were allocated back to the accounts of participants.

**Date of Management's Review –**

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued. See Note 9 for disclosure of subsequent events.

**3. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual funds:*

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. INFORMATION PREPARED AND CERTIFIED BY PLAN'S TRUSTEE**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by ADP Retirement Trust Services, LLC, the trustee of the Plan.

**5. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**6. TAX STATUS**

The Plan has adopted a prototype plan and relies on the prototype plan's opinion letter from the IRS dated October 6, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**8. PARTY-IN-INTEREST TRANSACTIONS**

Notes receivable from participants qualify as party-in-interest transactions. The Plan has a revenue sharing agreement with the Plan's recordkeeper, as discussed in Note 2. These transactions also qualify as party-in-interest transactions.

**9. SUBSEQUENT EVENTS**

Effective January 1, 2025, the Plan was amended as follows:

**Plan Name:** The Plan was formally amended to change its plan name from RHC Group Management, LLC 401(k) Plan to Revere Medical 401(k) Plan.

**Employer Match:** The Plan was amended to provide for employer matching contributions equal to 100% of a participant's elective deferrals, up to 2% of their eligible compensation, with a maximum annual match of \$2,000 per participant. Employer matching contributions will be 50% vested after one year of service and 100% vested after two years.

**In-Plan Roth Rollovers:** The Plan permits In-Plan Roth rollovers and In-Plan Roth rollover transfers, subject to a minimum amount of \$500.
