Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Pressed Paperboard Technologies, LLC Profit Sharing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Pressed Paperboard Technologies, LLC Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan, which became effective January 1, 2004, is a defined contribution plan established by Pressed Paperboard Technologies, LLC (the Company and Plan Sponsor) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). All employees over the age of 18 who have completed at least three months of service with the Company are eligible to participate on the first day of the month after eligibility requirements have been met. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of available investment options. The Plan's most recent adoption agreement was effective January 1, 2024.

Contributions: Each year, participants may contribute up to 100% of pretax annual compensation (salary reduction contributions), as defined in the Plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants who attain age 50 before the end of the plan year may be eligible for catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation with annual 1% increases up to a maximum of 5% of compensation.

The Plan Sponsor matches 100% of employee contributions for contributions that do not exceed 3% of the participant's compensation plus 50% of employee contributions between 3% and 5% of the participant's compensation. Additional Company contributions may be contributed at the discretion of the Company's board of directors. No discretionary contributions were made for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts: Each participant's account is credited with the participant's salary reduction contributions, rollover contributions and an allocation of the Company's contributions and Plan's earnings (net of administrative expenses). Allocations are based on the participant's eligible compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately 100% vested in their contributions, safe harbor contributions and earnings thereon. Vesting in employer contributions along with the earnings thereon is based on years of service.

Vesting in the employer's contributions along with earnings thereon is as follows:

A participant may also become 100% vested in employer contributions and earnings thereon upon their early retirement date, which is the date in which the participant attains 59½ years of age.

Note 1. Description of the Plan (Continued)

Forfeitures: If a participant is not fully vested on their termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future Company contributions. In 2024, forfeitures totaling \$11,408 were used to reduce Company contributions. At December 31, 2024 and 2023, forfeited account balances totaled \$0.

Payment of benefits: Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the Plan document. The Plan provides for normal retirement at age 65. The total participant's account balance is distributed in the form of a lump-sum payment, installments or an annuity. Participants who have attained age 59½ may withdraw a portion of this account balance as defined in the Plan. The Plan requires mandatory payments for terminated participants with total account balances of less than \$5,000.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are allowed to have only one loan outstanding at any time. Loan terms cannot exceed five years with the exception of the purchase of a primary residence, as defined in the Plan document. These loans are secured by the balance in the participant's account. The loans bear an interest rate equal to one percentage point above the prime rate at the time of issuance. Principal and interest is paid ratably through payroll deductions.

Plan termination: Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, the account of each participant shall be nonforfeitable and shall continue to participate in the earnings credited, expenses charged and any appreciation or depreciation of the applicable investment fund until the vested account is distributed.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) in accordance with the Financial Accounting Standards Board Accounting Standards Codification.

Valuation of investments and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. Refer to Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes gains and losses on investments bought and sold as well as held during the year.

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Notes receivable from participants: Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as benefit payments to participants based upon the terms of the Plan document.

Note 2. Summary of Significant Accounting Policies (Continued)

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Benefit payments: Benefit payments to participants are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Note 3. Information Certified and Provided by ADP Retirement Services and Reliance Trust Company

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified as complete and accurate to the best of their knowledge and belief by ADP Retirement Services (ADP), the current custodian of the Plan, as of and for the year ended December 31, 2024, and Reliance Trust Company (Reliance), the former trustee of the plan, as of December 31, 2023, qualified institutions.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Note 4. Fair Value Measurements (Continued)

The three levels of the fair value hierarchy under the accounting standards are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Registered investment companies held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded and are valued at the daily closing price as reported by the fund.

Common/collective trust fund: A stable asset value fund which invests primarily in synthetic guaranteed investment contracts that is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Due From Broker

Effective January 1, 2024, the Plan changed their custodian to ADP Retirement Trust Services, LLC (ADP). As a result of this change, the investments held by the former custodian were liquidated prior to year-end and the related proceeds from sale are shown as due from broker on the statement of net assets as of December 31, 2023. The related cash was received by ADP in January 2024. The balance as of December 31, 2024, is \$0.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Party-in-Interest Transactions

The custodian and recordkeeper services are managed by ADP or their affiliates. The administrative fees paid to ADP and their affiliates amounted to \$28,108 for the year ended December 31, 2024.

Note 8. Tax Status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan document. The pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator is not aware of any events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Prohibited Transactions

During 2023 and 2022, the Plan Sponsor inadvertently failed to deposit \$37,363 and \$54,201, respectively, of participant deferrals and loan repayments within the required timeframe as stated by the United States Department of Labor (DOL) regulations. During 2025, the Plan Sponsor remitted lost earnings to the Plan for these late deposits through the DOL's Voluntary Fiduciary Correction Program. The Plan Sponsor also filed a Form 5330 and paid the applicable excise tax, which were made from the Plan Sponsor's assets and not from the assets of the Plan.

Note 10. Subsequent Event

The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 1, 2025, the date the financial statements were available to be issued.
