The following description of the Griswold International LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees who are not nonresident aliens of Griswold International LLC (the "Plan") who have attained 21 years of age and completed three months of service. Upon satisfying the eligibility requirements, an employee is eligible to participate on the first day of the following month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions**

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan also allows for Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan contributes a safe harbor match of 100% of the first 3% of base compensation that a participant contributes to the Plan, plus 50% of the next 2% of base compensation that a participant contributes to the Plan. Additional profit sharing amounts may also be contributed at the discretion of the Plan. During the year ended December 31, 2024, the Plan made safe harbor matching contributions of \$208,154 and did not make a discretionary profit sharing contribution. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contribution, and allocations of (a) the Company's discretionary profit sharing contribution and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Note 1: Description of Plan** (Continued)

##### **Vesting**

Participants are vested immediately in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's safe harbor matching contribution and discretionary profit sharing contribution portions of their account plus actual earnings thereon is based on continuous years of service subject to a six-year graded vesting schedule, as defined in the plan document. Participants vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service.

##### **Notes Receivable From Participants**

Participants may borrow from their accounts a maximum of three loans with a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms shall not exceed five years except for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate as published in *The Wall Street Journal*, plus 1%. Interest rates on existing loans range from 3.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

##### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum, partial withdrawal, or installments if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000 but is greater than \$1,000, the plan administrator will pay an involuntary cashout distribution as a direct rollover to an individual retirement plan. Vested balances less than \$1,000 can be distributed only in a single lump-sum payment. In addition, hardship distributions out of the participant's voluntary contributions account and any vested Company contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 ½.

##### **Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10. Forfeitures are used to reinstate previously forfeited account balances of participants, if any, to reduce future Company contributions, or to pay administrative expenses of the Plan in accordance with the plan document. During 2024, forfeitures of \$111 were used to reduce the employer contributions or to pay administrative expenses of the Plan.

#### **Note 2: Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States. Under this basis, investment income and contributions are recorded when received, and plan expenses are recorded when paid, rather than recording such items on an accrual basis.

##### **Use of Estimates**

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

##### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract (FBRIC)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded when cash is disbursed or received. Interest and dividend income is recorded when cash is received. Net appreciation/depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The FBRIC is reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

##### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balances. Interest income is recognized as remitted to the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation/depreciation in fair value of investments.

##### **Subsequent Events**

The Plan has evaluated subsequent events through September 16, 2025, which is the date the financial statements were available to be issued.

#### **Note 3: Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 and 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Common collective trust funds:* Valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding and is used as a practical expedient to estimate fair value. The NAV's unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments that are traded on an active market.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Note 4: Fully Benefit Responsive Investment Contract (FBRIC)**

The Plan invests in a FBRIC with Wilmington Trust Retirement and Institutional Services Company ("Wilmington") in the form of a guaranteed investment contract (GIC) that invests in traditional investment contracts. Wilmington maintains the contributions in a pooled account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Wilmington is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Wilmington including plan termination and other events as specified in the GIC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit the Trustee to terminate the agreement prior to the scheduled maturity date.

#### **Note 5: Information Prepared and Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, FBRIC, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company ("Reliance"), the Trustee of the Plan.

#### **Note 6: Related-Party Transactions and Party-in-Interest Transactions**

Certain plan investments are managed by Reliance. Reliance is the Trustee, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation/depreciation in fair value of investments, since they are paid through revenue sharing rather than a direct payment.

ADP, LLC ("ADP") is the third-party administrator, as defined by the Plan, and therefore these transactions also qualify as party-in-interest transactions. Administrative expenses totaling \$44,957 were paid to ADP for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

#### **Note 7: Tax Status**

The Plan adopted a nonstandard prototype document with an IRS notification letter, which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **Note 8: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

#### **Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

Users of these financial statements should be aware that the financial markets' volatility may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments as of December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.
