Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Newbury Comics Employee Benefit Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Newbury Comics Employee Benefit Trust’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (a “qualified institution”).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Newbury Comics Employee Benefit Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of Plan

The following brief description of the Newbury Comics Employee Benefit Trust (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreements for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan established by Newbury Comics, Inc. (the "Company") under the provision of Section 401(a) of the Internal Revenue Code ("IRC"), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees of the Company who have completed six months of service, as defined, are eligible to participate, provided they are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

(b) Plan Administration

The Plan is administered by several officers of the Company who are appointed by the board of directors. The Plan's Trustee, Reliance Trust Company, is responsible for the custody and management of the Plan's assets.

(c) Contributions

Eligible participants may contribute the lesser of up to 90% of their eligible pretax annual compensation, as defined by the Plan, or the maximum allowed by law (\$23,000 for 2024 and \$22,500 for 2023). Participants may alternatively elect to make after-tax Roth 401(k) deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company provides for "Safe Harbor" matching contributions of 100% of participant contributions up to the first 3% of compensation, and 50% of participant contributions for the next 2% of compensation. Additional amounts may be contributed at the option of the Company's Board of Directors. Both employer and participant contributions are subject to certain annual limitations under the IRC. Participants direct the investment of their contributions into various investment options offered by the Plan.

(d) Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's matching contribution, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) Description of Plan (Continued)

(e) Vesting

Participants are immediately vested in their contributions and employer "Safe Harbor" matching contributions, plus the related allocated Plan earnings thereon. Effective April 1, 2021, the Company's board of directors voted to remove vesting requirements for all employees employed as of that date. Employees previously became vested in employer matching contributions made prior to January 1, 2002, from July 1 to December 31, 2019, and earnings thereon as follows:

(f) Investment Options

The assets of the Plan, both employee and employer, are allocated to the various investment options at the direction of the Participant.

(g) Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to twenty-five years for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator (8.50% at December 31, 2024 and 9.50% at December 31, 2023). Principal and interest are paid ratably through payroll deductions.

(h) Payment of Benefits

Upon termination of service, death, disability or retirement, a participant or the beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account.

(i) Unallocated Assets

At December 31, 2024 and 2023, forfeited non-vested accounts and unallocated plan assets totaled \$25,379 and \$25,389, respectively. These accounts will be used to reduce future employer contributions or pay plan administrative expenses.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements of the Plan have been prepared pursuant to accounting principles generally accepted in the United States of America and in accordance with the accrual method of accounting.

Investments held by a defined contribution Plan are required to be reported at fair value.

Notes to Financial Statements (Continued)

(2) Summary of Significant Accounting Policies (Continued)

(b) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments in mutual funds (shares of registered investment companies) are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. See Note 4 for a discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The incorporation of investment data in the accompanying financial statements is based solely on the certified statements provided by Reliance Trust Company, the Trustee for the Plan (See Note 3).

(c) Contributions

Contributions from participants are recorded as they are withheld from the participant's wages. Contributions from the Company are recorded in the period in which the related participant contributions are due.

(d) Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

(e) Payments of Benefits

Benefits are recorded when paid to the participants or their beneficiaries.

(f) Expenses

Substantially all administrative expenses are paid by the Company. Fees paid by Plan participants include investment management and consulting, loan issuances, distributions, and similar charges.

Investments in registered investment companies (mutual funds) are subject to sales charges (broker commission or load fees) and annual expenses (12b-1 fees). These expenses are deducted prior to the allocation of the Plan's investment earnings activity and thus are not separately identifiable as Plan expenses. Such expenses are included in the net appreciation (depreciation) in fair value of investments.

(g) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

(3) Investments and Information Certified by the Trustee (Unaudited)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023, was certified by Reliance Trust Company, the trustee of the Plan, as being complete and accurate:

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(4) Fair Value Measurements

The Plan determines the fair market values of its financial assets and liabilities, as well as non-financial assets and liabilities that are recognized or disclosed at fair value on a recurring basis, based on the fair value hierarchy established in accordance with accounting principles generally accepted in the United States of America for Fair Value Measurements.

The hierarchy gives the highest priority to Level 1 measurements and the lowest priority to Level 3 measurements.

Notes to Financial Statements (Continued)

(4) Fair Value Measurements (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date. The Plan's Level 1 assets include mutual funds, which are valued using the Net Asset Value (NAV) per share held by the Plan at year end. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is quoted in an active market.

Level 2: Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies. The Plan does not have any Level 2 assets.

Level 3: Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk. The Plan does not have any Level 3 assets.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

(5) Benefits Allocated to Former Participants

Net assets available for benefits at December 31, 2024, include a total of approximately \$10,885,000 of benefits allocated to the accounts of persons who have withdrawn from participating in contributions to the Plan as of that date.

(6) Related Party and Party-in-Interest Transactions

Certain fees related to the administration of the Plan were paid by the Plan or by the Company. Fees paid by the Plan to Automated Data Processing, Inc., the recordkeeper of the Plan, for administrative services and certain transactions totaled \$12,878 and \$10,065, for the years ended December 31, 2024 and 2023, respectively. The Plan also paid Osaic Wealth, Inc. \$25,017 and \$25,000 during the years ended December 31, 2024 and 2023, respectively, for investment management and consulting fees. All of these transactions are exempt from the prohibited transaction rules of ERISA.

(7) Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their account balances.

(8) Tax Status

The Internal Revenue Service has determined and informed the sponsoring organization of this prototype plan, by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Company and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no

uncertain tax positions taken or expected to be taken. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.

(10) Subsequent Events

The Plan administrator and sponsor have evaluated subsequent events through October 1, 2025, which is the date that the Plan's financial statements were available to be issued. No material subsequent events have occurred since December 31, 2024, that required recognition or disclosure in these financial statements.
