Note 1. Description of the Plan

The following description of the Derick Dermatology PLLC 401(k) Plan (Plan) provides only general information. Users of these financial statements should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Derick Dermatology, PLLC (Company) who are eligible to participate on January 1 or July 1 coinciding with or following the date they complete one year of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation. The Plan was adopted on February 1, 2009. The Plan was initially restated effective January 1, 2017, and was subsequently restated on January 1, 2021, and July 1, 2022.

Contributions

Participants may contribute amounts from a minimum of 1% up to a maximum of 90% of their annual compensation, as defined in the Plan, subject to certain Internal Revenue Code (IRC) limits. Contributions to the Plan can be classified as pre-tax or Roth contributions. Participants can make election changes and stop making contributions at any time during the plan year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations.

For the year ended December 31, 2024, the Company elected to make safe harbor matching contributions to the Plan in an amount equal to 100% of employee contributions, not to exceed 4% of employee compensation, as defined in the plan document. Effective January 1, 2021, the Company elected to make a true-up contribution each plan year as defined in the plan document. For the year ended December 31, 2024, the Company made an employer match true up contribution in the amount of \$71,454, which was made during the 2025 plan year.

The Company may also make a discretionary profit-sharing contribution. No discretionary profit-sharing contributions were made to the Plan during 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions and an allocation of plan earnings/losses and charged with an allocation of administrative expenses. Plan earnings/losses are allocated to participants' accounts in direct proportion to their respective account balances, based on the performance of participants' investment selections. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately fully vested in participant and rollover contributions plus the actual earning thereon. The portion of participant's accounts attributable to the Company's matching contribution are immediately fully vested. The portion of the participants' accounts attributable to the Company's discretionary profit-sharing contributions becomes vested at 20% after two years of service plus an additional 20% for every additional year of service between three and six years. In the event of death or disability, participants become fully vested.

Payment of Benefits

Upon termination of service, retirement, death, disability or attainment of age 59½, as defined, the participant may elect to have his or her vested account balance distributed. A participant may elect to receive either a lump sum or installment payments. Participants who terminate employment or upon death, whose balances do not exceed \$5,000, shall receive a single lump-sum cash distribution.

Participants are allowed to make in-service withdrawals from their vested interest in the Plan prior to age 59½ for reasons of financial hardship.

Forfeitures

Forfeitures of nonvested account balances are used to reduce future Company contributions. The Company utilized \$21,298 of forfeitures to reduce matching contributions during the year ending 2024. Unused forfeitures totaled \$426 and \$414 as of December 31, 2024 and 2023, respectively.

Investment Options

Participants may direct the investment of all contributions in one or more of the various investment options offered by the Plan. The Plan currently offers various registered investment companies and a common or collective investment trust fund, as investment options.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The Plan's investments in registered investment companies are valued at quoted market prices.

The common or collective trust fund is valued at the net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period of twelve months is applicable only at the plan level. There are no unfunded commitments at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis and dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Fees paid in the amount of \$46,611 for the year ended December 31, 2024, relating to active participants are paid by the Plan and charged to the respective participant's account. Other administrative expenses of the Plan are paid by the Company. Additionally, certain employees of the Company provide administrative and trustee services to the Plan and are not reimbursed by the Plan for such services. Certain investment fees are netted in the net appreciation in fair value of investments.

Note 3. Fair Value Measurements

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted market prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants would become 100% vested in their accounts.

Note 5. Certification of Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments, at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 6. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement 401(k) plan and trust sponsored by ADP, LLC. This prototype plan document has been filed with the appropriate agency and the prototype sponsor has obtained an opinion letter from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the IRC. Although the Plan has been amended since the date of the opinion letter, the plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Party-in-Interest Transactions

Certain plan investments were managed by Reliance Trust Company, the trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

Note 8. Risk and Uncertainties

The Plan provides for investments that, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note 9. Prohibited Transaction

The Company made late contributions totaling \$1,722 during the plan year ended December 31, 2023. The Company will utilize the Department of Labor Voluntary Fiduciary Corrections Program calculator to determine lost earnings to self-correct these delinquent contributions. Lost earnings were contributed during the 2023 plan year.
