INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit on the financial statements of Ingenuity Prep 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statement of Net Assets available for benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ingenuity Prep 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).



A. DESCRIPTION OF PLAN:

The following description of the Ingenuity Prep 401(k) (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

1. General - The purpose of the Plan is to provide a retirement savings plan for employees of Ingenuity Prep. The Plan is intended to be a qualified retirement plan under the Internal Revenue Code. The Plan is a defined contribution plan covering all employees of the school who become eligible to participate on the first day of the month following the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator is responsible for oversight of the Plan.
2. Contributions - For 2024 and 2023, participants may make a pre-tax contribution up to \$23,000 and \$22,500, respectively, of their total annual compensation, as defined in the Plan and as limited by Federal tax law. For 2024 and 2023, pre-tax contributions withheld from compensation are subject to an annual limit of the lesser of 87% of eligible compensation or \$23,000 and \$22,500, respectively. In addition, if a participant attains age 50 at any time before the close of the plan year and is making deferral contributions to the Plan, they are eligible to make additional "catch-up" contributions for 2024 and 2023 of \$7,500 to the Plan. The limits on salary Reduction Contributions are governed by Federal rules that provide that the total of both employer and employee 401(k) contributions (not including catch-up contributions) cannot exceed the lesser of \$69,000 and \$66,000 or 100% of annual compensation for 2024 and 2023, respectively. These maximums are adjusted each year to reflect the then current maximums. In addition to the traditional 401(k) contributions, the Plan accepts Roth 401(k) contributions.

For the 2024 and 2023 years, participants became eligible for matching contributions only if they made deferral contributions. Each year, the employer contributes 100% of the deferral contribution subject to a maximum of 3% of eligible compensation contributed to the Plan.

Beginning on August 1, 2022, an automatic deferral provision was implemented. The automatic deferral percentage is 1% of eligible compensation. This applies to employees who become participants on or after the effective date of this automatic deferral provision and eligible employees who were not contributing prior to August 1, 2022.

The limitation year for purposes of applying the above limits is the twelve-month period ending December 31. Contributions under this plan, along with employer contributions under any other employer-sponsored defined contribution plans, may not exceed the above limits. If this does occur, then excess contributions in a participant's account may be forfeited or refunded to the participant based on the provisions of the Plan document. Participants will be notified by the Plan Administrator if they have any excess contributions. Income tax consequences may apply on the amount of any refund a participant may receive.

A participant may roll over part or all of an eligible rollover distribution they receive from an eligible retirement plan into this Plan.

3. Participant Accounts - Each participant's account is credited with the (a) participant's contribution and (b) employer matching contributions (c) Plan earnings, and charged with an allocation of (d) administrative expenses and (e) appreciation and depreciation of market value of Plan assets. Allocations are based on the participant's earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. Vesting - Participants are 100% vested for all participant contributions and rollovers into the Plan. Vesting is as follows for employer contributions:

<u>Years of Service</u>	<u>Vested %</u>
Less than 1 year	0%
At least 1 year, but less than 2	33%
At least 2 years but less than 3	66%
3 years or more	100%

5. Investment Options - The Plan is called an individual account plan under Section 404(c) of ERISA. Participants are responsible for investment decisions under the Plan and any resulting investment activity. The Plan fiduciaries, including, but not limited to Reliance Trust Company, Automatic Data Processing, LLC, and Ingenuity Prep, are not responsible for any losses incurred as a result of a participant's investment decisions.
6. Payment of Benefits - On termination of service due to any reason (retirement, disability, termination of employment or death) or after a participant reaches age 59 1/2, a participant may elect to receive installment distributions paid over a period of time, a lump-sum amount equal to the value of the participant's vested account, or have the payment paid as a "direct rollover" to an individual retirement account or annuity or to another employer's tax qualified plan. Reservists called to active duty for more than 179 days or for an indefinite period may elect to withdraw penalty-free deferral contributions during the active duty period. Any death benefits under the Plan will be paid to the participant's beneficiary in a single lump sum.

If an employee terminates his/her employment and has \$5,000 or less in the Plan, then the Plan can cash out his/her entire vested account balance out of the Plan. The participant has to make an election to receive a lump sum payment or to have a distribution paid to an eligible retirement plan. If the election is not made then the Plan shall pay the distribution in a direct roll over to an individual retirement account in the participant's name with an IRA provider. If a terminated participant has a balance of less than \$1,000, the Plan shall pay the distribution in a lump sum.

The Plan provides for hardship withdrawals. A participant may request a hardship withdrawal that must be approved by the Plan Administrator. A participant may withdraw certain contributions to satisfy heavy financial needs, as determined by Internal Revenue Service regulations. The minimum hardship withdrawal is \$500. Contributions available to withdraw under the terms of this section are:

- Employee deferral contributions (including both pretax and Roth deferral contributions if available in the participant's account)
- Match

7. Forfeitures - If a participant is terminated before becoming 100% vested in his/her account balance but does not take a distribution from the Plan, the non-vested portion of his/her account balance will be forfeited as of the date he/she has a five-year period of severance. If the participant takes a distribution from the Plan and is not fully vested, the nonvested portion of the account will be forfeited.
8. Forfeited Accounts - As of December 31, 2024 and 2023, the balance of the non-vested forfeiture account was \$684 and \$375, respectively. This amount is used to reduce future employer contributions. During the years ended December 31, 2024 and 2023, \$72,425 and \$45,091, respectively, was used to reduce employer contributions.
9. Loans - The minimum loan is \$500. A participant can borrow up to 50% of his/her vested account balance to a maximum of \$50,000 (this amount is reduced by the highest outstanding loan balance he/she had under the Plan during the previous one-year period). Loans must be fully repaid within five years, unless the loan is used for the purpose of his/her primary residence. An outstanding loan must be repaid before a new loan can be made. Principal and interest payments are paid through payroll deductions. The interest rate for a loan will be the rate in effect in the month the loan is effective. The interest rate is prime plus two percentage points.
10. Outstanding Loans - As of December 31, 2024 and 2023, the balance of the outstanding loans was \$136,576 and \$108,627, respectively.
11. SECURE 2.0 - In December 2022 Securing a Strong Retirement Act (Secure 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Most of the provisions became effective in 2024 and later. The Plan believes that it has complied with the provisions of the Act that became effective during the 2024 year. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan accordingly by the required due date.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

1. Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.
2. Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.
3. Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value investments. See note E for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold ,as well as held during the year.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES: (Continued)

4. Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.
5. Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were excess contributions payable in the amount of \$20,432 and \$16,226, respectively, as of December 31, 2024 and 2023. The Plan distributed these excess contributions to the applicable participants prior to March 15, 2025, and March 15, 2024, deadlines.
6. Payment of Benefits - Benefits are recorded when paid.
7. Administrative Costs - Certain expenses of maintaining the Plan are paid by the Organization and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

D. FUNDING AND OPERATIONS OF THE PLAN:

1. Funding of the Plan - Contributions funded by the Plan's sponsor, pursuant to the plan are invested in assets held by the trustee. The Trustees of the Fund invest the Fund's money as set forth in the Plan document and as designated by the participants. Investments consist of investing in various fund groups and are reported in the accompanying financial statements at fair value. Investment income from investments is recognized when earned.
2. Administration - The Plan's Administrator has responsibility for administering the Plan. Reliance Trust Company has the responsibility for the custodian of the assets and the trust and maintaining the retirement plan's accounting and administrative services.

E. FAIR VALUE MEASUREMENTS:

Fair value measurements in accordance with current accounting standards establish a framework for measuring fair value. This framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the net asset value of units of a bank collective trust. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust fund, the investment adviser reserves the right to temporarily delay withdrawal from the trust fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

G. PARTY IN INTEREST TRANSACTIONS:

Automatic Data Processing, Inc., is the recordkeeper as related to the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan for the recordkeeping services amounted to \$8,698 for the year ended December 31, 2024.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

H. PLAN TERMINATION:

Although they have not expressed any intent to do so, the employer has the right under the Plan to discontinue their contributions at any time and to terminate or amend/modify the Plan subject to the provisions of ERISA.

I. TAX STATUS:

The adopted Plan is a prototype plan administered through Tag Services, LLC, and Automatic Data Processing, LLC. The IRS has determined and informed the employer by a letter dated July 8, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

I. TAX STATUS: (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

J. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

K. BENEFIT CLAIMS AT YEAR END:

As of December 31, 2024 and 2023, there were no such distributions requested that were not paid until after year end.

L. SUBSEQUENT EVENTS:

In preparing these financial statements, the Plan has evaluated subsequent events and transactions for potential recognition or disclosure through September 30, 2025, the date the financial statements were available to be issued.
