**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Grameen America, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General: The Plan is a defined contribution plan covering all eligible employees of Grameen America, Inc. (the Company). The Plan was established effective January 1, 2014 and most recently amended effective January 1, 2024.

The Plan qualifies under the Internal Revenue Code (IRC) as a 401(k) Pension Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees are eligible to participate in the Plan after completion of two months of service. Employees are eligible to receive the company's matching contribution after six months of consecutive service.

Contributions: The Plan includes a salary deferral arrangement allowed under Section 401(k) of the IRC. Eligible participants are permitted to elect to have a percentage of their compensation contributed as either a pre-tax or Roth contributions to the Plan, subject to annual Internal Revenue Service (IRS) limitations. Employees are automatically enrolled at a 3% pre-tax deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. Automatically enrolled participants will also have their pre-tax contributions escalated by 1% each year, up to a maximum deferral rate of 6%, unless they elect otherwise. Participants age 50 or older are allowed to make catch-up contributions.

The Company contributes 50% of the first 6% of base compensation that a participant contributes to the Plan. For the years ended December 31, 2024 and 2023, the employer made qualified matching contributions of \$328,577 and \$252,905, respectively.

The employer may, at its sole discretion, elect to make profit sharing contributions to the Plan. For the years ended December 31, 2024 and 2023, the employer did not elect to make an additional profit sharing contribution.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans or conduit IRAs. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Vesting: Participants are always fully vested in their elective deferral contributions, catch-up contributions and employee rollover contributions. Vesting in the employer matching and profit sharing contributions is based on years of credited service. A participant is vested 25% in the employer contribution per year of credited service and is 100% vested after four years of credited service.

Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or disability.

Participant Accounts: Each participant's account is credited with the participant's contributions, the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

Investments Elections: Contributions to the Plan are invested with Reliance Trust Company, the Trustee, according to participant instructions. The Plan Administrator has selected a list of investment options and has provided participants with information describing these investment options.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in their account. A participant may receive a lump-sum distribution, installment payments, or partial distribution.

If the total vested value is below \$1,000 in a participant's account at the time of termination, then a distribution will be made to the participant regardless of whether they consent to receive it. If the total vested value is greater than \$1,000, but less than \$5,000, the participant has the option of either 1) rolling over their balance into a qualified individual retirement account, or 2) receiving a distribution. If the vested value is greater than \$5,000, the participant may remain in the Plan.

Hardship distributions to employees are permitted if certain conditions are met. In addition, participants may elect in-service withdrawals of their vested account balances after reaching age 59½.

Forfeited Non-vested Accounts: Forfeited balances of terminated participants' non-vested accounts are used first to reinstate forfeited account balances of participants, next to pay administrative expenses, next to reduce future employer matching contributions, and then to reduce future non elective employer contributions. The balance of forfeited non-vested accounts was \$24,959 and \$4,712 as of December 31, 2024 and 2023, respectively. The employer used the forfeiture balance to reduce fees and contributions of \$15,603 and \$19,615 during the years ended December 31, 2024 and 2023, respectively.

Notes Receivable From Participants: Participants are allowed two notes receivable at any time and may borrow from their fund accounts a minimum of \$1,000 up to 50% of the value of their account balance, or \$50,000, whichever is less. Note receivable terms range from one to five years, except for notes receivable used to purchase a primary residence, which have a maximum term of ten years.

The notes receivable are secured by no more than fifty percent of the balance in the participant's account and bear interest at a rate equal to the prime interest rate plus one percent, at the time the note originates. Loans are repaid in equal installments through payroll deductions, personal checks from employees on leave, or cashier's checks for the full payoff of the notes receivable.

Plan Termination: Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their accounts.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting: The financial statements are prepared on the accrual basis of accounting.

Use of estimates: The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Valuation of Investments: Investments are stated at their fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion on fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants: Notes receivable from participants are measured at their unpaid principal balance, plus accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefit Payments: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and some are paid out of the Plan, which are included in these financial statements. Investment-related expenses are included as a reduction in the net appreciation (depreciation) of fair value of investments presented in the accompanying Statements of Changes in Net Assets Available for Benefits. Expenses that are paid by the Company are excluded from these financial statements.

**NOTE 3 – INCOME TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 – CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the Trustee of the Plan).

#### **NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

The Plan investments are managed by the Trustee. ADP Retirement Services provides certain recordkeeping and administrative services to the Plan. Payment of investment and administrative fees to the Trustee and ADP Retirement Services qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

#### **NOTE 6 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### **NOTE 7 – FAIR VALUE MEASUREMENT**

In accordance with FASB ASC 820, Fair Value Measurement, the Plan has categorized its financial instruments, based on the priority of the inputs to the valuation technique, into a three-level fair value hierarchy. The fair value hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

If the inputs used to measure a financial instrument fall within different levels of hierarchy, the categorization is based on the lowest level input that is significant to the fair value measurement of the instrument.

Investments recorded in the Statements of Net Assets Available for Benefits are categorized based on the inputs to valuation techniques as follows:

*Level 1.* These are investments where values are based on unadjusted quoted prices for identical assets in an active market the Plan has the ability to access.

*Level 2.* These are investments where values are based on quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, or model-based valuation techniques that utilize inputs that are observable either directly or indirectly for substantially the full-term of the investments.

*Level 3.* These are investments where inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodologies used and there were no transfers between levels in the fair value hierarchy during the years ended December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.
