We have performed audits of the financial statements of EOS Fitness 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Description of Plan

The following description of the EOS Fitness 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan's provisions.

General

The Plan was adopted by EOS Fitness OPCO Holdings, LLC effective April 1, 2019 and most recently amended and restated on July 1, 2022. The Plan is a defined-contribution plan covering substantially all employees of the following affiliated entities: EOS Fitness OPCO Holdings, LLC; Fitness Alliance, LLC; and Sports Arena Fitness, LLC (collectively, the Company or Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Trustee and Administrator of the Plan

The trustee of the Plan is Reliance Trust Company (Reliance or Trustee). Automatic Data Processing, Inc. (ADP) is the recordkeeper of the Plan. The administrator of the Plan is the Company. Reliance holds all assets of the Plan in accordance with the provisions of the service provider contract with the Company. The Company determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Participant Eligibility

Employees are eligible to become a participant in the Plan on the first day of the quarter coinciding with or following attainment of age 21 and completion of six months with at least 500 hours of service during that period.

Contributions

Participants may contribute up to 90% of their eligible annual compensation on a pre-tax or after-tax Roth basis, subject to certain Internal Revenue Code (IRC) limitations. The Plan also allows catch-up contributions for participants age 50 or older subject to certain IRC limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a 3% pre-tax deferral rate, unless they affirmatively elect not to participate in the Plan or elect a different deferral rate. Participants that were automatically enrolled in the Plan have their contribution rate increase by 1% on the anniversary date of the auto enroll date of each year, with a maximum deferral rate of 10%.

The Plan allows for an employer discretionary matching contribution. Participants must be employed at year-end to receive the contribution. The employer discretionary match is 25% of the first 4% of compensation deferred, with a maximum employer discretionary matching contribution of \$1,500.

Participant Accounts

Each participant's account is credited with the participant's contributions; rollover contributions; employer discretionary matching contribution, if any; and Plan earnings or losses. Participants are charged with certain administrative fees that are paid by the Plan. Earnings or losses from investment funds are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option. Participant accounts are also credited or debited with participant-initiated transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their account balance into various investment options offered by the Plan. Currently, the Plan offers collective investment trusts (CITs) and various mutual funds as investment options for participants.

Notes Receivable from Participants

Participants may borrow from their accounts a maximum equal to the lesser of \$50,000 or 50% of the vested interest of their account balance. The notes are secured by the balance in the participant's account and bear interest at a reasonable rate, which is the prevailing rate charged by lenders for notes of a similar type. The interest rate on the outstanding notes receivable as of December 31, 2024 was 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the notes were used to purchase a primary residence.

Payment of Benefits

Upon separation of service due to death, disability, retirement, or otherwise, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments over a period of years not exceeding the life expectancy of the participant or beneficiary, or a transfer into another qualified retirement plan. All vested account balances not exceeding \$7,000 may be immediately distributed in a lump-sum payment.

In-service withdrawals at age 59½ are also allowed by the Plan if certain criteria are met.

Vesting

Participants are immediately vested in their contributions and employer discretionary match plus actual net earnings thereon.

Forfeitures

Forfeited amounts may be used to reduce future employer contributions or pay administrative expenses. At December 31, 2024 and 2023, the forfeited non-vested account balance available for use was \$0. During the year ended December 31, 2024, none were used to fund employer contributions or pay administrative expenses.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Participant loans are classified as notes receivable from participants and are measured at the unpaid principal balance plus unpaid accrued interest. Defaulted loans, if any, are reclassified as deemed distributions based upon the terms of the Plan document.

Contributions

Participant contributions and discretionary employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable and distributions from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

3. Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in the fair value of investments, dividend income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment amounts in the footnotes to the financial statements.
- Investments and notes receivable from participants reflected on the supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and ERISA-required supplemental schedule.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts (CITs) - CITs are valued at the NAV of units of a collective trust fund. The NAV, as provided by the trustee of the CIT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. These CITs are direct filing entities.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Company adopted a Prototype Non-Standardized Profit Sharing Plan with ADP, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, which stated that the plan document, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan's management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-in-Interest and Related Party Transactions

The Plan invests in a CIT managed by the trustee. Participant loan and distribution processing fees are paid to ADP by participants. The Plan also issues loans to participants that are secured by the vested balance of the participants' accounts. Certain other fees in the form of an expense ratio charged to each investment option are paid by the Plan and deducted from earnings on investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

7. Concentrations, Risks, and Uncertainties

The Plan provides for various investments in CITs and mutual funds. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Additionally, the value, liquidity, and related income of the investments are sensitive to changes in economic

conditions and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates. Due to the level of risk associated with certain investments and the level of uncertainty related to the changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, there were three investments, which individually represented more than 10% of investments held. Refer to the supplemental Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year) for a complete listing of investments held as of December 31, 2024.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate or amend the Plan at any time, subject to the provisions of ERISA. Participants would become fully vested, to the extent not already vested, upon termination.

9. Delinquent Participant Contributions

During the 2021 Plan year, the Company failed to timely remit certain employee contributions to the Plan. The Company restored the Plan for lost earnings in 2024. See the supplemental Schedule H (Form 5500), Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024.

10. Subsequent Events

Subsequent events have been evaluated by management through October 1, 2025, the date these financial statements were available to be issued. There were no events or transactions discovered during the evaluation that require recognition or disclosure in the financial statements.
