To the Plan Administrator and Plan Participants of the  
Castle Biosciences, Inc. 401(k) Profit Sharing Plan and Trust:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of the Castle Biosciences, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

## NOTES TO FINANCIAL STATEMENTS

### 1. Description of the Plan

The following description of the Castle Biosciences, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan, established January 1, 2014 and has been amended as of December 12, 2023, that provides benefits to eligible employees, covering substantially all employees of Castle Biosciences, Inc. (the "Company") who have attained the age of 18 years. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### Administration

The Company is responsible for the administration and operation of the Plan and has appointed third parties to perform certain administrative functions. North American Ktrade Alliance, LLC ("Ktrade") and The Charles Schwab Trust Bank served as recordkeeper and trustee, respectively, through September 30, 2024. Effective October 1, 2024, the Plan appointed ADP Retirement Services ("ADP") as the recordkeeper and Reliance Trust Company as the trustee.

#### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover"). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. These contributions invested in a designated balanced fund until changed by the participant. The Company makes Safe Harbor basic matching contributions equal to 100% of the participant's elective deferrals that do not exceed 6% of the participant's compensation. Additional profit sharing amounts may be contributed at the option of the Company's plan committee. During the year ended December 31, 2024, the Company did not make any profit sharing contribution to the Plan. Contributions are subject to certain IRS limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their elective contributions, rollover contributions, safe-harbor Company matching contributions, employer nonelective contributions, and earnings thereon.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest on outstanding loans ranged from 4.25% to 10.50% at December 31, 2024 and 2023. Principal and interest is paid ratably through semi-monthly payroll deductions.

### 1. Description of the Plan, continued

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount or installments equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

#### In-Service Withdrawals

A participant may take an in-service withdrawal of all or any portion of the balance in his or her pre-tax, Roth and/or rollover accounts as described in the Plan document. Once age 59 1/2 is attained, a participant may withdraw some or all of the vested amounts in his or her accounts. Certain participants, as specified in the Plan document, may make a hardship withdrawal from their Roth elective deferrals and earnings thereon. A hardship withdrawal shall only be made in the event of a financial need constituting a hardship, as defined in the Plan document.

### 2. Summary of Significant Accounting Policies

#### Basis of Presentation

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value investments.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consists of realized gains and losses on investments sold during the year and unrealized appreciation (depreciation) of investments held at the end of the year. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### Benefit Payments

Benefit payments are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and record keeper fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### 3. Fair Value Measurements

Accounting Standards Codification Topic 820, Fair Value Measurement (“ASC 820”), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In determining the fair value of assets and liabilities, the Plan generally uses the market approach, which uses prices and other relevant data based on market transactions involving identical or comparable assets and liabilities.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Information Certified by the Plan's Custodian (Unaudited)**

The Plan Administrator has elected the method of annual reporting and compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments, non-interest bearing cash, money marketing accounts, notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in the fair value of investments, interest and dividends and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the trustee.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**5. Party-in-Interest Transactions**

Certain Plan investments are in accounts managed by the Trustee and the Plan issues notes receivable from participants. In addition, described in Note 2, the Plan paid expenses related to the plan operations to the trustee and record keeper. These transactions qualify as party-in-interest transactions, as defined by ERISA. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants remain 100% vested in their account balances.

**7. Tax Status**

Under Section 401(a) of the IRC, the Plan is qualified as tax-exempt. The Plan is based on a non-standardized pre-approved plan offered by ADP, LLC and the Pension Planning Consultants, Inc. Pension Planning Consultants, Inc. received letters, dated October 6, 2020 and June 30, 2020 from the Internal Revenue Service ("IRS") regarding its review of the pre-approved plan from the period from October 1, 2024 to December 31, 2024 and December 31, 2023 to September 30, 2024, respectively. In the letters, the IRS stated the pre-approved plan was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letters, management of the Company and the Plan administrator believe the Plan complies with and is being operated in accordance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related tax trust is tax-exempt.

U. S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**9. Delinquent Participant Contributions**

During the year ended December 31, 2024, the Company determined that certain employee deferrals aggregating to \$244,437 had not been remitted to the Plan in a timely manner, according to DOL regulations. Although these remittances were made, they fell outside the normal processing time the Company allows. Various investigations were held to determine the root cause of the delinquent contributions and corrective measures were taken. The Company is in the process of calculating lost earnings as a result of the delinquent contributions. The lost earnings for the 2024 contributions are estimated to be approximately \$1,000 and will be processed and deposited to participant accounts as soon as administratively feasible.

**10. Subsequent Events**

The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued, and has concluded that there are no significant events to be reported.
