Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Asahi Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year), as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of Plan

The following description of Asahi Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution plan adopted on March 1, 2015, covering substantially all regular full-time employees of Asahi Refining USA, Inc. (the Company or Plan Sponsor).

Employees become eligible to participate in the Plan to make pre-tax contributions and receive employer matching contributions once they satisfy the Plan's service requirement and reach their entry date. Employees will meet the service requirement when they complete one month of service. Each employee's entry date is the first day of the month coinciding with or following the date they satisfy the Plan's eligibility requirements. Employees are automatically enrolled as participants in the plan with an automatic deferral percentage of 5%, which is deposited into a BlackRock, Inc. LifePath target retirement fund based on the employee's age, unless a contrary election is made. Excluded employees are considered employees who are leased employees or are either hourly or part-time salaried employees scheduled to work less than 16 hours per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute a maximum of 90% of their annual compensation, as defined in the Plan, in the form of a salary reduction not to exceed limits set by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in the amount of \$7,500. The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Plan Sponsor makes employer safe harbor matching contributions of 100% of all eligible employees' deferrals up to 5% of the employees' base compensation.

The Plan Sponsor may also make additional employer discretionary contributions to the Plan. The discretionary contributions are equal to 5% of each eligible participant's compensation. During the 2024 Plan year the Plan Sponsor contributed \$487,793 in employer discretionary contributions.

Participant accounts and investment options: Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, employer safe harbor matching contributions, and employer discretionary contributions, if any, as well as an allocation of Plan earnings, and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may select from various investment funds in which their accounts may be invested.

Vesting: Participants are immediately vested in their elective salary deferral contributions plus earnings thereon as well as safe harbor contributions. Discretionary employer contributions are subject to a three-year cliff vesting schedule. Participants become 100% vested after three years of credited service.

Forfeitures: Forfeitures of terminated participants' nonvested accounts are used to pay Plan expenses or fund future employer contributions. There were no unused forfeitures as of December 31, 2024 and 2023. During the year ended December 31, 2024, \$95,464 of forfeitures were used to partially fund employer contributions.

Note 1. Description of Plan (Continued)

Payment of benefits: Participants or their beneficiaries are eligible for benefits upon retirement, termination, death or disability. Vested benefits are paid in single lump sum payment or as a direct rollover to an individual retirement account, individual retirement annuity, or to another employer's tax qualified plan. Participants may also withdraw money from their account in the event of a financial hardship. If the participant's account balance is less than \$5,000 at the time of termination, the amount will be automatically rolled over to an IRA account.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The repayment period is limited to five years, except a note used to purchase a principal residence may be repaid within a reasonable time (determined at the time the note is made). Participants may only have one note outstanding at any one time. The notes are secured by the balance in the participant's account, and bear interest at rates which are commensurate with prevailing interest rates charged on similar loans, as determined by the Plan Administrator. Notes receivable outstanding as of December 31, 2024, bear interest rates between 4.25% and 9.50% and are due through May 2048. Principal and interest are payable through payroll deductions.

Administrative expenses: Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses include fees related to the administration of notes receivable and benefit payments that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are charged against earnings. Expenses that are paid by the Company are excluded from these financial statements.

Note 2. Significant Accounting Policies

Basis of accounting and presentation: The accompanying financial statements have been prepared under the accrual basis of accounting.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Risk and uncertainties: The Plan utilizes various funds as investment instruments. Investment securities are exposed to various risks, such as interest rate and credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes are treated as distributions based upon the terms of the Plan document. No allowance for credits losses has been recorded as of December 31, 2024 or 2023.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Payment of benefits: Benefit payments to participants are recorded when paid.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and disclosure through October 6, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by the Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Reliance Trust Company (the Trustee). The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee related to the following assets is, to the best of its knowledge and belief, complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

The Fair Value Measurements and Disclosures Topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the topic are described below:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in valuation methodologies at December 31, 2024 compared to December 31, 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the NAV of shares in each account held by the Plan at year end. The net asset value is not a public-quoted price in an active market. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain investments could result in a different fair value measurement at the reporting date.

Note 5. Related-Party Transactions and Party-in-Interest Transactions

The administrative expenses paid by the Plan of \$59,087 for the year ended December 31, 2024, were remitted to the third-party administrator and other advisors as appropriate based on customary and reasonable rates for such services. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. These transactions qualify as party-in-interest transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, or another action that would qualify as a partial plan termination, the participants affected would immediately become 100% vested in their accounts at the date of termination and the net assets of the Plan would be distributed to the participants of the Plan in accordance with the provisions of ERISA.

Note 7. Tax Status

The Plan is a nonstandardized prototype plan sponsored by ADP, LLC. The prototype plan has received an advisory letter from the Internal Revenue Service dated October 6, 2020, as to its qualified status. The prototype plan letter has been relied upon by the Plan. The Plan has been amended subsequent to the version covered by the prototype plan's advisory letter. However, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements; therefore, no provision of liability for income taxes has been included in the financial statements.
