## INDEPENDENT AUDITOR'S REPORT

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan of Daly Computers, Inc. (Company) and was established on January 1, 1997. The Plan is subject to the provisions of ERISA.

On December 29, 2022, the SECURE 2.0 Act of 2022 (SECURE 2.0 Act) was signed into law. The SECURE 2.0 Act makes various required and optional changes applicable to tax qualified retirement plans with varying effective dates through 2027. Certain mandatory changes to plan provisions or optional changes to be made to plan provisions as a result of the SECURE 2.0 Act are discussed in these financial statements. The plan document is required to be amended in regard to the requirements of SECURE 2.0 by December 31, 2026.

Eligibility: The Plan covers substantially all employees of the Company; however, residents of Puerto Rico, employees covered by a collective bargaining agreement, leased employees, nonresident aliens, interns and temporary and seasonal employees are excluded from participating in the Plan. However, temporary or seasonal employees who complete 1,000 hours of service during an eligibility computation period (as defined) and attain age 21 are eligible to participate in the Plan. Employees are eligible to participate once they have completed two months of service. Employees may enter the Plan on the first day of the following month upon satisfying these requirements.

Employees are eligible for a discretionary matching contribution as determined by the Company. Employees are eligible for a discretionary non-elective contribution once they have completed one year of service with at least 1,000 hours of service.

Contributions: Each year, participants may elect to contribute up to 100% of their eligible compensation (as defined), up to the maximum allowable contribution under the Internal Revenue Code (IRC). These contributions may be made as pre-tax or after-tax Roth deferral contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company provides for the following contributions on behalf of participants:

A discretionary matching contribution in which the amount and specific quarter(s) are determined by the Company. Participants not actively employed at the end of the calendar quarter will not share in the discretionary matching contribution, regardless of service. No discretionary matching contribution was made for 2024.

A discretionary non-elective contribution as determined by the Company. The contribution is allocated based upon the Participant Group Allocation Method to which a benefiting participant is assigned. In order to share in the allocation of the discretionary non-elective contribution, a participant must have at least 1,000 hours of service during the plan year and be actively employed at the end of the plan year. No discretionary contribution was made for 2024.

Qualified Nonelective Contributions (QNECs), as defined in the Plan. No QNECs were made for 2024.

**NOTE 1 - DESCRIPTION OF PLAN - CONTINUED**

Participant Accounts: Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants may direct the investment of their contributions and Company contributions into various registered investment companies (mutual funds) and a common/collective trust fund offered by the Plan. For those participants who do not make an investment selection, their contributions and the related Company contributions are automatically invested in the Plan's qualified default investment account.

Vesting: Participants are immediately vested in their contributions, safe harbor matching contributions (discontinued effective November 1, 2019) and QNECs plus earnings thereon. Vesting in the Company's discretionary matching contribution (based on date of contribution) and the discretionary non-elective contribution portion of their accounts is based on years of continuous service. Participants receiving the discretionary matching contribution will be fifty percent vested after two years of service and fully vested after three years of service. A participant is 100 percent vested after five years of credited service in relation to the Company's discretionary matching contribution (contributed prior to January 1, 2018) and discretionary non-elective contribution. Regardless of the vesting schedule, participants will become fully vested upon reaching the normal retirement age (as defined), death or disability.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account, bear interest at the prime rate plus 1% and cannot exceed a repayment period of five years. Only one note may be outstanding at a time. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits: Benefit payments may be in the form of lump sums or partial withdrawals and are payable upon termination of employment, death, disability or retirement (as defined). The Plan shall make automatic distributions of vested account balances that are less than \$7,000 (as updated by the SECURE 2.0 Act) in accordance with plan provisions. Distributions from a participant's employee and rollover account may be made at any time. Hardship withdrawals and in-service withdrawals at age 59 ½ are also permitted, subject to provisions defined in the plan document. In-service withdrawals up to \$5,000 for the birth or adoption of a child are permitted and may be recontributed into the Plan at any time subject to certain requirements.

Forfeitures: Forfeitures of the Company contribution portion of participants' accounts (due to participants' termination prior to full vesting) are to be used to reduce future employer contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,145 and \$4,957, respectively. During 2024, forfeitures of \$6,235 were used to pay plan expenses.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Basis of Accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Unit Values: Individual participant accounts for the common/collective trust fund are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the fund, but do have an interest therein represented by units valued daily. The fund earns dividends which are automatically reinvested in additional units. Generally, contributions to and withdrawals from the fund are made daily at the NAV and are considered as made immediately after daily valuation, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes are reclassified as distributions based on the terms of the plan document.

Contributions: Contributions from plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits: Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no significant amounts due but unpaid to participants.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees of individual fund investments are charged to the respective investment and included in the net appreciation/depreciation of the investment, as they are paid through revenue sharing. A net annual asset based fee and fees related to the administration of notes receivable from participants and participant distributions are charged directly to the participant's account and are included in administrative expenses.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1**

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

**Level 2**

Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3**

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Companies:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Putnam Stable Value Fund:* The common/collective trust fund primarily invests directly in or indirectly in fully benefit-responsive investment contracts. The fund is valued daily at the NAV as provided by the trustee and is based on the fair value of the underlying contracts except for certain investment contracts that generally are valued at contract value. The NAV is used as a practical expedient to estimate fair value. Unit values are computed by dividing total net assets by the total number of participants' units outstanding on the valuation date. The fund declares and pays dividends which are reinvested in the fund and included in the determination of unit value. The fund maintains a stable \$1 unit price.

**NOTE 4 - INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (Fidelity), a qualified institution.

**NOTE 5 - TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed FMR LLC, by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain plan investments consist of registered investment companies managed and/or issued by Fidelity Investments. Fidelity Investments is the parent company of Fidelity Workplace Services, LLC (FWS), the Plan's recordkeeper, and Fidelity, the trustee of the Plan. Transactions with Fidelity Investments, FWS and Fidelity qualify as party in interest transactions.

FWS provides certain administrative services to the Plan pursuant to the Fidelity Investments Retirement Plan Service Agreement (Agreement) between the Company and FWS. The Agreement provides for a fixed basis point pricing platform. FWS receives recordkeeping revenue (revenue) based on average quarterly assets billed and payable quarterly. This revenue is subject to offsets (as defined) of Fidelity Investment and non-Fidelity investment products. Any remaining revenue balance is billed to participants on a pro-rata basis based on account balances. However, if the offsets exceed the revenue, FWS or an affiliate will make available a service credit towards the future cost of FWS provided services only. FWS also receives compensation with respect to any non-Fidelity Investment funds that are offered as investment options in the Plan, as disclosed in separate agreements, for services provided by FWS with respect to such investment funds. Further, FWS is authorized to retain net float earnings earned on the investment of transaction account balances in overnight short-term investments and may also retain the difference between the float earnings and bank fees it collects, if any, as compensation for recordkeeping services. The Plan or Company may make payments to FWS for administrative expenses not covered by the aforementioned fees. Under the Agreement, participants also pay transactional fees relative to notes receivable from participants and participant distributions. Fees paid by the Plan to FWS amounted to \$8,456 for 2024.

**NOTE 7 - DELINQUENT CONTRIBUTIONS**

During the plan year ended December 31, 2024, employee contributions and loan repayments in the amount of \$23,573 were not remitted by the Company to the Plan within the required timeframe, as defined by ERISA. As such, these transactions constitute prohibited transactions and are reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a). Corrections on the delinquent employee contributions and loan repayments are expected to be calculated and remitted to the Plan during 2025.

**NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their discretionary employer contributions.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 9 - RISKS AND UNCERTAINTIES - CONTINUED**

As of December 31, 2024 and 2023, 72% and 73%, respectively, of net assets available for benefits is invested in the Fidelity Advisor Freedom Funds; however, by their nature, these funds are a diversified mix of equities and fixed income that rebalance over time.

**NOTE 10 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.
