To the Investment Committee

Opinion

We have audited the financial statements of TEOCO Corporation Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Note 1. Description of Plan

Plan description: The following description of the TEOCO Corporation Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan, effective beginning January 1, 2007, was established in December 2007 by TEOCO Corporation (the Company or Plan Sponsor) and is a stock bonus plan under Section 401(a) of the Internal Revenue Code (IRC) with a matching contribution portion under IRC section 401(m). The Plan is also an employee stock ownership plan under Section 4975(e)(7) of the IRC and Section 407(d)(6) of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was restated, effective January 1, 2011, to provide a comprehensive document comprised of the original plan document and the amendments one through five passed since inception. The Plan was restated, effective January 1, 2013, to adjust the date of forfeiture for non-vested participants. The Plan was restated effective January 1, 2018, to incorporate Amendments 1 through 5 to the 2011 restatement and to update the indexed dollar amount of applicable limitations.

The Plan is subject to Titles I, II and III and is exempt from Title IV of ERISA. Title IV of ERISA provides for federally sponsored insurance for plans that terminate with unfunded benefits. No such insurance is provided to participants in this plan because the benefits that participants are entitled to receive are always equal to the value of their account balances and, therefore, the Plan is always fully funded. The value of a participant's account may change from time to time. Each participant assumes the risk of fluctuations in the value of his or her account.

Effective January 1, 2023, a portion of TEOCO Corporation's business was spun-off to create TEOCO Network Analytics, Inc. The Employee Stock Ownership Plan (ESOP) Participant Agreement was created to include employees of TEOCO Network Analytics, Inc.

Participation: Employees are eligible to participate after completing one hour of service, provided they are at least 21 years of age and provided the participant remains an employee upon a plan entry date. Plan entry dates are January 1 and July 1. Employees are entitled to receive Company contributions for each plan year in which they complete one thousand (1,000) hours of service and are employees (or on approved absence) on the last day of the plan year.

Contributions: Company contributions to the Plan will be made primarily in the form of Company stock, though the Company has the option of contributing cash. Participants are not required or permitted to make contributions to the Plan except insofar as the Board of Directors may provide for the ability of participants to reinvest dividends in Company stock within the Plan. Each year, the Company's Board of Directors determines and approves the amount of discretionary contributions to the Plan. Participants are entitled to receive Company contributions for each plan year in which they have completed one thousand (1,000) hours of service and are an employee (or on an approved absence) on the last day of the plan year.

On January 1, 2017, the Plan was amended to change the fixed matching employer contributions into discretionary matching employer contributions. Additionally, the Plan changed its language to allow discretionary employer contributions each year with the intent of an annual four percent (4%) contribution. This means all employees will be eligible for the contribution rather than just the 401(k) contributors. The Board of Directors declared there would be no matching employer contributions for the 2024 plan year.

Note 1. Description of Plan (Continued)

Participant accounts: The Plan maintains a Company stock account and another investment account in the name of each participant. The Company stock account is credited annually with the participant's allocable share of Company stock purchased and paid for by Reliance Trust (the Trust) or employer contributions with any forfeitures, stock or cash dividends. The other investment account is credited annually with the participant's allocable share of employer contributions that are not in the form of Company stock and with any forfeitures, stock dividends, cash dividends from other investment accounts and any net income or loss of the Trust.

Vesting: Participants' interest in their accounts become 100% vested and non-forfeitable without regard to their credited service if a participant's employment terminates by reason of retirement, death or permanent disability. Vesting of the Company's contributions is based on years of service. A summary of the vesting schedule of the Plan is as follows:

Years of Credited Service	Vested Percentage
Fewer than two (2) years	0%
Two (2) years or more	100%

Forfeitures: Any portion of the final balances in a participant's account which is not vested will become forfeited upon the earlier of (i) receipt of a complete distribution of capital accumulation or (ii) the allocation date of the plan year in which the participant incurs five consecutive breaks in service. A break in service is a 12-consecutive-month period beginning on an employee's severance date or any anniversary date thereof in which the employee is not credited with an hour of service.

A participant who is not vested shall be deemed to have received a complete distribution of their capital accumulation on the date in which their service terminates as opposed to the allocation date of the plan year in which their service terminates. All forfeitures will be reallocated to the accounts of remaining participants as of the allocation date of the plan year in which the forfeiture occurs. Forfeitures allocated to participants totaled \$10,249 and \$19,447 for the years ended December 31, 2024 and 2023, respectively.

Distribution of capital accumulation: In the event of a participant's retirement, disability or death, distribution of capital accumulation will commence prior to the allocation date of the plan year following the plan year in which the participant's retirement, disability or death occurs. If service terminates for any other reason, distribution of the participant's capital accumulation will commence prior to the allocation date of the sixth plan year following the plan year in which service terminates (unless reemployed by the Company).

Voting rights: Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by Atul Jain (the Trustee) prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interests of Plan participants and beneficiaries.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, additions, and deductions therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain administrative expenses, if any, are paid by the Plan, and accordingly, are reflected in the accompanying financial statements. The Plan Sponsor may pay all or any portion of such expenses directly and shall not be deemed to be contributions to the Plan.

Subsequent events: The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued. The Plan has determined that there are no subsequent events that require disclosure pursuant to Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC).

Note 3. Concentration of Credit Risk

Financial instruments, which potentially subject the Plan to credit risk, consist principally of cash and cash equivalents, investments at fair value and employer contribution receivable.

Note 4. Fair Value Measurements

FASB ASC Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodology used at December 31, 2024 and 2023.

Common stock: Valued at price of shares held by the Plan at year-end. Price of shares is determined by an independent valuation.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Receivables

Receivables represent the Company's contribution to the Plan at December 31, 2024 and 2023, which corresponds to the market value of the Company's common stock at the end of the year that was subsequently issued to the Plan.

In July 2025, the Company's Board of Directors authorized the issuance to the Plan of 9,450 shares of stock of the Company for the Plan year that ended December 31, 2024. This represents the 4% discretionary ESOP contribution.

In June 2024, the Company's Board of Directors authorized the issuance to the Plan of 9,010 shares of stock of the Company for the Plan year that ended December 31, 2023. This represents the 4% discretionary ESOP contribution.

Note 6. Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55, with at least 10 years of participation in the Plan, may elect to diversify a portion of their account. Diversification is offered to each eligible participant up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. During 2024, 18 participants diversified their investments and received total cash distributions of \$134,080.

Note 7. Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Note 8. Related Party and Party-In-Interest Transactions

Certain Plan investments are common shares of the Plan Sponsor and, therefore, these transactions qualify as party-in-interest transactions.

Note 9. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time by action of the Company's Board of Directors, subject to the provisions of ERISA. If the Plan is terminated, all participant accounts become fully vested and distributable based on the Plan's guidelines. Any unallocated assets of the Plan shall be allocated to participants accounts and distributed in such manner as the Company may determine.

Note 10. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan by a letter dated September 20, 2013, that the Plan is designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan's Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.

The IRS determination letter for the Plan expired on January 31, 2017. Effective January 1, 2017, the IRS eliminated the staggered five-year remedial amendment cycles for individually designed plans. As of January 1, 2017, the IRS no longer accepts determination letter applications based on the five-year remedial amendment cycles. The Company plans to adopt a prototype pre-approved plan by the IRS as soon they are available.

Note 11. Risks and Uncertainties

The Plan invests in the Company's stock. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
