## INDEPENDENT AUDITORS' REPORT

To the Plan Participants and the Plan Administrator of the  
Cloverland Farms Dairy 401(k) Retirement Plan for Union Employees:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Cloverland Farms Dairy 401(k) Retirement Plan for Union Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. DESCRIPTION OF THE PLAN

The following description of the Cloverland Farms Dairy 401(k) Retirement Plan for Union Employees (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established by Two Farms, Inc. (the Company) effective January 1, 1990. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended and restated effective January 1, 2021 to reflect statutory and regulatory changes as permitted by the Internal Revenue Service (IRS).

During the year ended December 31, 2024, participants' account balances totaling \$28,303 and \$165,448 were transferred to and from the Plan, respectively, to Two Farms Inc. Employees' 401(k) Profit Sharing Plan, an affiliated plan.

#### **Eligibility**

The Plan covers all Union Employees with collectively bargained retirement benefits of the Company assuming the employee is not a non-resident alien. Employees who have attained the age of 18 are eligible upon hire to contribute to the Plan. Non-resident aliens, temporary and leased employees are not eligible for participation in the Plan. Participants are immediately entered into the Plan upon meeting eligibility requirements. Employees must reach one year of service to be eligible for matching and discretionary contributions.

#### **Participant Contributions**

Participants may defer up to 100% of their pre-tax compensation, as defined by the Plan. Participants may contribute Roth 401(k) contributions to the Plan, which are maintained separately from pre-tax contributions. Participant contributions are subject to the Internal Revenue Code (the Code) limits, which totaled \$23,000 for the year ended December 31, 2024. Contributions may be further limited at the Plan's discretion in order for the Plan to comply with nondiscrimination limitations imposed by the Code. Participants are permitted to make rollover contributions to the Plan. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the year ended December 31, 2024.

#### **Company Contributions**

Prior to June 1, 2024, the Plan agreement and related collective bargaining agreements provided for Company contributions equal to 100% of each participant's contributions up to \$23 per week for Union Employees of Local 570 of the International Brotherhood of Teamsters (Local 570). Effective June 1, 2024, Company contributions for Local 570 increased to 100% of the participant's contributions up to \$25 per week. For Union Employees of Local 37 of the International Union of Operating Engineers (Local 37), the Company matched 100% of each participant's contributions up to 3% plus 50% on each additional dollar of participant's contributions up to the next 2% for the year ended December 31, 2024. Catch-up contributions are not matched. During the year ended December 31, 2024, Company matching contributions for the Local 570 and the Local 37 totaled \$111,234.

The Company may contribute to the Plan each year an amount determined by a Company resolution. If no resolution is adopted to the contrary, 1% of participants' compensation will be contributed. Discretionary Company contributions are allocated to an eligible participant's account in the same proportion as a participant's compensation bears to the compensation of all Plan participants.

Participants are eligible to receive discretionary contributions if they are 18 years of age, have obtained one year of service, and are employed on the last day of the Plan year. Participants do not have to be participating in the Plan to receive discretionary contributions.

During the year ended December 31, 2024, the Company made a discretionary contribution equal to 1% of participants' compensation, which totaled \$127,694.

#### **Participant Accounts**

Participant contributions, withdrawals and Company contributions are participant-directed and are credited according to the available investment options selected by each participant. Any earnings, losses, and administrative expenses are allocated to participant accounts based on the proportion of each participant's account balance to the total of all account balances within the respective fund. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account balance.

#### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, without regard to the intended use of the funds. A participant may only have one note outstanding at any given time. Notes are collateralized by the vested account balance in the participant's account and bear interest at rates commensurate with commercial rates in the local lending area for similar type notes at the time of note origination (prime rate plus 1%). Principal and interest are paid ratably through payroll deductions. All notes, excluding those for the purchase of a primary residence, must be paid back within five years. Loans for primary residences may be paid back over a period not to exceed fifteen years.

#### Vesting

Participants are 100% vested in their elective deferrals plus earnings thereon. Vesting in the Company's matching contributions and any additional Company contributions, plus earnings thereon, is based on years of service, as defined by the Plan, according to the following schedule:

<u>Years of Service</u>	<u>Percentage Vested</u>
Less than 3 years	0%
3	100%

Participants become fully vested in their accounts upon reaching retirement at age 62, death or permanent disability.

#### Payment of Benefits

Upon termination of service, participants with vested account balances of less than \$5,000 will be distributed in accordance with the Plan agreement. Prior to retirement, distributions may be made either in a lump sum payment or direct rollover equal to the value of the participant's vested interest in his or her account.

In all cases, certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. Distributions are subject to the applicable provisions of the Plan agreement. As of December 31, 2024 and 2023, there are no net assets of the Plan allocated to participants who had elected to withdraw from the Plan and have not received such amounts prior to year-end.

#### Forfeitures

Forfeitures of nonvested accounts are used to reduce future Company contributions. For the year ended December 31, 2024, forfeitures used to reduce Company contributions totaled \$24,000. Forfeitures available to the Plan totaled \$26,766 and \$34,381 as of December 31, 2024 and 2023, respectively.

#### Plan Expenses

Expenses incurred in the administration of the Plan are required to be paid by Vanguard Fiduciary Trust Company (the Trustee) with net assets of the Plan unless paid by the Company at its discretion. During the year ended December 31, 2024, the Company paid a portion of direct expenses. Distribution fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities could occur in the near term, and these changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are treated as distributions based on the terms of the Plan agreement.

#### Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Interests in registered investment companies:* Valued at the closing price reported in the active market in which the funds are traded.

### **4. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions to the Plan and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, affected participants would become 100% vested in their Company contributions.

### **5. INCOME TAX STATUS**

The pre-approved plan which the Plan has adopted received a favorable opinion letter from the IRS dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Code, and therefore, the related trust is exempt from taxation. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. Given the Plan is tax exempt and has no unrelated business income tax, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any tax periods in progress.

### **6. PARTY-IN-INTEREST TRANSACTIONS**

The Plan invests in shares of mutual funds that are managed by an affiliate of the Trustee. The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### **7. CARES ACT**

On March 27, 2020, Congress passed the Coronavirus Aid, Relief and Economic Security Act (CARES Act) in order to help the United States economy and workers in the midst of the Coronavirus Pandemic. The CARES Act included numerous provisions related to retirement plans. The Plan adopted the provision to provide a temporary waiver of required minimum distributions required to be paid in 2020. The CARES Act also delayed loan repayments from the date of the Act through December 31, 2020 for qualified individuals. As of the date of the report, the Plan has not been formally amended for such provisions.
