INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor of
Clampco Products, Inc. 401(k) Profit Sharing Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Clampco Products, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all

material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Note 1 - Plan Description:

The following description of the Clampco Products, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General:

The Plan sponsored by Clampco Products, Inc. was established effective January 1, 1979 and restated on November 1, 2011, January 1, 2016, March 10, 2021 and November 30, 2023. The amendment and restatement on November 30, 2023 was done to address the creation of the Clampco Products, Inc. Employee Stock Ownership Plan effective January 1, 2023. The Plan is a defined contribution plan with both a 401(k) portion and a profit sharing portion. The Plan covers all employees who have at least six months of service for the 401(k) portion of the Plan and one year of service for the profit sharing portion of the Plan. The employee must be age 18 or older to participate in either portions of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor, Clampco Products, Inc., is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions:

The participating employees make contributions to the Plan according to their elected salary reduction agreement with the Company, not to exceed limits imposed by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participant contributions may be changed as of each payroll period. The Plan also allows participants to make Roth and rollover contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Effective January 1, 2024, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated target fund until changed by the participant. The Plan is a safe-harbor plan and the Company makes matching contributions equal to 3% of the participant's compensation. Effective January 1, 2023, the safe harbor contributions were made to the Clampco Products, Inc. Employee Stock Ownership Plan. The Company may make a discretionary contribution in an amount determined by resolution of the Board of Directors on an annual basis. There were no discretionary employer contributions during the years ended December 31, 2024 and 2023.

Note 1 - Description of Plan (Continued):

Participants Accounts:

Each participant's account is credited with the participant's contributions, rollover contributions and Company contributions, an allocated share of investment income, and the net appreciation in the fair value of investments. Account balances are decreased by participant distributions, administrative expenses, and any net depreciation in the fair value of investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their salary deferral contributions, employer matching contributions, employee rollover contributions and related earnings. The employer discretionary contribution vests on a six year graded scale based on the employee's years of credited service.

Forfeited Accounts:

Total forfeitures from nonvested accounts totaled \$17,656 and \$7,083 for the years ended December 31, 2024 and 2023, respectively. These accounts will be used to reduce future employer contributions. Total forfeitures unallocated to participants' accounts were \$28,099 and \$7,849 at December 31, 2024 and 2023.

Payment of Benefits:

During their employment, participants may withdraw their employee vested account balances in the event of financial hardship as permitted by IRS guidelines. The balance in an employee's account not previously withdrawn may be paid to the participant or their designated beneficiary in the event of death, permanent disability, retirement, or other termination of employment with the Company. Participants with a vested interest in their accounts of \$5,000 or more may elect to receive a lump sum distribution or rollover the amount into another qualified plan. Participants with a vested interest in their account of \$5,000 or less who do not contact the plan sponsor will have benefits paid in a lump sum or have an individual IRA account created and the participant's funds will be rolled over into the new IRA account.

Withdrawals:

Withdrawals are not permitted before age 59.5, except in the event of death, disability, termination of employment, or reasons of proven financial hardship. In service withdrawals are also permitted if the participant has attained the age of 59.5.

Note 2 - Summary of Accounting Policies:

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of Benefits:

Benefit payments are recorded when paid.

Investment Valuation:

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

Contributions:

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

Administrative Expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Administrative plan expenses amounted to \$2,980 and \$33,415 for the years ended December 31, 2024 and 2023, respectively.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2 - Summary of Accounting Policies:

Subsequent Events:

Subsequent to December 31, 2024, it was determined that the Plan Sponsor did not properly permit deferrals on bonus payments as required by the Plan document. The Plan Sponsor's contribution for the missed deferral amount and estimated earnings, thereon, will be made in 2025 and will be partially contributed out of available forfeited funds.

The Plan Sponsor has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued, and no other matters came to their attention that would require adjustments to or disclosure in the financial statements.

Note 3 - Information Prepared and Certified by Custodian:

The following information included in the accompanying financial statements was obtained from data that has been prepared and certified to as complete and accurate by Principal Trust Company as of December 31, 2024 and 2023 and for the years then ended, respectively:

Note 4 - Income Tax Status:

The Plan uses a prototype plan document. The Plan received an opinion letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code ("IRC"). The Plan itself has not obtained a determination letter from the IRS. However, trustees of the plan sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and has no income subject to unrelated business income tax. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination. No such positions have been recorded in the December 31, 2024 and 2023 financial statements.

The Plan is subject to routine audits by the IRS; however, there currently are no audits for any tax period in progress. As of December 31, 2024, the Plan's federal informational returns are no longer subject to examination by the IRS for the tax years prior to 2021.

Note 5 -Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

Level 2 - Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets; 2) quoted prices for identical or similar assets or liabilities in inactive markets; 3) inputs other than quoted prices that are observable for the asset or liability; 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or the liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Common collective trusts - The fair values of participation units held in common collective trusts are valued based on their quoted net asset values ("NAV"), as reported by the managers of the common collective trusts and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date. The NAV is used as a practical expedient to estimate fair value and are not required to be leveled.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). The funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts - The pooled separate accounts are valued based on the quoted NAV of units as determined by the insurance company. The NAV is used as a practical expedient to estimate fair value and are not required to be leveled.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 - Group Annuity Contract:

In 2022, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company ("Principal"). The balance in the account at December 31, 2024 and 2023 was \$979,671 and \$859,858, respectively. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and is reviewed on a semiannual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6 - Group Annuity Contract (continued):

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes in the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without consent of the issuer.

Note 7 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested and the custodian shall distribute account balances in accordance with the Plan.

Note 8 - Party-In-Interest:

The Plan has invested in various funds managed by Principal Trust Company, the Plan's custodian as of December 31, 2024 and 2023. Principal Trust Company is a fiduciary as defined by the Plan, therefore, these transactions qualify as party-in-interest.

Note 8 - Party-In-Interest (continued):

Principal Trust Company provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement between the Company and Principal Trust Company. Principal Trust Company receives revenue from mutual fund service providers for services Principal Trust Company provides to the funds. This revenue is used to offset certain amounts owed to Principal Trust Company for its administrative services to the Plan.

Note 9 - Risks and Uncertainties:

The Plan provides for various investment options in any combination of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Note 10 - Delinquent Contributions:

During 2022, the Company did not timely remit participant contributions totaling \$23,227. The Company remitted \$18,445 of those deferrals during 2022. The remaining \$4,782 of deferrals have not yet been contributed to the Plan and are included in the participant contribution receivable at December 31, 2024 and 2023. The Company is in the process of computing and remitting the contributions and lost earnings to the Plan.

Note 11 - Refund of Excess Participant Deferrals:

During the year ended December 31, 2024, the Plan identified certain participants whose contributions exceeded the limits prescribed under Section 415 of the IRC. In accordance with IRS regulations, excess deferrals, along with applicable earnings, were refunded to the affected participants. The total amount of excess contributions and earnings refunded during the year ended December 31, 2024 amounted to \$98,620. These refunds were made to ensure compliance with nondiscrimination requirements, as well as to comply with annual contribution limits.
