Independent Auditor's Report

Opinion

We have audited the financial statements of the GBT US LLC Supplemental Unemployment Benefits Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Notes to Financial Statements

Note 1. Description of Plan

The following brief description of the GBT US LLC Supplemental Unemployment Benefits Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined benefit health and welfare plan established by GBT US LLC (the Company or the Plan Sponsor) and its participating subsidiaries. The Plan and trust funding the Plan were both established on August 3, 2020. The trust was most recently amended September 30, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan uses a third-party service provider, Total Management Solutions, Inc., to calculate and administer the benefits of the Plan.

Eligibility: Any full-time or part-time employee who is involuntarily terminated for one of the following reasons: reduction in employer's workforce, elimination or discontinuation of employee's job or position and other circumstances as the Company, in its sole discretion, deems appropriate, will be considered eligible to participate in the Plan. In addition, the employee must submit a signed Separation Agreement and General Release of Claims to the Company no later than the 60th day after the termination date. The employee must also not be covered by an employment agreement or offer letter that provides for any severance or similar pay benefits and the employee must not be eligible for any severance or similar pay under another severance pay plan of an employer.

Contributions: The Plan is funded by contributions from the Plan Sponsor for the sole purpose of the supplemental unemployment benefit.

Actuarial present value of accumulated plan benefits: Accumulated plan benefits (see Note 3) are those estimated future periodic payments that are attributable under the Plan's provisions to the service employees have rendered to the valuation date. Accumulated plan benefits include benefits expected to be paid to: (a) active employees and (b) those employees who are currently receiving benefits. Benefits for active employees are based on the age, years of service and salary of the employees. The accumulated plan benefits for those employees receiving benefits are based on the remaining payments owed to them after the valuation date. Benefits payable under all circumstances are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

Effective January 1, 2024, the Plan approved to allow certain former employees of Egencia LLC to participate in the Plan. This amendment increased the accumulated benefit obligation by approximately \$1.3 million.

Payment of benefits: The Plan provides benefits to supplement the amount an employee receives from the state as unemployment insurance (UI) benefits. The Plan provides for the payment of biweekly benefits which will equal 100% of an employee's previous weekly base pay for the period of time during which an employee is eligible. The amount of benefits the Plan provides will be directly reduced for the UI benefits provided to the participant by the applicable state. The duration of the benefit payments will be determined by the participants duration of service. In no event, however, will a participant receive more than 43 weeks of base pay for a given termination.

Administrative expenses: Administrative expenses incurred to manage the Plan are borne by the Plan Sponsor. During 2024, all administrative expenses were paid by the Company.

Note 2. Summary of Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of accounting: The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Employer's contributions and employer's contributions receivable: Contributions receivable are reported at their outstanding balances net of an estimated reserve for doubtful accounts. Contributions are funded on the same payroll cycle as active employee payroll and recorded when earned based on weekly unemployment status. As of December 31, 2024 and 2023, the allowance was \$0.

Benefit payments: Benefits are recorded when paid.

Subsequent events: The Plan evaluates events occurring after the date of the financial statements to consider whether or not the impact of such events needs to be reflected and/or disclosed in the financial statements. Such evaluation is performed through the date the financial statements are available for issuance, which was October 1, 2025, for these financial statements.

Note 3. Accumulated Plan Benefits

Consulting actuaries estimated the actuarial present value of accumulated plan benefits, which is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits earned by the members to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

Note 4. Party-in-Interest and Related-Party Transactions

The Plan Sponsor provides to the Plan certain accounting and administrative services for which no fees are charged. Total Management Solutions, Inc. helps to administer the benefits of the Plan. These transactions qualify as exempt party-in-interest transactions.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 6. Tax Status

The Plan has received a determination letter from the Internal Revenue Service dated February 9, 2021, stating that the Plan is qualified under Section 501(c)(17) of the Internal Revenue Code (the Code) and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Sponsor believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Management evaluated all of the Plan's tax positions for all open tax years and has concluded that the Plan has taken no uncertain tax positions that require adjustment to the financial statements.

Note 7. Risks and Uncertainties

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to salary, voluntary departure and involuntary termination, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
