## Independent Auditor's Report

To the Plan Administrators  
BB&E, Inc. Employee Stock Ownership Plan

### **Opinion**

We have audited the financial statements of BB&E, Inc. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets (deficiency in net assets) available for benefits as of December 31, 2024 and the related statement of changes in net assets (deficiency in net assets) available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and the changes in net assets available for benefits for the year then ended in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Emphasis of Matter**

As explained in Note 4, the financial statements include investments valued at \$16,750,000 at December 31, 2024 and \$3,410,000 at December 31, 2023, whose fair values have been estimated by management in the absence of readily determinable market values. Management's estimates are based on information provided by an independent qualified appraiser. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

Such information is the responsibility of the Plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 1 - Plan Description

The following description of BB&E, Inc. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

BB&E, Inc. (the "Company") established the Plan effective January 1, 2022. The Plan operates as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the "IRC"), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended. The Plan is administered by the Plan Administrators, which are appointed by the Company. Ventura Trust is the trustee of the Plan (the "Trustee"), and the Company is the Plan's custodian (the "Custodian").

On August 31, 2023, the Plan purchased 500,000 shares of the Company's common stock using the proceeds of a note totaling \$86,693,047 (see Note 6). The note is guaranteed by the Company and holds the common stock in a trust established under the Plan. The note is to be repaid over a period of 55 years and is funded by company contributions to the Plan. The borrowings are collateralized by the unallocated shares of common stock. The lender has no rights against shares of common stock once they are allocated under the Plan. As the Plan repays the notes, a percentage of stock is allocated to eligible employees' accounts in accordance with applicable regulations under the IRC. Accordingly, the financial statements of the Plan for the years ended December 31, 2024 and 2023 present separately the assets and liabilities and changes therein pertaining to the accounts of employees in allocated common stock (allocated) and common stock not yet allocated to employees (unallocated).

#### **Eligibility**

The Plan covers all employees of BB&E, Inc. who have obtained one year of service and are age 21 or older. A year of service is defined as 12 months following the first completed hour of service and 1,000 hours. Employees must be active as of the last day of the plan year to be eligible to receive a contribution except for employees who left due to death, disability, or normal retirement during the plan year.

#### **Contributions**

The Company makes annual contributions to the Plan, as approved by the Company's board of directors. The Company is obligated to make ESOP contributions in cash to the Plan, which, when aggregated with the Plan's interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest on its ESOP loan. Employee contributions are not permitted. The Company may make annual discretionary contributions to the Plan, as approved by the Company's board of directors. No discretionary contributions were made to the Plan during 2024.

#### **Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance.

**Note 1 - Plan Description (Continued)**

***Vesting***

If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest the balance in his or her account based on total years of service with the Company. After two years of service, a participant becomes 20 percent vested in employer contributions in the Plan; the vesting increases by 20 percent each year. A participant is 100 percent vested after six years of credited service.

***Benefit Payments***

Distributions are payable upon death, disability, or retirement for participants with vested account balances less than or equal to \$7,000 in the form of a lump-sum distribution, which is paid approximately 180 days after the close of the plan year following the separation event. Participants with vested account balances greater than \$7,000 will receive distributions over five installments, with minimum annual payments of \$7,000.

Participants with a vested account balance of greater than \$1,230,000, adjusted annually for cost of living, may be subject to an extended payment period of an additional year for every \$245,000 over \$1,230,000, up to four years, at the discretion of the Plan.

Distributions are made in cash or, if the administrator elects, in the form of company common stock plus cash for any fractional share of common stock, subject to the requirement that they be sold to the Company immediately upon distribution.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations. During 2024 and 2023, no shares were distributed outside of the plan assets and all terminated shares are recycled to eligible active participants within the plan.

Amounts allocated to participants who have elected to withdraw from the Plan but have not yet been paid as of plan year end amounted to \$52,901 at December 31, 2024.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. The Company allocates forfeitures to participants based on the participant's compensation, as defined. Allocations of forfeitures are considered additional company contributions and are subject to the vesting provisions of company contributions. At December 31, 2024, unallocated forfeited account balances totaled \$112,985. At December 31, 2023, there were no unallocated forfeited account balances.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, the balance of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. The board of directors should direct the Trustee to pay all liabilities and expenses of the trust fund and to sell shares of financed common stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan. Upon termination of the Plan, participants become 100 percent vested in their account balances.

***Administration***

The Plan's assets, which consist principally of BB&E, Inc. common shares, are held by the Trustee of the Plan.

**Note 1 - Plan Description (Continued)**

Company contributions are held and managed by the Trustee, who invests cash received, interest, and dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on any outstanding loans.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

***Voting Rights***

Each participant is entitled to exercise, in certain matters, voting rights attributable to the shares allocated to his or her account as long as the Trustee is notified prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant.

***Party-in-interest Transactions***

The Plan's sponsor, BB&E, Inc., paid certain administrative expenses on behalf of the Plan in the amount of approximately \$386,000 during the year ended December 31, 2024. Additionally, certain plan assets were invested in the stock of the plan sponsor; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Put Option***

Under federal income tax regulations, the company stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

***Unallocated and Allocated Shares***

The borrowing is collateralized by the unallocated shares of stock and is guaranteed by the Company. The lender has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023 and for the years then ended present separately the assets and liabilities and changes therein pertaining to the following:

- a. The accounts of employees with vested rights in allocated stock (allocated)
- b. Stock not yet allocated to employees (unallocated)

***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their accounts.

Diversification is offered to each eligible participant over a 5-year period. In each of the first 4 years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the 5th year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year end based upon the shares of employer stock in the participant's account at year end. Diversification is prohibited for any participant with an account balance less than \$500.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The common shares of the Company are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and is determined by annual independent appraisals. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Realized gains and losses from security transactions are reported on the average cost method.

***Benefit Payments***

Benefits are recorded when distributed by the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. The most significant assumptions and estimates relate to the valuation of company common stock. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan's primary investment is company stock. The company stock value is based on an independent appraisal as of December 31, 2024 and 2023. There are significant assumptions inherent in the appraisal of the common stock, and changes in these assumptions could have a significant impact on the financial statements. Due to the level of risk associated with the investment in company stock and the level of uncertainty related to changes in the value of such stock, it is at least reasonably possible that changes in the value of the company stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 3, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Tax Status**

The Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Note 4 - Fair Value Measurements (Continued)**

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset. The Company's common stock is classified as a Level 3 investment in the hierarchy and is based on the fair value determined through third-party appraisal, which utilized a combination of both market and income approaches, including the discounted cash flow methods and guideline transaction method. The unobservable inputs for the discounted cash flow methods were the weighted-average cost of capital, revenue growth, discount for lack of marketability, and market and company risk premiums. The unobservable inputs for the guideline transaction method were EBITDA growth, revenue growth, and net working capital requirements.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

During the year ended December 31, 2023, the Plan entered into a \$81,693,047 term loan agreement with the plan sponsor. The proceeds of the loan, along with a down payment of \$5,000,000, were used to purchase Company common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 8,567 shares being released and allocated for the plan year ended December 31, 2024. The agreement provides for the loan to repaid over a 55-year period. The loan bears an interest rate of long term-applicable federal rate (LT AFR) at the time the loan was entered into (4.03 percent at August 31, 2023). Principal and interest payments totaling \$3,666,014 are due annually, with the last payment due in December 2077.
