We have performed audits of the financial statements of LADACIN Network, Inc. Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 

**NOTE 1 PLAN DESCRIPTION**

The LADACIN Network, Inc. Defined Contribution Plan (the Plan) is administered by LADACIN Network, Inc. (the Organization or the Sponsor). The following description of the Plan is provided for general information purposes only. More complete information is provided in the Summary Plan Description and Plan Document, which are available from the Organization.

**General**

The Plan is a defined contribution plan that became effective January 1, 2009. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as restated.

**Eligibility**

All employees, excluding members of a collective bargaining unit where benefits were subject of good faith bargaining, nonresident aliens, leased employees, and reclassified employees, are eligible to participate in the Plan. The Plan has a minimum age requirement of 21 years and a service requirement of one year and 1,000 hours. Participants may be entered in the Plan on the first day of the Plan Year or the first day of the seventh month of the Plan Year following the date that the eligibility requirements are satisfied.

**Contributions**

The Plan is noncontributory for employees. The Organization may make discretionary nonelective contributions to participants who are employed on the last day of the Plan Year. During the years ended December 31, 2024 and 2023, the Organization made discretionary nonelective contributions of \$750,000 and \$1,000,000, respectively, which was the gross contributions prior to forfeiture offsets. Participants direct the investment of Organization contributions made on their behalf. The Plan accepts pre-tax and Roth rollover contributions from other qualified retirement plans in accordance with ERISA.

**Investment Options**

Upon enrollment in the Plan, participants may direct the Organization contributions by percentages into any of the investment options available. A separate account is maintained for each participant, and interest and dividends earned by each fund are reinvested in that fund. Participants may change their investment options daily, subject to certain fund limitations.

**Participant Accounts**

Each participant's account is credited with the allocation of: (a) the Organization's discretionary nonelective contribution; (b) Plan earnings, gains or losses; and (c) charged with an allocation of administrative expenses. Allocations are made pro-rata based on participant classification and compensation, as defined in the Plan Document.

**NOTE 1 PLAN DESCRIPTION (CONTINUED)**

**Vesting**

Vesting in the employer discretionary nonelective contributions plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in the employer's discretionary nonelective contributions after five years of service. A participant with less than one year of credited service is 0% vested in employer contributions. Vesting increases 20% per year from year one through five. A participant is 100% vested in their rollover contributions. Also, a participant is 100% vested when reaching age 65, normal retirement age, death, or disability.

**Benefit Payments**

After termination of service due to death, disability, or retirement, participants are entitled to receive a lump-sum distribution amount equal to the value of the participant's vested interest in their account, or monthly installments over a specified period. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. Participants have the option to leave amounts in the Plan up to the mandatory distribution date, which is defined as April 1 following the calendar year of attaining the age of 72. If the participants are still employed by the age of 72, the mandatory distribution date generally is April 1 following the termination date of employment. Upon termination, vested benefits can be rolled over to another qualified plan or an individual retirement account (IRA), or distributed in a lump-sum payment or partial withdrawals. If the vested balance is \$7,000 or less, the participant will receive a lump-sum distribution without consent. If the amount of distribution exceeds \$1,000, and the participant does not elect to receive it or roll it over, then the distribution will be automatically rolled over to an IRA without consent.

The Plan does not permit in-service or hardship withdrawals.

**Retirement**

The Plan's normal retirement age is 65. There is no early retirement provision under the Plan.

**Forfeitures**

Forfeitures are used to reduce future employer contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited, nonvested accounts totaled \$8,136 and \$9,053, respectively. During 2024 and 2023, \$8,136 and \$8,680, respectively, from the forfeited nonvested accounts was used to reduce future employer contributions. During 2024 and 2023, \$38 and \$47, respectively, from the forfeited, nonvested accounts was used to pay administrative expenses.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Finance Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, Custodian and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Benefit Payments**

Benefit payments are recorded when paid.

**Administrative Expenses and Participant Transaction Fees**

Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Investment fees and certain Plan administration fees not covered by the Organization are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Organization has evaluated its subsequent events and transactions occurring after December 31, 2024 through September 30, 2025, the date that the financial statements were available to be issued.

**NOTE 3 INFORMATION CERTIFIED BY THE PLAN CUSTODIAN**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, and Empower Annuity Insurance Company of America, Custodians of the Plan.

**NOTE 4 FAIR VALUE MEASUREMENTS**

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. (Level 1 inputs)

*Money Market Fund:* Valued at closing price reported on the active market on which individual securities are traded. (Level 1 input)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a traditional investment contract. This contract meets the investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

With traditional investment contracts, the Plan owns the contract itself and is designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan, which is between 1-3%. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

**NOTE 6 PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments are held by Empower Retirement, LLC, and Empower Annuity Insurance Company of America, the Custodians, as defined by the Plan and, therefore, those transactions qualify as party-in-interest transactions.

**NOTE 7 PLAN TERMINATION**

Although the Organization has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participants' accounts and distributed in such a manner as the Plan Document describes. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 8 TAX STATUS**

The Plan Sponsor obtained an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, in which the IRS stated that the volume submitter Plan Document was in compliance with applicable requirements of the IRC. There have been no amendments as of December 31, 2024, since receiving this letter and, therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE 8 TAX STATUS (CONTINUED)**

The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any periods in progress.

**NOTE 9 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events that could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
