1. **Description of the Plan** The following description of the MCR, LLC 401(k) & Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of MCR, LLC and its subsidiaries (collectively, the "Company") (except for collective bargaining employees and leased employees) who are at least 21 years old and who have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective March 15, 2022, the Plan was amended and restated to adopt a pre-approved defined contribution plan sponsored by Principal Life Insurance Company. Effective with this amendment and restatement reclassified employees were added as an excluded class and therefore ineligible to participate in the Plan.

In August 2021, the Company was acquired by Systems Planning and Analysis, Inc. In August 2022, the decision was made to merge the Plan into the Systems Planning and Analysis, Inc. Profit Sharing Plan Trust effective January 3, 2023. In order to facilitate the transfer to Systems Planning and Analysis, Inc. Profit Sharing Plan Trust, the majority of investments held by the Plan were liquidated at year end. These amounts are reported as Cash-In-transit at December 31, 2022 and were received by Systems Planning and Analysis, Inc. Profit Sharing Plan Trust in January 2023.

Notes to Financial Statements

Contributions: Each year, participants may contribute up to 50 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan allows for automatic enrollment. Any eligible employee who has not affirmatively elected to contribute to the Plan or has not affirmatively declined to participate in the Plan will be automatically enrolled in the Plan with a five percent withholding of pretax annual compensation. This withholding will increase by one percent each subsequent year until the automatic election reaches a maximum withholding contribution of ten percent of compensation. The Company contributes a safe harbor matching contribution of 100 percent of the first 3.5 percent of compensation that a participant contributes to the Plan. Profit sharing amounts may be contributed at the discretion of the Company. Participants must complete at least 1,000 hours of service during the Plan year and be employed on the last day of the Plan year to receive an allocation of any discretionary profit sharing contribution. There were no such contributions for the Plan year ended December 31, 2022. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contributions, as well as allocations of the Company's discretionary profit sharing contribution, if any, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary profit sharing contributions, if any, are based on the ratio of the participant's eligible compensation to total eligible compensation for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited accounts: At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$4,588 and \$5,817, respectively. These accounts can be used to pay Plan expenses, reduce future Company contributions or be reallocated to participants. During 2022, \$4,644 of forfeited nonvested accounts were used to reduce Company contributions and \$7 was used to pay Plan expenses. There were no amounts reallocated to participant accounts for the year ended December 31, 2022.

Vesting: Participants are vested immediately in their contributions, safe harbor matching contributions, and discretionary matching contributions (made under previous Plan provisions) plus actual earnings thereon. Vesting in the Company profit sharing contributions is based on years of continuous service of at least 1,000 hours per year. A participant is 40 percent vested after two years of service are completed, and vests an additional 20 percent per year until full vesting after five years. Different vesting schedules may apply to account balances of participants due to prior Plan provisions as described in the Plan document.

Payment of benefits: Benefits are payable upon retirement at age 65, early retirement at age 55 with five years of service, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum payments.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the Plan administrator based on prevailing market rates. Principal and interest are paid through payroll deductions.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan and distribution administration fees, are charged directly to the participant's account and are included in administrative expenses. Participants are also charged asset based fees for recordkeeping and investment advisory services. These fees are included in administrative expenses.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through October 3, 2025, which is the date the financial statements were available to be issued.

3. Information certified

Certain information related to investments, cash-in-transit, and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments, cash-in-transit, and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan.

- 4. Fair value measurements** The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of the units of pooled separate accounts is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the accounts. The NAV is used as a practical expedient to estimate fair value and is determined by the trustee based on fair value of the underlying assets in the account, less the liabilities.

The fair value of the collective trust funds is based on the NAV on the last business day of the Plan year provided by the entity holding the trust funds. The NAV of the collective trust is used as a practical expedient to estimate fair value and is determined by the fund trustee based on the fair value of underlying assets in the trust, less its liabilities.

- 5. Guaranteed investment contract** The Plan participates in a traditional benefit responsive investment contract with Principal Life Insurance Company via an investment in a Guaranteed Investment Contract (“GIC”). Principal Life Insurance Company (“PLIC”) commingles the assets of the GIC with other assets in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal Life Insurance Company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfer all or a portion of their investment at contract value.
- There are no reserves against contract value for credit risk of the contract issuer or otherwise. No events limit the ability of the Plan to transact at contract value. There is a surrender charge of five percent for an employer-level liquidation of this contract unless the employer provides twelve months advance notice.
- In August 2022, PLIC was provided notice by the Company of the intent to terminate the Plan's investment in the GIC with PLIC.
- 6. Risks and uncertainties** The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.

7. Party-in-interest transactions

Certain Plan investments are managed by affiliates of Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"). Principal is the trustee and recordkeeper as defined by the Plan. During 2022, a total of \$44,862 was paid to Principal for recordkeeping services. These transactions qualify as exempt party-in-interest transactions.

The Plan is a party to a plan expense agreement with Principal. Under this agreement, the participants are charged an asset based fee, a portion of which is set aside to pay the Plan's investment advisor. The remaining balance may be used to pay other eligible Plan expenses or be reallocated to participants. During 2022, a total of \$54,021 of investment advisory fees was incurred under the agreement. Additionally, the Plan paid \$21,350 to the recordkeeper and auditor for services performed during the year ended December 31, 2022 from the amounts received from participant accounts. At December 31, 2022 and 2021, \$9,033 and \$16,701, respectively, was owed for these services and reported as accrued expenses in the Statements of Net Assets Available for Benefits. At December 31, 2022 and 2021, the Plan had unallocated funds of \$32,250 and \$40,134, respectively, that were received from participant accounts. These amounts are available to pay future Plan expenses. These transactions qualify as exempt party-in-interest transactions.

During 2021 and 2022, the Company failed to remit to the trustee certain employee contributions and loan repayments totaling \$10,003 within the period prescribed by Department of Labor regulations. The 2021 late remittances were fully corrected in 2022. The 2022 late remittances were fully corrected in 2025. These delinquent remittances are considered nonexempt party-in-interest transactions.

8. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

9. Tax status

Prior to March 15, 2022, the Plan was a volume submitter plan of Principal Life Insurance Company, which received an opinion letter on August 8, 2014, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). Effective March 15, 2022, the Plan is a pre-approved plan of Principal Life Insurance Company, which received an opinion letter on June 30, 2020, in which the IRS stated that the form of the plan document was acceptable under the applicable requirements of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
