Note 1. Description of the Plan

The following description of Armon, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Under the Plan, any affiliate of Armon, Inc. can also adopt the Plan. In addition to Armon, Inc., the following were adopting employers: F.E. Moran, Inc.; F.E. Moran, Inc. Fire Protection; F.E. Moran, Inc. Fire Protection of Northern Illinois; F.E. Moran, Inc. Special Hazard Systems; F.E. Moran, Inc. Mechanical Services; F.E. Moran, Inc. Refrigeration; and F.E. Moran, Inc. Industrial. All adopting employers will be referred to collectively as "Company."

General

The Plan is a defined contribution plan established by the Company. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

The Board of Trustees is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Eligibility

All employees are covered if they have attained the age of 20.5 and have completed one month of employment, except for union employees covered by a collective bargaining agreement and leased employees. Initial enrollment is available at the beginning of the month after reaching eligibility. Qualified employees become eligible for Company matching on January 1 or July 1, after completing one year of service. Eligibility pertaining to profit sharing contributions includes the above, as well as Employees covered by a collective bargaining agreement performing services for the Company in a supervisory, non-manual, or technical capacity (as those functions are determined and defined by the Company for purposes of this Plan) on January 1 or July 1, after completing one year of service.

Contributions

Each year, participants may contribute up to 25% of pretax annual compensation, as defined in the Plan agreement. Participants have the option of contributing a percentage of their taxable compensation as a Roth contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Discretionary matching contributions and profit sharing contributions may be made on behalf of all eligible participants who made a pretax or Roth contribution to the Plan. In 2024, the Company elected to match 50% of a participant's elective deferral contribution limited to 6% of eligible participants. To be eligible for the Company matching and profit sharing contributions, an eligible participant must complete at least 1,000 hours of service and be employed on the last day of the Plan year. For the year ended December 31, 2024, Company contributions were \$761,181. Forfeitures of \$99,355 were used to offset the contributions, therefore, \$661,826 was deposited into the plan in 2025. No profit sharing contributions were approved for 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings (losses) and charged with an allocation of applicable administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

The Plan provides that each participant direct the investment of his or her account contributions and employer contributions in any combination into a number of investment funds. The Plan currently offers a variety of pooled separate accounts which contain registered investment companies, common or collective trust funds, a guaranteed investment contract, and money market fund as investment options for participants.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing portions of their accounts is based on years of continuous service. A participant is 100% vested in the Company matching contribution after six years of credited service and 100% vested in the Company profit sharing contribution after three years of credited service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. At December 31, 2024, interest rates on outstanding loans ranged from 4.25% to 9.50%.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments in accordance with the Plan agreement. In addition, the Plan allows for in-service distributions for participants who have attained age 59 1/2. Hardship distributions are also permitted from the elective deferral source of a participant's vested account.

Forfeited Accounts

If a participant is not fully vested on their termination date, the nonvested portion of their account is forfeited. Forfeitures are used to reduce future Company contributions or to pay plan expenses. As of December 31, 2024 and 2023, forfeited account balances available for future use totaled \$132,862 and \$134,182, respectively. In 2024, \$101,575 was used to reduce Company contributions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the

reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Pooled separate accounts are valued at the net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2024 or 2023.

Common or collective trust funds are valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The guaranteed investment contract, which is fully benefit-responsive, is reported at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses incurred in administering the Plan are paid by the Company and not reimbursed by the Plan. Administrative expenses paid by the Plan are recognized as paid. Certain investment fees are netted in the net appreciation in fair value of investments.

Note 3. Investment Contract With Insurance Company

The Plan has a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and specified interest rate guaranteed to the Plan. The investment contract is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against the contract value for credit risk of the contract issuer or otherwise. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events, e.g., divestitures or spin-offs of a subsidiary that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The guaranteed investment contract held with Voya totaled \$2,364,938 and \$2,906,975 as of December 31, 2024 and 2023, respectively.

Note 4. Information Certified by the Plan's Custodian

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income components and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3 Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The pooled separate accounts (\$28,806,754) and common or collective trust funds (\$3,047,348) are valued at the net asset value (NAV) of units held which has been used as a practical expedient to estimate fair value. In accordance with Subtopic 820-10, certain investments that are measured at net asset value per share (or its equivalent) are not classified in the fair value hierarchy.

Note 6. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are shares of pooled separate accounts and a guaranteed investment contract issued by Voya Retirement Insurance and Annuity Company, the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions.

The Company provides certain administrative services at no cost to the Plan. External fiduciary and investment advisors, considered parties-in-interest of the Plan were paid \$31,879 during 2024 for professional services.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the employer contribution portions of their accounts.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Tax Status

The Plan operates under an adoption agreement in connection with a non-standardized pre-approved profit sharing/money purchase/CODA plan sponsored by Voya Retirement Insurance and Annuity Company. The non-standardized plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter dated June 30, 2020, from the Internal Revenue Service stating that the non-standardized pre-approved plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is

currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10. Employer Contributions Receivable

As of December 31, 2024 and 2023, the Company has not made its committed profit sharing contribution to the Plan of \$390,000 which was originally scheduled to be made July 1, 2011. Based on the terms of the commitment, the Company may delay payment of all or a portion of the contribution if experiencing an adverse financial circumstance pertaining to the Company which would be considered an event of default under certain credit agreements. Upon payment of the contribution, interest will be computed based on the Department of Labor's Voluntary Fiduciary Correction Program calculator. As of December 31, 2024 and 2023, total cumulative interest due is \$418,732 and \$367,948, respectively, and is included in the Plan's employer contribution receivable on the statements of net assets available benefits. The increase in the cumulative interest receivable of \$50,784 for the year ended December 31, 2024, is reflected in interest income on the statement of changes in net assets available for benefits for the year then ended. As of December 31, 2024, employer contributions receivable also includes \$661,826 of discretionary matching contributions, after being reduced by forfeitures used of \$99,355 which were received by the Plan in 2025. As of December 31, 2023, employer contributions receivable also includes \$689,366 of discretionary matching contributions, which were received by the Plan in 2024.
