## Independent Auditors' Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the ACO, Inc. Tax Favored Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

## NOTES TO FINANCIAL STATEMENTS

### Note 1. Description of Plan

The following description of the ACO, Inc. Tax Favored Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General:

The Plan began January 1, 1986 and is a defined contribution plan sponsored by ACO, Inc. (the "Company"). The Plan covers eligible employees who are age 20½ and have completed at least 30 days of eligible service, excluding employees who are covered by a collective bargaining agreement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### Contributions:

Participants may make pre-tax or Roth 401(k) contributions in any amount up to 100% of their eligible compensation, subject to certain limits imposed by the Internal Revenue Service ("IRS"). Participants who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan may also make catch-up contributions, subject to certain IRS limitations. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

The Company makes safe-harbor matching contributions at a rate of 100% of salary deferrals up to the first 4% of plan compensation and 50% of salary deferrals up to the next 2% of plan compensation. The Company may also make discretionary non-elective contributions to the Plan though none were made for 2024.

#### Participant Accounts:

Each participant's account is credited with the participant's contribution, any Company contribution, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participants direct their investment fund options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Notes Receivable From Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to the extent of one-half of their vested account balance under the Plan, not to exceed \$50,000. The loans are secured by the balance in the participant's account and bear interest at 1% over the prime rate. Principal and interest is paid ratably through monthly payroll deductions.

#### Vesting:

Participants are vested immediately in their contributions and Company safe-harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary non-elective contribution portion of their accounts is based on years of continuous service. A participant is vested after six years of credited service (20% after year two and 20% each year thereafter) or in the event of death or disability, or attaining retirement age as defined by the Plan.

**Note 1. Description of Plan (Continued)**

Payment of Benefits:

On termination of service due to severance, death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the vested interest in his or her account. The Plan also provides for in-service distributions upon attaining age 59½ and hardship withdrawals, subject to certain limitations.

Forfeited Accounts:

Any forfeitures during the year may be used to pay administrative fees or to be applied as a credit against Company contributions to the Plan. Unallocated forfeiture balances were \$3,774 and \$3,646 as of December 31, 2024 and 2023, respectively. During 2024, administrative expenses were reduced by \$14 from forfeited non-vested accounts.

**Note 2. Summary of Significant Accounting Policies**

- A. Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

- B. Investment Valuation and Income Recognition – Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by its investment advisers and custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest and dividends are recorded when received. There is no material difference between the cash and accrual basis relative to the periods presented. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- C. Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document. An allowance for credit losses of \$78,601 and \$70,010 has been recorded as of December 31, 2024 and 2023, respectively.
- D. Administrative Fees – Fees of the Plan are paid by the Company or the Plan at the discretion of the Company. In addition, certain transactions and account maintenance fees are charged to the affected participants. Revenue credit payments are made from excess revenue generated by the Plan through fund revenue or fees that are made available to the Plan. The Company monitors the payments received by the Plan service providers to ensure that they are used properly for qualifying Plan purposes. \$32,983 in revenue credits was received in 2024 and used to reduce administrative expenses.

**Note 2. Summary of Significant Accounting Policies (Continued)**

- E. Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- F. Benefit Payments – Benefits are recorded when paid.
- G. Subsequent Events – The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

**Note 3. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants shall be 100% vested in their accounts and will receive a total distribution of their accounts.

**Note 4. Unaudited Information**

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received certifications from Empower Annuity Insurance Company of America ("Empower") and Empower Trust Company, LLC, Custodian and Trustee, respectively, of the Plan, acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, the supplemental schedule of assets (held at end of year) as of December 31, 2024, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

**Note 5. Fair Value Measurements**

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

Level 1 – Quoted market prices in active markets for identical assets and liabilities

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data

Level 3 – Unobservable inputs in which little or no market data exists

**Note 5. Fair Value Measurements (Continued)**

The following is a description of the valuation methodologies used for plan assets measured at fair value:

- The fair value of investments in mutual funds is based on their quoted market prices in active markets for identical investments, and is classified as Level 1.
- The fair value of the investments in the pooled separate accounts is based on their reported net asset value ("NAV"). The NAV is based primarily on observable inputs, the market value of the underlying investments, and is classified as Level 2.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6. Group Annuity Contract**

The Plan holds an investment contract which meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

**Note 6. Group Annuity Contract (Continued)**

Investments in the Guaranteed Interest Account are reported at contract value as determined by Empower, which represents contributions plus interest at a specified rate, less participant withdrawals and fees. Empower maintains the investments in a general account. All transactions within this contract are executed at contract value including full liquidation of the Guaranteed Interest Account. Empower is contractually obligated to repay the principal and a specified rate that is guaranteed to the Plan. Empower has indicated that the guaranteed interest rates are reset quarterly.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on several factors, including the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate (1%), and prevailing market conditions.

The Guaranteed Interest Account does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**Note 7. Income Tax Status**

The Plan has adopted a prototype plan document. This prototype document has obtained an opinion letter dated June 30, 2020 from the IRS in which the IRS stated that the document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the prototype, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The Plan's management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

**Note 8. Party-in-Interest Transactions**

Certain Plan investments are held in a group annuity contract or pooled separate accounts of Empower or its affiliates. Empower is Custodian as defined by the Plan. Its affiliate, Empower Retirement, is the recordkeeper and also receives administrative fees from the Plan. These transactions qualify as party-in-interest transactions.

**Note 9. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
