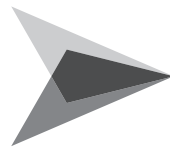

Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed the audit of the financial statements of Economy Advertising Company Salary Deferral Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(c) (ERISA Section 103(a)(3)(c) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Notes to Financial Statements

December 31, 2023 and 2022

Note 1 - Plan Description

The following description of the Economy Advertising Company Salary Deferral Plan (the “Plan”) provides only general information. Participants should refer to the plan document and adoption agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering all employees of Economy Advertising Company Salary Deferral Plan (the Plan Sponsor) who have reached age 18 and completed six months of service. Participants are eligible to enter the plan on the first day of each plan quarter. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974.

Participant Accounts - Each participant’s account is credited with the participant’s contributions, employer contributions and an allocation of Plan earnings based on account balances plus contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Contributions - Participants may make elective contributions not to exceed the 402(g) limit. The Plan has elected a safe harbor nonelective employer contribution, under which the Plan Sponsor makes contributions equal to 3% of all participating employees’ eligible compensation.

Vesting - Participants’ contributions and employer contributions are immediately 100% vested.

Payment of Benefits - Upon retirement, death, disability or termination of employment, participants receive the amount credited to their accounts. The participant or beneficiary may elect to receive a lump sum amount or installments over a specific period of time. In the event of termination of employment, if the participant’s equity balance is greater than \$5,000, the participant may elect to receive a lump sum amount or equal installments over a specific period of time. If the participant’s equity balance is less than \$5,000 but greater than \$1,000, the balance will automatically roll over into an individual retirement account. For participant balances less than \$1,000, the participant will automatically receive a lump sum.

Investment Options - Upon enrollment in the Plan, a participant may direct their account balances into any of the investment options offered by the Plan. Participants may change their investment option at any time.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with U.S. generally accepted accounting principles.

Accounting Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates and assumptions that affect the reported amount of net assets available for benefits and changes therein. Accordingly, actual results may differ from those estimates.

Note 2 - Significant Accounting Policies (Continued)

Risks and Uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment valuation and investment income - Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Money market funds are reported at net asset value, which approximates fair value. See Note 4 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits payments to participants are recorded upon distribution.

Administrative Expenses - The Plan paid administrative fees of \$40,906 and \$40,503 during the years ended December 31, 2023 and 2022, respectively. All other expenses are paid by the Plan Sponsor.

Uncertain Tax Positions - Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Date of Management Review - In preparing the accompanying financial statements, management has evaluated subsequent events through September 24, 2024, the date which the financial statements were available to be issued, for material subsequent events requiring recognition or disclosure.

Note 3 - Information Certified or Provided by Hills Bank and Trust Company

The following is a summary of the Plan's investment information, included in the Plan's financial statements and supplemental schedule that was prepared by, or derived from, information prepared by Hills Bank and Trust Company, the trustee of the Plan, and furnished to the plan management. The plan administrator has obtained certifications from the trustee that the information is complete and accurate as of and for the years ended December 31, 2023 and 2022.

Note 4 - Fair Value Measurement

Accounting guidance establishes the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below.

Basis of Fair Value Measurement

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices for identical or similar assets or liabilities in active markets;
Inputs other than quoted prices that are observable for the asset or liability;
Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means;
If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Each asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use on unobservable inputs.

The prototype plan has received an opinion letter from the Internal Revenue Service as to the prototype's qualified status. The prototype opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

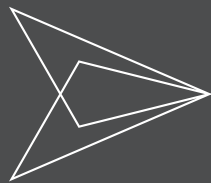
