We have performed audits of the financial statements of FourGen Holdings Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 – DESCRIPTION OF PLAN**

The following description of the FourGen Holdings Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan sponsored by FourGen Holdings, Inc. covering all nonunion and nonleased employees of FourGen Holdings Inc. and the related adopting companies (the "Companies"), as defined in the Plan's literature. Employees who are age 18 or older are eligible for the salary deferral and employer match portion of the Plan. Effective January 1, 2023, the plan was amended and removed the one year of service requirement previously needed in order to receive the employer match. Employees who are age 18 or older, have completed one year of service, and are employed on the last day of the plan year are eligible for the additional discretionary profit sharing of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions: Each year, participants may contribute up to 50% of eligible compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Employees are not automatically enrolled upon becoming eligible to participate in the Plan but may elect to change or discontinue deferrals at any time. The Plan does not have an automatic escalation feature. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may, at its discretion, make matching contributions to the Plan on an annual basis. The percentage of Elective Deferral Contributions matched, if any, shall be a percentage determined by FourGen Holdings Inc. and shall apply to all eligible persons for the entire Plan Year. The total matching contributions were \$710,481 for the year ended December 31, 2024. The Company may, at its discretion, make additional profit-sharing employer contributions to the Plan. The 2024 total profit-sharing employer contributions were \$1,378,879. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and is charged with his or her withdrawals and an allocation of (c) plan losses and (d) administrative expenses. Allocations are based on participant contributions, account balances or compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement or disability. In the event of the death of a participant while employed by the Employer, vesting in the participant's account shall be 100%. In the event of the death of a former participant, but prior to the complete distribution of his vested balance, normal vesting rules apply.

Vesting: Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Matching contributions and profit-sharing contributions (Employer Contributions) plus actual earnings thereon is vested based on years of continuous service and are subject to a four-year graded schedule. A qualifying year of service requires 1,000 hours of service.

Payment of Benefits: Upon retirement, death, disability, or termination of service, a participant is entitled to an amount equal to his or her vested balance. In addition, hardship distributions are permitted if certain criteria are met. The Company also permits participants to begin receiving benefits if they elect an early retirement date upon attainment of age 55.

Forfeitures: Participant forfeitures of the Employer Contributions shall be used to pay Plan administrative expenses and used to reduce Employer Contributions under the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 6, 2025, which is the date the financial statements were available to be issued. In August 2025, the FourGen Holdings, Inc. Retirement Plan Committee approved the election to transition the Plan into a Pooled Employer Plan (“PEP”) with Principal Trust Company effective October 1, 2025. Effective as of the end of business day September 30, 2025, all plan assets were transferred to the PEP with Principal Trust Company.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan’s investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan’s principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, global events, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the trustee of the Plan, at December 31, 2024 and 2023 and for the year ended December 31, 2024.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and have redemption prices that are determined by the fund’s net asset value per unit.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain plan investments are invested in funds administered by Principal Life Insurance Company, Principal Trust Company, and Principal Global Investors Trust Company. As Principal Life Insurance Company, Principal Trust Company, and Principal Global Investors Trust Company are trustees or affiliate of the trustees of the Plan, these investments qualify as party-in-interest investments. Investment management fees paid by the Plan to parties-in-interest and are reflected as a reduction of the investment returns earned by the Plan on its investments. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Companies.

**NOTE 6 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). Although the Plan has been amended from the non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**
