Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of RQM+ 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

1. Plan Description

The following description of the RQM+ 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

General

Effective January 1, 2022, the Plan sponsor's name was changed from R&Q Solutions, LLC to Regulatory & Quality Solutions, LLC dba RQM+ (the Company).

The Plan is a defined contribution 401(k) plan covering substantially all employees. Employees are required to be 21 years or older and have completed three consecutive months of service to be eligible. Entry dates are the first day of each month during the year following the completion of the service requirement.

Contributions

Participants may make deferral or roth contributions to the Plan in a percentage of their annual pre-tax and after-tax compensation up to the maximum allowed under the IRC. All participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions subject to IRC limitations. The Company may also make an additional discretionary matching contribution to the Plan.

Participants may direct their contributions and any employer contributions made on their behalf to a variety of investment options provided by the Plan.

Contributions and the related receivable are recognized in the period during which the Company makes respective payroll deductions from the participant's compensation. During 2024, the Company made matching contributions of approximately \$1,189,000 based on a formula of 100% of the first 3% and 50% of the next 2% of compensation contributed by the employees.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions and allocations of Plan earnings. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions, actual earnings thereon, and any contributions made on their behalf into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are 100% vested in the Company's matching portion plus actual earnings thereon based on years of continuous service. Participants, while employees, will become fully vested upon their attainment

of age 59½, death, or becoming disabled. A participant vests over three years of credited service according to the following schedule:

Notes Receivable From Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are collateralized by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions over a term not exceeding five years, or ten years for loans used for the purchase of a primary residence. At December 31, 2024, interest on outstanding loans ranged from 4.25% to 9.50%.

Payment of Benefits

Distribution of account balances may be made upon retirement, disability, death, or termination. Unless a lump-sum distribution is required by the Plan, participants may elect to receive alternate forms of distributions as defined by the Plan document. A participant may request a withdrawal from their account based upon financial hardship or at age 59½, as defined by IRC regulations.

Forfeitures

Nonvested accounts are forfeited upon a participant's termination. Forfeited amounts may be used to reduce future contributions made by the employer or to pay Plan expenses. Employer contributions reduced by the forfeitures within the Plan totaled approximately \$153,000 in 2024. Forfeitures available to offset future contributions or pay Plan expenses were approximately \$113,000 and \$164,000 at December 31, 2024 and 2023, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Participants would remain 100% vested in their employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect

certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation, Income Recognition, and Risks

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 3).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes gains or losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

Administrative expenses are paid by the Company or the Plan, as provided by the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included as a reduction to net appreciation in fair value of investments.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

The Company evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through September 16, 2025, the day the financial statements were approved and authorized for issue.

3. Investments

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to

valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of inputs that may be used to measure fair value are as follows:

Level 1 - This level consists of quoted prices in active markets for identical assets or liabilities.

Level 2 - This level consists of observable inputs other than quoted prices in active markets for identical assets and liabilities, quoted prices for identical or similar assets or liabilities in inactive markets, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - This level consists of inputs that are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for the investments.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Fixed Annuity Contract

The Empower Annuity Insurance Company Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is

reset quarterly. The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Certain events may limit the ability of the Plan to transact at contract value including any contract termination other than a full Plan termination. Participants can redeem units at any time.

The contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers (if any) less any withdrawals, transfers, and any applicable fees charges (if any). Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

5. Certification of Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company, qualified institutions.

6. Tax Status

The Plan was restated to adopt the Metro Benefits, Inc. Non-Standardized Pre-Approved Profit Sharing Plan, which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and, therefore, the related trust is tax-exempt. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related Party and Party-in-interest Transactions

Certain Plan investments are managed by Empower Annuity Insurance Company, the contract holder, and affiliate of the trustee, Empower Trust Company LLC. Additionally, the Plan paid certain administrative fees for trustee and recordkeeping services. These transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under Section 408(b) of ERISA regulations.

The Plan has notes receivable from participants subject to specific guidelines as defined in the Plan document (Note 1).

Certain administrative functions are performed by officers or employees of the Company at no cost to the Plan.

These transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory or administrative exceptions from the IRC and ERISA's rules on prohibited transactions.
