### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statement**

We have performed the audit of the accompanying financial statements of Flexsys America Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

## **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Their report dated September 30, 2024 indicated that in their opinion (c) the amount and disclosures in the 2023 financial statements, other than those agrees to or derived from the certified investments information, were presented fairly in all material respects, in accordance with the accounting principles generally accepted in the United States of America and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agree to, or is derived from, in all material respects, the information prepared and certified an institution that management determined meets the requirements of ERISA Section 103 (a)(3)(c). Their report also indicated that the form of content of the 2023 supplemental schedules other than then information in the 2023 supplemental schedules that agrees to or is derived from certified investment information, were presented, in all material respect in conforming with the Departments of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplement schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by and institution that managements determined meets the requirements of ERISA Section 103(a)(3)(c).

### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

#### NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Flexsys America Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan adopted on January 1, 2022 covering substantially all full-time employees of Flexsys America LP (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator oversees governance of the Plan. The Plans management determines the appropriateness of the Plan's investment offerings, monitors investments performance, and reports to the Company's Board of Directors.

**Eligibility:** Beginning in August 2024, employees are eligible to make payroll deferrals immediately upon employment. Employees whose employment is covered by a collective bargaining agreement unless the agreement requires the employees to be included under the plan, residents of Puerto Rico, leased employees, and limited service and special program employees, as defined in the agreement, are not eligible to participate in the Plan. Prior to August 2024, an employe must have completed one month of service. Employees could enter the plan on the first of the month following meeting the service requirement.

**Contributions:** Participants may make voluntary pre-tax or after tax (Roth) contributions, by means of a salary deferral agreement of up to 75% of their annual compensation, subject to IRS limitation for the Plan year. The Plan provided for automatic enrollment upon eligibility and, accordingly, employees are treated as having elected 7% of their compensation as a pre-tax 401(k) contribution unless an election is made for a different amount or an election is made not to participate. Plan participants over the age of 50 are also permitted to make additional pre-tax and Roth catch up contributions up to a maximum of \$7,500 on 2024. The Plan also permits rollover contributions from other qualified pre-tax retirement plans. Participants direct investment of contributions into various investment options offered by the plan. The Company matches 100% of the first 7% of union participant contributions and 50% of the first 7% of non-union participant contributions. Additionally, the Company may elect to make discretionary profit-sharing contributions. During 2024, the Company elected to make a discretionary profit-sharing contribution totaling \$810,583 which were remitted to the Plan during 2025 and, accordingly, are included in employer contribution receivable on the accompanying 2024 statement of net assets available for benefits.

**Participant accounts:** Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, if any, and (b) plan earning, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit, to which a participant is entitled is the benefit that can be provided from the participant vest account.

**Vesting:** Participants are 100% vested in their voluntary contributions, the Company's matching contributions and the Company's discretionary profit sharing contributions, plus actual earning thereon.

**Notes receivable from participants:** The Plan allows participants to obtain loans from the Plan. These loans are subject to the following general provisions: the maximum amount of loans outstanding is equal to the lesser of \$50,000 or 50% of the participant's account balance with a minimum of \$1,000. The term of any loan may not exceed five years unless the purpose of the loan is to purchase the participant's primary residence, in which case the term of the loan may not exceed 10 years. The loans are secured by the participant's account balance and bear interest at a rate equal to the prime rate (8.75% and 8.50% at December 31, 2024 and 2023, respectively) plus one percent as of the date the loan is requested. Principal and interest are paid through payroll deductions.

If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document.

**Payment of benefits:** Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or payment in annual installments not to extend past the lives or life expectancies of the participant and spouse. For termination of service due to other reasons, a participant can elect to receive the value of the vested interest in his or her account as a lump-sum distribution or in partial withdrawals. Lump-sum distributions are required if the vested balance is \$5,000 or less. Any account with a vested balance less than \$1,000 will be automatically distributed directly to the participant. In the case of hardship, a participant may apply for a distribution, minimum of \$500, described in the Plan agreement. Actively employed participants may begin receiving distributions at 59 ½.

**Forfeited accounts:** Forfeitures of non-vested accounts are to be used to reduce future employer matching contributions or for payment of plan administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,902 and \$4,655 respectively. During 2024, \$3,654 of forfeitures were used to reduce employer matching contributions.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of presentation:** The financial statements are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and accompany notes. Actual results could differ from those estimates.

**Notes receivable from participants:** Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are written off when deemed uncollectable.

**Investment valuation and income recognition:** Investments are reported at fair value using methodologies described in Note 3. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees of the plan.

Purchases and sales of investments, including gains or losses, are recorded on a trade-date basis. Interest income is recorded when earned, and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Benefit payments:** Benefit payments to participant's are recorded when paid.

**Administrative expenses:** Certain administrative expenses of the Plan have been paid by the Company and are, therefore, not included in investment related expenses are included in net appreciation or depreciation of fair value of investments. Other plan expenses not paid by the Company, including investment management, record keeping, and participant loans and distribution administrative fees are paid from other assets of the Plan and allocated to participant accounts.

**Subsequent events:** In preparing these financial statements, management has evaluated events and transactions for potential recognition or disclosure through September 26, 2025, the date the financial statements were available to be issued.

### **NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

1. **Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively-traded.

2. *Investments measured at net asset value*: A common/collective trust stable value fund which is composed primarily of fully benefit-responsive investment contracts. This fund is valued at the net asset value of units of the common/collective trust. The net asset value as provided by the trustee is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments relating to this type of investment.
3. *Self-directed brokerage accounts*: Accounts primarily consist of cash, mutual funds, and common stocks that are valued on the basis of readily determinable market prices.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

#### NOTE 5 – INCOME TAX STATUS

The trust established under the Plan, which holds the Plan’s assets, is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust’s net investment income is exempt from income taxes. The Plan, as adopted, is a pre approved plan, which does not require an application for a determination letter from the Internal Revenue Service (“IRS”). The pre-approved plan has received a favorable opinion letter from the IRS dated June 30, 2020. The Plan has not individually sought its own determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

#### NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

The Plan issues notes receivable to participants, which are secured by the balances in the participants’ accounts. These transactions qualify as party-in-interest transactions.

Certain Plan investments are shares of mutual funds managed by Fidelity Investments and related entities. Fidelity Management Trust Company, the trustee as defined by the Plan, is a related entity, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. The Plan made direct payments to the third-party administrator of \$34,668 for the year ended December 31, 2024.

#### NOTE 7 – PROHIBITED TRANSACTIONS

During 2023, the Company failed to remit certain participant contributions to the Plan on a timely basis, as defined by the Department of Labor’s Rules and Regulations under ERISA. Such contributions totaled \$1,123,061 for the year ended December 31, 2023, and are included in the Schedule of Delinquent Participant Contributions. The contributions were remitted to the Plan during 2023. Lost earnings related to the late remittances were credited to participant accounts in 2024.

The DOL views “full correction” as the payment of late contributions and reimbursement to the Plan for lost earnings or profits.

#### **NOTE 8 – RISKS AND UNCERTAINTIES**

The participants direct the Plan to invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks included global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for benefits.

#### **NOTE 9 – PLAN TERMINATION**

Although the Plan’s management has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
