## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Mower 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-12 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion***



**1. Description of Plan**

The following description of the Mower 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of Eric Mower and Associates, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Administration**

The Plan is administered by Eric Mower and Associates, Inc., which acts as the Plan Sponsor. The Plan has adopted and operates under a Non-Standardized Pre-Approved Profit Sharing Plan sponsored by AAAA Benefits, Inc. The Plan is part of the American Association of Advertising Agencies Retirement Fund for Member Agencies (AAAA Fund). The AAAA Fund is organized as a 103-12 investment entity (103-12 IE), as defined by 29 CFR-2520.103-12 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan's investments in the AAAA Fund is managed by AAAA Benefits, Inc. the trustee and third-party administrator of the Plan. The Plan Administrator is responsible for oversight of the Plan, helps to determine the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions**

Each year, participants may elect to contribute a portion of their compensation on a pre-tax basis, an after-tax basis or a combination of the two, subject to the maximum allowed by the Internal Revenue Service (IRS) and as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). In addition, each participant may elect to contribute up to 100% of any cash bonus attributable to services performed by the participant. The Company also provides a matching contribution at the discretion of the Board of Directors based on eligible compensation, participant salary deferrals, years of service and employment on the last day of the plan year. For the year ended December 31, 2024, the Company made a matching contribution in an amount of \$132,008. Contributions are subject to certain IRS limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, discretionary Company matching contributions, if eligible, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the discretionary Company matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant's vested percentage increases by 20% each year, reaching 100% after five years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear an interest rate equal to 2% above the prime rate, as defined. All loans are required to be repaid within five years, unless the loan is used to purchase a principal residence, the term is extended to fifteen years. Principal and interest are paid ratably through bi-weekly payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, retirement or other terminations of service, a participant may elect to receive the value of his or her account as a lump-sum amount, in installments, in partial withdrawals, or to defer payment until a later date in compliance with regulations. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 55, subject to specific criteria set forth in the Plan Document.

**Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,681 and \$1,122, respectively. These accounts will be first used to pay administrative expenses with any remaining forfeitures used to reduce any future discretionary Company matching contributions. During 2024, administrative expenses were reduced by \$8,354 from forfeited nonvested accounts.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**3. Information prepared and provided by 103-12 Investment Entity**

The Plan's interest in the assets of the AAAA Fund, a 103-12 investment entity, is included in the accompanying statements of net assets available for benefits. Although the assets are commingled in the AAAA Fund, the AAAA Fund maintains supporting records for the purpose of allocating the net gain, dividends and interest income of the investment accounts to the various participating plans based on the plan's percentage of assets of the AAAA Fund. A total of 58 and 63 member agencies sponsored defined contribution pension plans and participated in the AAAA Fund as of December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, the Company had a 6.81% and 7.17% interest, respectively, in the AAAA Fund.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan's investments are invested in the AAAA Fund, a 103-12 investment entity, and measured at the value quoted by the AAAA Fund. The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund:* Valued based on the net asset value (NAV) of units of the collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value as of the reporting date.

The objective of the collective trust fund is to provide a diversified group of investments offering competitive levels of yield consistent with stable fixed-income methodology and the careful and prudent assumption of investment risk providing for preservation of capital, stability and predictability of returns, liquidity to pay Plan benefits and high credit quality. The collective trust seeks to achieve this objective by investing in conventional, synthetic and separate account investments contracts (collective contracts) issued by life insurance companies, banks and other financial institutions. Characteristics of these contracts allow for their principal value to remain stable regardless of the volatility of the financial markets. For liquidity purposes, the collective trust may have all or a portion of its assets invested in high-quality money market instruments, investment companies and collective investment trusts that meet the investment objectives.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**7. Related-Party Transactions and Party-in-Interest Transactions**

The Plan's investments in the AAAA Fund are managed by AAAA Benefits, Inc., the trustee and third-party administrator of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan amounted to approximately \$25,000 for the year ended December 31, 2024.

**8. Tax Status**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Subsequent Events**

The Plan has evaluated subsequent events through September 22, 2025, which is the date the financial statements were available to be issued. There were no material subsequent events that required recognition or disclosure within these financial statements.
